**Introduction of Bills**

Rep. Haines introduced

**House Bill No. 4941, entitled**

A bill to amend 1978 PA 368, entitled "Public health code," by amending section 16181 (MCL 333.16181), as amended by 2006 PA 643.

The bill was read a first time by its title and referred to the Committee on Health Policy.
