And as the melting snow quenches the earth, it is time to plant. It is morning in Michigan. Amen.

2. Amend page 2, line 1, after “**SUBSECTION**” by striking out “**(3)**” and inserting “**(4)**”.

3. Amend page 2, line 4, after “**SUBSECTION**” by striking out “**(8)**” and inserting “**(9)**”.

4. Amend page 2, line 20, after “**SUBSECTION**” by striking out “**(6)**” and inserting “**(7)**”.

5. Amend page 3, line 9, by striking out all of subdivision (F) and inserting:

**“(F) A COPY OF THE RESULTS OF THE CRIMINAL RECORDS CHECK DESCRIBED IN SUBSECTION (2).”**

6. Amend page 3, line 21, after “**SUBSECTION**” by striking out “**(3)(F)**” and inserting “**(2) AND SUBMITTED THE RESULTS OF THAT CRIMINAL RECORDS CHECK TO THE COMMISSIONER**”.

“(C) AN APPLICANT FOR WHOM THE COMMISSIONER HAS NOT RECEIVED THE RESULTS OF THE CRIMINAL RECORDS CHECK DESCRIBED IN SUBSECTION (2).”.

8. Amend page 5, line 4, after “SUBSECTION” by striking out “(3)(E)” and inserting “(4)(E)”.

9. Amend page 5, line 8, after “SUBSECTION” by striking out “(3)” and inserting “(4)”.

10. Amend page 5, line 10, after “SUBSECTION” by striking out “(3)(D)” and inserting “(4)(D)”.

11. Amend page 5, line 11, after “SUBSECTION” by striking out “(5)” and inserting “(6)”.

12. Amend page 5, line 19, after “EXCEPT” by striking out the balance of the line through “(5)(A)” on line 20 and inserting “SUBSECTION (6)(A) AND (C)”.
