HOUSE SUBSTITUTE FOR SENATE BILL NO. 306

A bill to amend 1961 PA 120, entitled

"An act to authorize the development or redevelopment of principal shopping districts and business improvement districts; to permit the creation of certain boards; to provide for the operation of principal shopping districts and business improvement districts; to provide for the creation, operation, and dissolution of business improvement zones; and to authorize the collection of revenue and the bonding of certain local governmental units for the development or redevelopment projects,"

by amending sections 1, 5, 10, 10b, 10c, 10e, 10f, 10g, 10h, 10j, 10k, and 10*l* (MCL 125.981, 125.985, 125.990, 125.990b, 125.990c, 125.990e, 125.990f, 125.990g, 125.990h, 125.990j, 125.990k, and 125.990*l*), sections 1 and 5 as amended by 2003 PA 209, sections 10, 10c, 10f, 10g, and 10k as amended by 2018 PA 262, sections 10b, 10e, 10h, and 10*l* as amended by 2013 PA 126, and section 10j as





added by 2001 PA 260.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 1. (1) As used in this chapter:
- 2 (a) "Assessable property" means real property in a district3 area other than all of the following:
- 4 (i) Property classified as residential real property under
 5 section 34c of the general property tax act, 1893 PA 206, MCL
- 6 211.34c, unless the local governmental unit expressly designates
- 7 property classified as residential real property as assessable
- 8 property as part of its special assessment proceedings.
- 9 (ii) Property owned by the federal, a state, or a local unit of 10 government where property is exempt from the collection of taxes 11 under the general property tax act, 1893 PA 206, MCL 211.1 to 211.157.211.155.
- 13 (iii) One or more classes of property owners whose property
 14 meets all of the following conditions:
- 15 (A) Is exempt from the collection of taxes under the general property tax act, 1893 PA 206, MCL 211.1 to 211.157, 211.155, other than property identified in subparagraph (i) or (ii).
- 18 (B) As a class has been determined by the legislative body of19 the local governmental unit not to be benefited by a project for20 which special assessments are to be levied.
- (c) "District" means a business improvement district or aprincipal shopping district.
- 27 (d) "Highways" means public streets, highways, and alleys.

- (e) "Local governmental unit" means a city, village, or urban
 township.
- 3 (f) "Principal shopping district" means a portion of a local
 4 governmental unit designated by the governing body of the local
 5 governmental unit that is predominantly commercial and that
 6 contains at least 10 retail businesses.
 - (g) "Urban township" means a township that is an urban township as defined in section 2 of the local development financing act, 1986 PA 281, MCL 125.2152, 402 of the recodified tax increment financing act, 2018 PA 57, MCL 125.4402, and is a township located in a county with a population of more than 750,000.
 - (2) A local governmental unit with a master plan for the physical development of the local governmental unit that includes an urban design plan designating a principal shopping district or includes the development or redevelopment of a principal shopping district, or 1 or more local governmental units that establish a business improvement district by resolution, may do 1 or more of the following:
 - (a) Subject, where necessary, to approval of the governmental entity that has jurisdiction over the highway, open, widen, extend, realign, pave, maintain, or otherwise improve highways and construct, reconstruct, maintain, or relocate pedestrian walkways.
 - (b) Subject, where necessary, to approval of the governmental entity that has jurisdiction over the highway, prohibit or regulate vehicular traffic where necessary to carry out the purposes of the development or redevelopment project.
- (c) Subject, where necessary, to approval of the governmental
 entity that has jurisdiction over the highway, regulate or prohibit
 vehicular parking on highways.

- (d) Acquire, own, maintain, demolish, develop, improve, or
 operate properties, off-street parking lots, or structures.
- 3 (e) Contract for the operation or maintenance by others of
 4 off-street parking lots or structures owned by the local
 5 governmental unit, or appoint agents for the operation or
 6 maintenance.
- 7 (f) Construct, maintain, and operate malls with bus stops,
 8 information centers, and other buildings that will serve the public
 9 interest.
- 10 (g) Acquire by purchase, gift, or condemnation and own,
 11 maintain, or operate real or personal property necessary to
 12 implement this section.
 - (h) Promote economic activity in the district by undertakings including, but not limited to, conducting market research and public relations campaigns, developing, coordinating, and conducting retail and institutional promotions, and sponsoring special events and related activities. A business may prohibit the use of its name or logo in a public relations campaign, promotion, or special event or related activity for the district.
 - (i) Provide for or contract with other public or private entities for the administration, maintenance, security, operation, and provision of services that the board determines are a benefit to a district within the local governmental unit.
 - (3) A local governmental unit that provides for ongoing activities under subsection (2)(h) or (i) shall also provide for the creation of a board for the management of those activities.
- (4) One member of the board of the principal shopping district
 shall be from the adjacent residential area, 1 member shall be a
 representative of the local governmental unit, and a majority of

 27 increment financing act, 2018 PA 57, MCL 125.4201 to 125.4230, the
- 28 governing body may provide that the members of the board of the
- 29 downtown development authority, which manages the downtown

- district, shall compose the board of the principal shoppingdistrict, in which case subsection (4) does not apply.
- 3 (6) The members of the board of a business improvement
 4 district shall be determined by the local governmental unit as
 5 provided in this subsection. The board of a business improvement
 6 district shall consist of all of the following:
- (a) One representative of the local governmental unit appointed by the chief executive officer of the local governmental unit with the concurrence of the legislative body of the local governmental unit in which the business improvement district is located. If the business improvement district is located in more than 1 local governmental unit, then 1 representative from each local governmental unit in which the business improvement district is located shall serve on the board as provided in this subdivision.
 - (b) Other members of the board shall be nominees of the businesses and property owners located within the business improvement district. If a class of business or property owners, as identified in the resolution described in subsection (8), is projected to pay more than 50% of the special assessment levied that benefits property in a business improvement district for the benefit of the business improvement district, the majority of the members of the board of the business improvement district shall be nominees of the business or property owners in that class. The board shall include no less than 1 owner of residential real property if residential real property is determined assessable property by the local governmental unit under subsection (1).
 - (7) A local governmental unit may create 1 or more business improvement districts.

- (8) If 1 or more local governmental units establish a business
 improvement district by resolution under subsection (2), the
 resolution shall identify all of the following:

- 6 (b) The number of board members in that business improvement7 district.
- 8 (c) The different classes of property owners in the business9 improvement district.
- (d) The class of business or property owners, if any, who are projected to pay more than 50% of the special assessment levied that benefits property in that business improvement district.
 - Sec. 5. (1) If a local governmental unit elects to levy special assessments to defray all or part of the cost of the district project, then the special assessments shall be levied pursuant to applicable statutory or charter provisions or, if there are no applicable statutory or charter provisions, pursuant to statutory or charter provisions applicable to local governmental unit street improvements. If a local governmental unit charter does not authorize special assessments for the purposes set forth in this chapter, the charter provisions authorizing special assessments for street improvements are made applicable to the purposes set forth in this chapter, without amendment to the charter. The total amount assessed for district purposes may be made payable in not more than 20 annual installments as determined by the governing body of the local governmental unit, the first installment to be payable in not more than 18 months after the date
 - (2) A special assessment shall be levied against assessable

- 5 (3) This subsection applies to a principal shopping district 6 only if the principal shopping district is designated by the 7 governing body of a local governmental unit after July 14, 1992. 8 The special assessments annually levied on a parcel under this 9 chapter shall not exceed the product of \$10,000.00 and the number 10 of businesses on that parcel. A business located on a single parcel 11 shall not be responsible for a special assessment in excess of \$10,000.00 annually. The adjustment for each year shall be made by comparing the Detroit consumer price index Consumer Price Index for the 12-month period ending the preceding October 31 with the corresponding Detroit consumer price index Consumer Price Index of 1 year earlier. The percentage increase or decrease shall then be multiplied by the current amounts under subsection (3) authorized by this section. The product shall be rounded up to the nearest multiple of 50 cents

- 3 (8) A local governmental unit that levies a special assessment
 4 under this chapter that benefits property within a business
 5 improvement district is considered to have approved the marketing
 6 and development plan described in subsection (7).
 - (9) Any notice required as part of the special assessment process shall include a statement that a property owner of residential real property within a business improvement district may seek a homestead deferment for a special assessment under this act in the same manner as provided in section 4 of 1976 PA 225, MCL 211.764.
- Sec. 10. As used in this chapter:
- 14 (a) "Assessable property" means real

 - (h) "Project" means any activity for the benefit of property owners authorized by section 10a to enhance the business environment within a zone area.
 - (i) "Property owner" means a person who owns, or an agent authorized in writing by a person who owns, assessable property according to the records of the treasurer of the city or village in which the business improvement zone is located.
 - (j) "Qualifying period" means the period in which a business improvement zone is authorized to operate and impose and collect assessments, beginning on the date that the business improvement zone is approved by the property owners voting on the question as provided in section 10f and ending 7 to 10 calendar years after

(1) If a petition is delivered to the clerk of the city or village in accordance with section 10c, the governing body of the city or village shall within 28 days schedule a public hearing of the governing body to review the zone plan and any proposed assessment and to receive public comment. The clerk shall notify all owners of parcels within the zone area of the public hearing by first-class mail.
 - (2) At the public hearing required under subsection (1), or at the next regularly scheduled meeting of the governing body of the city or village, the governing body shall approve or reject the establishment of the business improvement zone and the zone plan attached to the petition under section 10c.  12 the city or village in conducting the election to keep the expenses
 13 of the election at a minimum.
 - Sec. 10f. (1) All property owners as of the date of the delivery of the petition as provided in section 10c are eligible to participate in the election. The election shall be conducted by mail. The question to be voted on by the property owners is the adoption of the zone plan and the establishment of the business improvement zone, including the identity of the initial board.
 - (2) If the zone plan for the zone area provides a basis for allocating assessments based upon taxable value, the votes of property owners shall be weighted in proportion to the amount that the taxable value of their respective real property for the preceding calendar year bears to the taxable value of all assessable property in the zone area. If the zone plan for the zone area provides for allocation of assessments based upon assessed value, the votes of property owners shall be weighted in proportion to the amount that the assessed value of their respective real property for the preceding calendar year bears to the assessed

- (2) (3)—A zone plan and the proposal for the establishment of a business improvement zone, including the identity of the initial board, shall be considered adopted upon the approval of more than 60% of the property owners voting in the election. , with votes weighted as provided in subsection (2).
- (3) (4)—Upon acceptance or rejection of a business improvement zone and zone plan by the property owners, the resulting business improvement zone or the person filing the petition under section 10c shall, at the request of the city or village, reimburse the city or village for all or a portion of the reasonable expenses incurred to comply with this chapter. - 21 section 10. A nomination not disapproved by a governing body within
- 22 60 days shall stand confirmed.
- 23 (3) The duties and responsibilities of the board shall be
- 24 prescribed in the zone plan and to the extent applicable shall
- 25 include all of the following duties and responsibilities:
- 26 (a) Developing administrative procedures relating to the
- 27 implementation of the zone plan.
- 28 (b) Recommending amendments to the zone plan.
- 29 (c) Scheduling and conducting an annual meeting of the

- 1 property owners.
- 2 (d) Developing a zone plan for the next qualifying period.
- **3** (4) Members of the board shall serve without compensation.
- 4 However, members of the board may be reimbursed for their actual
- 5 and necessary expenses incurred in the performance of their
- 6 official duties as members of the board.
- 7 Sec. 10h. (1) A business improvement zone may be funded in
- 8 whole or in part by 1 or more assessments on assessable property,
- 9 as provided in the zone plan. An assessment under this chapter
- 10 shall be in addition to any taxes or special assessments otherwise
- 11 imposed on assessable property. The business improvement zone, with
- 12 the approval of the board, may enter into agreements with 1 or more
- 13 property owners in the city or village providing for the provision
- 14 of business zone activities or services to the property owner or
- 15 owners by the business improvement zone in exchange for monetary
- 16 contributions to the business improvement zone from the property
- 17 owner or owners. An agreement providing for the provision of
- 18 business zone activities or services described in this subsection
- 19 shall be in writing and shall be made available to all property
- 20 owners of assessable property in the zone area.
- 21 (2) An assessment shall be imposed against assessable property
- 22 only on the basis of the benefits to assessable property afforded
- 23 by the zone plan. There is a rebuttable presumption that a zone
- 24 plan and any project specially benefits all assessable property in
- 25 a zone area.
- 26 (3) If a zone plan provides for an assessment, the treasurer
- 27 of the city or village in which the zone area is located as an
- 28 agent of the business improvement zone shall collect the assessment
- 29 imposed by the board under the zone plan on all assessable property

- 1 within the zone area in the amount authorized by the zone plan.
- 2 (4) Except as provided in subsection (6), assessments shall be
- 3 collected by the treasurer of the city or village as an agent of
- 4 the business improvement zone from each property owner and remitted
- 5 promptly to the business improvement zone. Assessment Except as
- 6 otherwise provided in this subsection, assessment revenue is the
- 7 property of the business improvement zone and not the city or
- 8 village in which the business improvement zone is located. However,
- 9 all payments to the treasurer shall be entirely applied first to
- 10 the balance of any property taxes owed to the city or village and
- 11 only then any remaining payment amount shall be considered
- 12 assessment revenue belonging to the business improvement zone and
- 13 applied to the assessment levied under this chapter. The business
- 14 improvement zone may, at the option and under the direction of the
- 15 treasurer, assist the treasurer of the city or village in
- 16 collecting the assessment to keep the expenses of collecting the
- 17 assessment at a minimum.
- 18 (5) The business improvement zone may institute a civil action
- 19 to collect any delinquent assessment and interest.
- 20 (6) An assessment is delinquent if it has not been paid within
- 21 90 days after it was due as provided under the zone plan imposed
- 22 under this chapter. Delinquent assessments shall be collected by
- 23 the business improvement zone. Delinquent assessments shall accrue
- 24 interest at a rate of 1.5% per month until paid.
- 25 (7) If any portion of the assessment has not been paid within
- 26 90 days after it was due, that portion of the unpaid assessment
- 27 shall constitute a lien on the property. The lien amount shall be
- 28 for the unpaid portion of the assessment and shall include any
- 29 applicable interest. Alternatively, a delinquent and unpaid

- 1 assessment may, at the request of the business improvement zone, be
- 2 returned as delinquent by the treasurer of the city or village and
- 3 collected in the same manner as a delinquent tax special assessment
- 4 along with any associated interest, fees, and costs under the
- **5** general property tax act, 1893 PA 206, MCL 211.1 to 211.155.
- 6 However, property is not subject to forfeiture, foreclosure, and
- 7 sale under sections 78 to 79a of the general property tax act, 1893
- 8 PA 206, MCL 211.78 to 211.79a, for nonpayment of an assessment
- 9 under this chapter unless the property also is subject to
- 10 forfeiture, foreclosure, and sale under sections 78 to 79a of the
- 11 general property tax act, 1893 PA 206, MCL 211.78 to 211.79a, for
- 12 delinquent property taxes. If a parcel of assessable property that
- 13 has a delinquent and unpaid assessment is sold to a purchaser who
- 14 is not related or affiliated to the seller, as determined by the
- 15 board, the board may reduce or eliminate any delinquent and unpaid
- 16 assessment on that parcel of assessable property if the property is
- 17 not subject to forfeiture, foreclosure, and sale under sections 78
- 18 to 79a of the general property tax act, 1893 PA 206, MCL 211.78 to
- 19 211.79a. If the delinquent property taxes are paid, the property
- 20 may not be forfeited, foreclosed, and sold for an unpaid assessment
- 21 under this chapter.
- Sec. 10j. A zone plan may be amended. Amendments shall be
- 23 effective if approved by a majority of the property owners voting
- 24 on the amendment at the annual meeting of property owners or a
- 25 special meeting called for that purpose. , with the votes of the
- 26 property owners weighted in accordance with section 10f(2). A zone
- 27 plan amendment changing any assessment is effective only if also
- 28 approved by the governing body of the city or village in which the
- 29 business improvement zone is located.

- Sec. 10k. (1) Prior to the expiration of any qualifying 1 period, the board shall notify the property owners within the 2 business improvement zone of a special meeting by first-class mail 3 at least 14 days prior to the scheduled date of the meeting to 4 5 approve a new zone plan for the next qualifying period. Notice 6 under this section shall include the specific location, scheduled 7 date, and time of the meeting and shall include a statement that a property owner of residential real property within a business 8 9 improvement zone may seek a homestead deferment for an assessment 10 under this act in the same manner as provided in section 4 of 1976 11 PA 225, MCL 211.764.
- 12 (2) Approval of the new zone plan at the special meeting by more than 60% of the property owners of assessable property voting 13 14 at that meeting , with the vote of the property owners being 15 weighted in accordance with section 10f(2), constitutes 16 reauthorization of the business improvement zone for an additional 17 qualifying period, commencing as of the expiration of the 18 qualifying period then in effect. If the new zone plan reflects any 19 new assessment, or reflects an extension of any assessment beyond 20 the period previously approved by the city or village in which the business improvement zone is located, the new or extended 21 assessment shall be effective only with the approval of the 22 23 governing body of the city or village.
 - Sec. 10l. (1) Upon written petition duly signed by 30% of the property owners of assessable property within a zone area and submitted no sooner than 2 years following the adoption of the business improvement zone and zone plan, the board shall place on the agenda of the next annual meeting, if the next annual meeting is to be held not later than 63 days after receipt of the written

- petition or a special meeting not to be held later than 63 days
 after receipt of the written petition, the issue of dissolution of
 the business improvement zone. Notice of the next annual meeting or
 special meeting described in this subsection shall be made to all
 property owners by first-class mail not less than 14 days prior to
 the date of the annual or special meeting. The notice shall include
- 7 the specific location and the scheduled date and time of the 8 meeting.
- 9 (2) The business improvement zone shall be dissolved upon a
 10 vote of more than 50% of the property owners of assessable property
 11 voting at the meeting. , with the votes of the property owners
 12 weighted in accordance with section 10f(2). A dissolution shall not
 13 take effect until the later of the end of the second calendar year
 14 after the vote for dissolution or all contractual liabilities of
 15 the business improvement zone have been paid and discharged.
 - (3) Upon dissolution of a business improvement zone, the board shall dispose of the remaining physical assets of the business improvement zone. The proceeds of any physical assets disposed of by the business improvement zone and all money collected through assessments that is not required to defray the expenses of the business improvement zone shall be refunded on a pro rata basis to persons from whom assessments were collected. If the board finds that the refundable amount is so small as to make impracticable the computation and refunding of the money, it may be transferred to the treasurer of the city or village in which the business improvement zone is located for deposit in the treasury of the city or village to the credit of the general fund.
 - (4) Upon dissolution of a business improvement zone, any remaining assets of the business improvement zone shall be

- 1 transferred to the treasurer of the city or village in which the
- 2 business improvement zone is located for deposit in the treasury of
- 3 the city or village to the credit of the general fund.
