SUBSTITUTE FOR SENATE BILL NO. 674

A bill to amend 1978 PA 368, entitled "Public health code,"

by amending section 22203 (MCL 333.22203), as amended by 2002 PA 619.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

Sec. 22203. (1) "Addition" means adding to a health facility
patient rooms, beds, and ancillary service areas, including, but
not limited to, procedure rooms or fixed equipment, surgical
operating rooms, therapy rooms or fixed equipment, or other
accommodations. to a health facility.

(2) "Capital expenditure" means an expenditure for a single project, including cost of construction, engineering, and equipment that under generally accepted accounting principles is not properly

- 1 chargeable as an expense of operation. Capital expenditure includes
- 2 a lease or comparable arrangement by or on behalf of a health
- 3 facility to obtain a health facility, licensed part of a health
- 4 facility, or equipment for a health facility, if the actual
- 5 purchase of a health facility, licensed part of a health facility,
- 6 or equipment for a health facility would have been considered a
- 7 capital expenditure under this part. Capital expenditure includes
- 8 the cost of studies, surveys, designs, plans, working drawings,

- 11 construction, or replacement of physical plant and equipment.
- 12 (3) "Certificate of need" means a certificate issued under

- 17 (4) "Certificate of need review standard" or "review standard"

- 19 (5) "Change in bed capacity" means 1 or more of the following:
- 20 (a) An increase in licensed hospital beds.
- 21 (b) An increase in licensed nursing home beds or hospital beds
- 22 certified for long-term care.
- (c) An increase in licensed psychiatric beds.
- 24 (d) A change from 1 licensed use to a different licensed use.
- 25 (e) The physical relocation of beds from a licensed site to

- 27 (6) "Clinical" means directly pertaining to the diagnosis,
- 28 treatment, or rehabilitation of an individual.
- 29 (7) "Clinical service area" means an area of a health

- 12 single project, excluding the cost of nonfixed medical equipment,
- 13 that includes or involves the acquisition, improvement, expansion,

- 16 (10) "Covered clinical service", except as modified by the
- 17 commission under section 22215, means 1 or more of the following:
- 18 (a) Initiation or expansion of 1 or more of the following

- 20 (i) Neonatal intensive care services or special newborn nursing
- 21 services.
- 22 (ii) Open heart surgery.
- 23 (iii) Extrarenal organ transplantation.
- 24 (b) Initiation, replacement, or expansion of 1 or more of the
- 25 following services:
- 26 (i) Extracorporeal shock wave lithotripsy.
- 27 (ii) Megavoltage radiation therapy.
- 28 (iii) Positron emission tomography.
- 29 (iv) Surgical services provided in a freestanding surgical



- 1 outpatient facility, an ambulatory surgery center certified under
- 2 title XVIII, or a surgical department of a hospital licensed under
- 3 part 215 and offering inpatient or outpatient surgical services.
- 4 (v) Cardiac catheterization.
- 5 (vi) Fixed and mobile magnetic resonance imager services.
- 6 (vii) Fixed and mobile computerized tomography scanner 7 services.
- 8 (viii) Air Through September 30, 2020, air ambulance services.
- 9 (c) Initiation or expansion of a specialized psychiatric
 10 program for children and adolescent patients utilizing licensed
 psychiatric beds.
- (d) Initiation, replacement, or expansion of a service not
 listed in this subsection, but designated as a covered clinical
 service by the commission under section 22215(1)(a).
- 15 (11) "Fixed equipment" means equipment that is affixed to and 16 constitutes a structural component of a health facility, including, 17 but not limited to, mechanical or electrical systems, elevators, 18 generators, pumps, boilers, and refrigeration equipment.
