SUBSTITUTE FOR HOUSE BILL NO. 5576

A bill to establish certain financial aid programs for certain residents of this state seeking associate degrees or industry-recognized certificates or credentials from certain educational and jobs training programs; to provide for the administration of the financial aid programs; and to prescribe certain powers and duties of certain state officers, agencies, and departments.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

2 Sec. 1. (1) This act shall be known and may be cited as the 3 "Michigan reconnect grant act".

(2) The reconnect program and reconnect initiative created respectively in parts 1 and 2 of this act are intended to provide last-dollar financial assistance to individuals age 25 and older

- 1 seeking associate degrees or industry-recognized certificates or

- 12 (b) "Continuous enrollment" means enrollment in at least 2
- 13 semesters or the equivalent in terms or quarters, as determined by

- 16 semesters, terms, or quarters of enrollment within a 12-month
- 17 period need not be consecutive.
- 18 (c) "Department" means the department of labor and economic
- **19** opportunity.
- 20 (d) "Eligible institution" means a postsecondary educational
- 21 institution that meets all of the following:
- 22 (i) Is an accredited public community college in this state.
- 23 (ii) Complies with applicable restraints on fee and tuition
- 24 rate increases, if any, provided for in article II of the school
- 25 aid act of 1979, 1979 PA 94, MCL 388.1801 to 388.1830.
- 26 (iii) Participates in quality assurance protocols established by
- 27 the department for purposes of accurately tracking student outcomes
- 28 described in section 3(g) and (h).
- 29 (iv) Submits a written report of all of the following

- information to the department by not later than October 1, 2020 and
 each year thereafter by not later than June 30:
- 3 (A) The institution's goals, expressed numerically, for4 student persistence and credential completion.
- 5 (B) An inventory of the institution's currently implemented 6 strategies to improve student success outcomes, including guided 7 pathways, proactive advising, and remediation. Regarding 8 remediation, the report must detail the institution's current 9 policy for determining whether a student is to be placed in 10 developmental or credit-bearing courses.
- 11 (C) Policies for converting prior learning into community college credit wherever possible, including, but not limited to, 12 prior learning demonstrated by coursework completed at the 13 14 institution or any other postsecondary educational institution, 15 including coursework completed in the distant past, or by college 16 level equivalent courses, college level equivalent credit examinations, military training, education, or certification, or 17 18 other relevant work or life experience. As used in this subsubparagraph, "college level equivalent courses" and "college level 19 20 equivalent credit examinations" mean those terms as described in section 1472 of the revised school code, 1976 PA 451, MCL 380.1472. 21
 - (v) By not later than January 1, 2022, for Michigan reconnect grant students who need academic remediation, provides accelerated courses aimed at enabling those students to raise their skills to college level and complete credit-bearing courses. To meet this criterion, an eligible institution must provide a remediation program that follows 1 of the following:
- (A) A corequisite model under which a student concurrentlyenrolls in a developmental education course and a freshman-level

- 1 course in the same subject area for each subject area needing
- 2 remediation, to be completed concurrently. An institution providing
- 3 a remediation program that follows the model described in this sub-
- 4 subparagraph or sub-subparagraph (B) or (C) remains eligible

- **6** (B) A compression model under which a student enrolls in 2 or
- 7 more courses, either a combination of developmental and college-

- 11 more developmental courses is divided into discrete sections with a

- 19 (vi) Provides reasonable accommodations to Michigan reconnect
- 20 grant students with disabilities as required by section 504 of
- 21 title V of the rehabilitation act of 1973, 29 USC 794, and subtitle
- 22 A of title II of the Americans with disabilities act of 1990, 42
- 23 USC 12131 to 12134.
- (vii) Designates an individual employed by the institution as
- 25 the institution's primary contact with the department for purposes
- 26 of coordinating the administration of the Michigan reconnect grant
- 27 program in accordance with this part.
- 28 (e) "Gift aid" means federal Pell grants under 20 USC 1070a
- 29 and tuition incentive program benefits under section 256 of the

- 1 school aid act of 1979, 1979 PA 94, MCL 388.1856. The term does not
- 2 include any of the following:
- 3 (i) Student loans.

- 4 (ii) Work-study awards.
- $\mathbf{5}$ (iii) Qualified withdrawals made from education savings accounts $\mathbf{6}$ to pay higher education expenses pursuant to the Michigan education
- 7 savings program act, 2000 PA 161, MCL 390.1471 to 390.1486.

act, 1986 PA 316, MCL 390.1421 to 390.1442.

- 8 (iv) Higher education expenses paid under the Michigan9 educational trust program, pursuant to the Michigan education trust
- 11 (ν) Higher education expenses paid under the Michigan promise 200e authority act, 2008 PA 549, MCL 390.1661 to 390.1679.
- 13 (f) "Half-time student" means a student enrolled in at least 6
 14 credit hours in an academic semester or the equivalent number of
 15 credit hours in a term or quarter, as determined by the department.
- 16 (g) "Industry-recognized certificate or credential" means a
 17 certificate or credential that is portable and is sought or
 18 accepted by multiple employers within an industry for purposes of
 19 recruitment, hiring, or promotion.
- (h) "Michigan reconnect grant student" means a student
 admitted to and enrolled in an eligible institution and receiving a
 Michigan reconnect grant under this part.
- (i) "Pell-eligible program" means a program eligible for grantfunding under 20 USC 1070a.
- Sec. 3. The Michigan reconnect grant program is created in the department for the purpose of providing Michigan reconnect grants to individuals eligible for those grants under sections 5 and 6.
- 28 The department shall do all of the following:
- 29 (a) Develop and administer the program.

- 1 (b) Create and maintain a program website.
- 2 (c) Create and maintain a marketing campaign for the program.
- 3 (d) Operate a help desk for the program.
- 4 (e) Create and maintain a network of navigators to help
- 5 Michigan reconnect grant students navigate the path to college,
- 6 supporting but not supplanting the programming and assistance
- 7 offered by community colleges.
- 8 (f) Provide Michigan reconnect grant students with information
- 9 about skills in demand and related compensation in the local labor
- 10 market.
- 11 (g) Partner with the center to report, in a user-friendly
- 12 format, credential completion outcomes of Michigan reconnect grant
- 13 students.
- 14 (h) To facilitate the reporting of valid and reliable
- 15 longitudinal data under subdivision (q), ensure that all eligible
- 16 institutions and other individuals and entities that participate in
- 17 the implementation of the Michigan reconnect grant program use the
- 18 unique statewide student identification codes issued by the center
- 19 to track Michigan reconnect grant students in accordance with
- 20 section 94a of the school aid act of 1979, 1979 PA 94, MCL
- **21** 388.1694a.
- (i) Select and convene a workgroup to study developmental
- 23 education placement policies appropriate for eligible institutions,
- 24 subject to all of the following:
- 25 (i) The workgroup must include representatives from the
- 26 governor's office, the legislature, eligible institutions, the
- 27 department of education, secondary schools, nonprofit
- 28 organizations, the United States Department of Labor's Office of
- 29 Apprenticeship, and the business community.

- (ii) Not later than 9 months after the effective date of this
 act, the workgroup shall provide the department with written
 recommendations that will assist the department in doing all of the
 following:
- 5 (A) Identify placement practices and policies that ensure 6 students know when remediation is required, what types of academic 7 and nonacademic supports will be available during remediation, and 8 when they can expect to complete credit-bearing English and 9 mathematics courses. Policies must emphasize placement in college-10 level courses for as many students as possible, with students requiring remediation being placed in appropriate programs. For 11 12 purposes of this sub-subparagraph, on and after January 1, 2022, a 13 remediation program is appropriate only if it complies with section 14 2(d)(v).
- (B) Encourage eligible institutions across this state to adoptconsistent placement polices.
- 17 (C) Clearly communicate sound policies for course placement18 and options for remedial courses.
- 19 (iii) Following the department's acceptance of the workgroup's 20 recommendations under subparagraph (ii), the workgroup shall disband.
- (i) Not later than 6 months after the effective date of this 22 23 act, organize regional meetings of labor market stakeholders, 24 including business organizations, trade unions, community colleges, 25 Michigan works agencies, private training providers, and regional 26 workforce and economic development representatives, to plan 27 effective ways to ensure that occupational certificates provided by 28 eligible institutions provide skills in demand in the regional 29 labor market.

- (k) As part of the department's responsibility to better
 connect education and training demands in the labor market with
 qualified degree, training, and apprenticeship programs, facilitate
 efforts by businesses, unions, and community colleges to
- 5 effectively match skills provided with those in demand.
- 6 (l) By not later than February 1 each year, beginning in 2021,
 7 provide a written report detailing the progress of the Michigan
 8 reconnect grant program to the chairpersons of the standing
 9 committees and the appropriations subcommittees of the house of
 10 representatives and senate having jurisdiction over legislation or
 11 oversight of appropriations pertaining to workforce development.
- 12 The report, at minimum, must include all of the following
 13 information for the immediately preceding academic year:
- (i) The total amount of Michigan reconnect grants awarded to Michigan reconnect grant students.
- 16 (ii) The total amount of funding used for oversight and

 18 but not limited to, total funding used for each of the following:
- 19 (A) Full-time equated positions.
- 20 (B) System improvements.

 services, including, but not limited to, total funding used for
 each of the following:
- 25 (A) Full-time equated positions.
- 26 (B) Case management.
- 27 (C) Technical assistance.
- 28 (iv) The total amount of funding used for marketing.
- (v) The total number of navigators employed by the department;

- 1 the total number of navigators assigned to each eligible
- 2 institution; and the number of Michigan reconnect grant students
- 3 assigned to each navigator, organized by eligible institution.
- $\mathbf{4}$ (vi) The total number of eligible institutions to which
- 5 Michigan reconnect grants were paid for credit to student accounts
- 6 under section 7; a list of the names of those eligible
- 7 institutions; and the total number and amount of Michigan reconnect
- 8 grants that were awarded, organized by eligible institution.
- 9 (vii) The total number of individuals who applied for Michigan
- 10 reconnect grants; the total number of individuals awarded those
- 11 grants; and the total number of grant recipients who earned either
- 12 an associate degree or industry-recognized certificate or
- 13 credential.
- 14 (viii) Any other relevant information, as determined by the
- 15 department.
- Sec. 4. Subject to appropriation, the department may expend
- 17 Michigan reconnect grant program money to award grants and support
- 18 its other duties as described in section 3.
- 19 Sec. 5. To establish initial eligibility for a Michigan
- 20 reconnect grant, an individual must meet all of the following
- 21 conditions by the date of his or her enrollment described in
- 22 subdivision (d):
- 23 (a) Be at least 25 years old.
- 24 (b) Be a resident of this state for at least the immediately
- 25 preceding year.
- 26 (c) Have graduated from high school with a diploma or
- 27 certificate of completion or achieved a high school equivalency
- 28 certificate. As used in this subdivision, "high school equivalency
- 29 certificate" means that term as defined in section 4 of the school

- 2 (d) Be admitted to, and enrolled as at least a half-time
- 3 student in, a Pell-eligible program at an eligible institution
- 4 leading to an associate degree or industry-recognized certificate
- 5 or credential.
- 6 (e) Not have previously earned an associate or baccalaureate7 degree.
- 8 (f) Timely complete a Michigan reconnect grant application in9 a form and manner determined by the department.
- 10 (g) Timely file the Free Application for Federal Student Aid11 for the enrollment period described in subdivision (d).
- (h) Timely apply for all available gift aid for the enrollmentperiod described in subdivision (d).
- Sec. 6. To establish continuing eligibility for a Michigan reconnect grant at an eligible institution, an individual must meet all of the following conditions:
- 17 (a) Continue to be a resident of this state.
- (b) Except as otherwise provided in section 8(1), maintain
 continuous enrollment as at least a half-time student in a Pelleligible program at an eligible institution leading to an associate
 degree or industry-recognized certificate or credential.
- (c) Maintain a 2.0 grade point average in courses taken by theindividual as a Michigan reconnect grant student.
 - (d) Participate in relevant academic and career advising programs offered by the eligible institution.
- (e) Timely file the Free Application for Federal Student Aid
 for each academic year in which he or she applies for a Michigan
 reconnect grant.
- 29 (f) Timely apply for all available gift aid for each academic

- 1 year in which he or she applies for a Michigan reconnect grant.
- 2 Sec. 7. Regardless of which community college district that a
- 3 Michigan reconnect grant student resides in, if any, the amount of
- 4 a Michigan reconnect grant must not exceed the cost of tuition at
- 5 the in-district resident rate and mandatory fees at the eligible
- 6 institution attended less all gift aid. Gift aid must be credited
- 7 first to the student's tuition and mandatory fees. If awarded,
- 8 Michigan reconnect grant money must be paid to the eligible
- 9 institution for credit to the student's account.
- 10 Sec. 8. (1) A Michigan reconnect grant student who takes a
- 11 leave of absence from an eligible institution due to a medical or
- 12 family hardship may, subject to department approval, continue to
- 13 receive the grant upon resuming the student's education at an
- 14 eligible institution if the student continues to meet all
- 15 applicable eligibility requirements. A leave of absence under this
- 16 subsection does not disrupt the requirement of continuous
- 17 enrollment under section 6(b) and does not count toward the 4-year
- 18 limitation described in subsection (2)(a).
- 19 (2) A student is eligible for a Michigan reconnect grant until
- 20 the occurrence of either of the following:
- 21 (a) Subject to subsection (1), 4 years have passed since the
- 22 student became a Michigan reconnect grant student.
- 23 (b) The student has earned an associate degree. For purposes
- 24 of this subdivision, a student who has earned a certificate or
- 25 credential at an eligible institution remains eligible for the
- 26 Michigan reconnect grant if he or she has not yet earned an
- 27 associate degree.
- 28 (3) A student who participates in the Michigan reconnect grant
- 29 program may transfer from 1 eligible institution to another

- 4 Sec. 9. Under this part, the department shall promulgate rules
- 5 to implement sections 3(h) and 5 only, pursuant to the
- 6 administrative procedures act of 1969, 1969 PA 306, MCL 24.201 to
- 7 24.328, subject to all of the following:
- 8 (a) Under section 3(h), any data reporting system and
- **9** penalties for noncompliance established by the department must be
- 10 narrowly tailored to the purposes described in section 3(h).
- 11 (b) Under section 5, the department is limited to developing
- 12 the form for the Michigan reconnect grant application and
- 13 prescribing the time and manner of its completion, as provided in
- 14 section 5(f), and applying the initial eligibility criteria listed
- 15 in section 5(a) to (e), (g), and (h). The department shall not
- 16 apply any initial eligibility criteria not listed in section 5.

 14 CFR 680.410.
- 15 (ii) A consortium of businesses in this state offering
 16 occupational training that guarantees employment for those who
 17 successfully complete the training and is included on this state's
 18 eligible training provider list located within the department
 19 pursuant to 20 CFR 680.410.
- Sec. 11. The reconnect private training learning initiative is created in the department for the purpose of providing skills scholarships to individuals eligible for those scholarships under this section. The department shall do all of the following:
 - (a) Develop and implement a process by which those seeking to participate in the reconnect private training learning initiative as a qualified private training institution offering qualified occupational training programs must apply to the department.
- (b) Approve as a qualified occupational training program aprogram for which an application is submitted under subdivision (a)

 - (f) Award skills scholarships, subject to all of the following:
- 22 (i) A skills scholarship is a 1-time grant not to exceed 23 \$1,500.00 to contribute to tuition costs for a qualified 24 occupational training program at a qualified private training 25 institution, both of which are approved under this section, for a 26 training program participant who meets the requirements of 27 subparagraph (ii). A skills scholarship is available under this 28 section only if the training program participant has applied for 29 all other gift aid, if any is available, and must not cause the

- 1 rules to implement section 11(a), (b), and (d) only, pursuant to
- 2 the administrative procedures act of 1969, 1969 PA 306, MCL 24.201
- 3 to 24.328, subject to all of the following:
- 4 (a) Under section 11(a), the department is limited to
- 5 developing the form for the application described in section 11(a)
- 6 and prescribing the time and manner of its completion.
- 7 (b) Under section 11(b), the department is limited to applying
- 8 the eligibility criteria described in section 11(b) and shall not
- 9 apply any other eligibility criteria.
