ENROLLED HOUSE BILL No. 4338

AN ACT to make appropriations for the state institutions of higher education and certain state purposes related to education for the fiscal year ending September 30, 1990; to provide for the expenditures of those appropriations; and to prescribe the powers and duties of certain state departments, institutions, agencies, and officers.

The People of the State of Michigan enact:

Sec. 101. There is appropriated for the state institutions of higher education and certain state purposes related to education, and subject to the conditions set forth in this act, for the fiscal year ending September 30, 1990, the following respective amounts:

GENERAL SECTIONS

Sec. 201. In accordance with the provisions of section 30 of article IX of the state constitution of 1963, total state spending in this appropriation act is \$1,195,518,820.00. There are no state appropriations to be paid to local units of government in section 101.

Sec. 202. (1) The sums appropriated in this act shall be paid out of the state treasury and shall be distributed by the state treasurer to the respective institutions in 12 monthly installments, except for the Martin Luther King, Jr.-Cesar Chavez-Rosa Parks programs which shall receive distributions in quarterly installments. If the appropriations for the Martin Luther King, Jr.-Cesar Chavez-Rosa Parks programs are not committed or awarded by April 1, 1990 the funds shall become subject to legislative transfer. Any unexpended and unencumbered funds remaining on September 30, 1990 from the amount appropriated for the Martin Luther King, Jr.-Cesar Chavez-Rosa Parks programs shall lapse on September 30, 1990 and shall be returned to the state general fund. The amount distributed to an institution shall not exceed the net appropriations plus additional distributions specifically authorized by this act.

- (2) Each institution shall receive payments providing the same percentage increase in its 1989-90 institutional fiscal year over its 1988-89 fiscal year as the percentage increase in state appropriations to each institution for the state fiscal year 1989-90 over 1988-89, based on the appropriations and scheduled allotments provided under Act Nos. 139 and 201 of the Public Acts of 1987 and Act No. 325 of the Public Acts of 1988.
- (3) A detailed description of procedures utilized to arrive at the amounts appropriated in section 101 shall be submitted to each institution by the senate and house fiscal agencies. That description shall include, but is not limited to, a detailed expenditure history of the student equity plan that was initially implemented in the fiscal year ending September 30, 1988. The expenditure history shall be calculated for each recipient institution based on HEIDI expenditure data.
- (4) From the amounts appropriated in section 101, institutions shall reimburse the Michigan public school employees' retirement system at the rate of 9.0% of retirement members' salaries.

- Sec. 203. (1) All colleges and universities shall furnish all program and financial information that is required by and in a manner prescribed by the state budget director or the house and senate appropriations committees.
- (2) Pursuant to section 4 of article VIII of the state constitution of 1963, all state institutions of higher education shall furnish an annual accounting of all income and expenditures to the legislature and the state budget director.
- Sec. 204. Money received by the state from the federal government or private sources for the use of a college or university is appropriated for the purpose for which it was provided. The acceptance and use of federal or private funds shall not place an obligation upon the legislature to continue the purposes for which the funds are made available.
- Sec. 205. The appropriations contained in this act shall not be used for the construction of buildings or operations of institutions of higher education not expressly authorized in section 101.
- Sec. 206. The appropriations in this act are subject to section 391 of the management and budget act, Act No. 431 of the Public Acts of 1984, being section 18.1391 of the Michigan Compiled Laws.
- Sec. 207. Each institution that is appropriated funds under this act shall comply with requests for data made by the Michigan postsecondary education database policy council.
- Sec. 208. The appropriations contained in this act shall not be expended for renting, purchasing, or showing any movie film determined to be obscene pursuant to Miller v California, 413 U.S. 15 (1973).

GRANTS AND FINANCIAL AID

- Sec. 301. Payments of the amounts included in section 101 for the state competitive scholarship program established under Act No. 208 of the Public Acts of 1964, being sections 390.971 to 390.981 of the Michigan Compiled Laws, shall be made as follows:
- (a) \$1,200.00 maximum per award in accordance with section 3(1) of Act No. 208 of the Public Acts of 1964, being section 390.973 of the Michigan Compiled Laws.
 - (b) \$23,223,929.00 total state general fund.
- (c) If a student who receives an award under this section for academic year 1989-90 has his or her tuition and fees paid under the Michigan education trust program and still has financial need, the funds awarded under this section may be used for educational expenses other than tuition and fees.
- Sec. 302. (1) The amounts appropriated in section 101 for the state tuition grant program established under Act No. 313 of the Public Acts of 1966, being sections 390.991 to 390.997a of the Michigan Compiled Laws, shall not exceed the following:
 - (a) \$2,300.00 maximum per grant.
 - (b) \$46,746,081.00 total state general fund.
- (2) Tuition grant awards shall be made to all eligible Michigan residents who apply before September 1, 1989, and who are qualified.
- (3) The Michigan higher education assistance authority shall determine an actual maximum tuition grant award amount per student that ensures that the aggregate payments for the tuition grant program do not exceed the appropriation contained in section 101 for the state tuition grant program.
- (4) Any unexpended and unencumbered funds remaining on September 30, 1990 shall be distributed among late applicants, not to exceed the appropriated amount in section 101.
- (5) If a student who receives an award under this section for academic year 1989-90 has his or her tuition and fees paid under the Michigan education trust program and still has financial need, the funds awarded under this section may be used for educational expenses other than tuition and fees.
- Sec. 303. Included in the appropriation in section 101 is funding for the Michigan work study program established under Act No. 303 of the Public Acts of 1986, being sections 390.1321 to 390.1332 of the Michigan Compiled Laws. Of the amount appropriated for the Michigan work study program, at least \$535,760.00 shall be allocated for graduate work study. An effort should be made by each institution participating in the Michigan work study program to assure that not less than 10% of those undergraduate, graduate, and professional students eligible to participate in the program are placed with for-profit employers no later than

December 31, 1989. The authority shall submit a report to the clerk of the house and the secretary of the senate no later than March 31, 1990, specifying the level of participation by each institution, the barriers to the achievement of the 10% for-profit participation level by each institution, and recommendations for addressing those barriers.

- Sec. 304. (1) Payments of the amounts included in section 101 for the general degree reimbursement program established under Act No. 75 of the Public Acts of 1974, being sections 390.1021 to 390.1027 of the Michigan Compiled Laws, shall be made as follows:
- (a) The reimbursement rate per eligible degree shall be the equally prorated amount permitted by the appropriation, except that the amount of the reimbursement for each associate degree shall be 1/2 of the rate of reimbursement for each bachelor or master degree.
 - (b) Total general degree reimbursement payments shall not exceed \$4,205,859.00.
- (c) From the general degree reimbursement program, \$135,300.00 shall be provided to Spring Arbor college for the southern Michigan state prison program.
- (d) From the general degree reimbursement program, \$200,500.00 shall be provided to the university of Detroit for graduate research aid.
- (e) From the general degree reimbursement program, \$30,100.00 shall be provided to Marygrove college for learning clinics.
- Sec. 305. Payments of the amounts included in section 101 for the allied health degree reimbursement program established under Act No. 75 of the Public Acts of 1974, being sections 390.1021 to 390.1027 of the Michigan Compiled Laws, shall be made as follows:
- (a) The reimbursement rate per eligible degree shall be the equally prorated amount permitted by the appropriation.
 - (b) Total allied health degree reimbursement payments shall not exceed \$659,197.00.
- Sec. 306. (1) Funds disbursed through the degree reimbursement programs shall not be used by any recipient institution for theology or divinity programs.
- (2) Each eligible institution shall be provided on October 1, 1989, or as soon as possible thereafter, a preliminary payment of at least 75%, but not more than 90%, of its estimated degree reimbursements under section 101. The balance of the degree reimbursement to each eligible institution shall be provided when the numbers of earned degrees conferred and total amounts to be paid are certified.
- Sec. 307. The funds appropriated in section 101 for the American Indian tuition waiver reimbursement established under Act No. 174 of the Public Acts of 1976, being sections 390.1251 to 390.1253 of the Michigan Compiled Laws, are to reimburse tuition waivers granted by colleges before September 30, 1988. Only those expenses classified as tuition assessments are eligible for reimbursement, except that if a student who receives an award under this section for academic year 1989-90 has his or her tuition and fees paid under the Michigan education trust program and still has financial need, the funds awarded under this section may be used for educational expenses other than tuition and fees.
- Sec. 308. Included in the appropriations in section 101 for higher education are \$500,000.00 for the establishment of the Robert C. Byrd honors scholarship program. Pursuant to the implementation of this program, the legislature encourages the department of education to distribute funds for this scholarship program to each high school in this state and to allow each high school to select a merit scholar.
- Sec. 309. To enable the legislature to evaluate the appropriation needs of institutions of higher education, each independent college and university shall make available to the legislature, upon request, data regarding grants for the preceding, current, and ensuing fiscal years.
- Sec. 310. The auditor general shall audit selected enrollments, degrees, and awards at selected independent colleges and universities receiving awards administered by the department of education. The audits shall be based upon definitions and requirements established by the department of management and budget and the senate and house fiscal agencies. The auditor general shall submit a report of findings to the senate and house appropriations committees not later than May 1, 1990.

STATE UNIVERSITIES

Sec. 401. The legislature encourages the development of an educational reciprocity program between Lake Superior state university and the colleges of northern Ontario, Canada.

Sec. 402. Student health services at state universities shall be self-supporting through student and user fees.

Sec. 403. (1) The auditor general shall audit enrollments at all public universities. The audits shall be based upon the definitions and requirements established by the department of management and budget and the senate and house fiscal agencies. The audits shall be based on uniform reporting categories and shall include HEIDI data. The auditor general shall submit a report of findings to the senate and house appropriations committees no later than March 1, 1990.

- (2) Student credit hours reports shall not include the following:
- (a) Student credit hours generated through correspondence courses, credit by examination, or inmate prison programs regardless of teaching location.
- (b) Student credit hours generated in new degree programs after January 1, 1975, that have not been specifically authorized for funding by the legislature, except spin-off programs converted from existing core programs that do all of the following:
 - (i) Represent new options, fields, or concentrations within existing programs.
 - (ii) Are consistent with the current institutional role and mission.
 - (iii) Are accommodated within the continuing funding base of the institution.
- (iv) Do not require a new degree level beyond that which the institution is currently authorized to grant within that discipline or field.
- (v) Do not require special grant funding from the state. As used in this subparagraph, "special grant funding" means funding in addition to that provided by the student credit hours generated within the program, either before program initiation or within the first 3 years of program operation.

Sec. 403a. (1) Pursuant to section 403, the following degree programs may be established:

- (a) A bachelor's degree in facilities management by Ferris state university.
- (b) A bachelor's degree in fire science by Lake Superior state university.
- (c) A bachelor's degree in business administration-hospitality by Lake Superior state university.
- (d) A bachelor's degree in pathologist assistant by Wayne state university.
- (e) A bachelor's degree in management information systems by Wayne state university.
- (f) A master's degree in physical therapy by Grand Valley state university.
- (g) A master's degree in surgery by Michigan state university.
- (h) A master's degree in physical therapy by Oakland university.
- (i) A master's degree in hazardous waste management by Wayne state university.
- (j) A master's degree in industrial engineering by western Michigan university.
- (k) A doctor of pharmacy degree by Ferris state university.
- (1) A doctorate degree in pathology by the university of Michigan-Ann Arbor.
- (m) A doctorate degree in cancer biology by Wayne state university.
- (2) The listing of degree programs in subsection (1) shall not constitute legislative intent to provide additional dollars for these programs.

Sec. 404. Included in the amounts appropriated in section 101, there is appropriated to Wayne state university the sum of \$440,000.00 for cooperative leadership skills programs for trade union minorities and women. This program is to be offered by a consortium consisting of eastern Michigan university, Michigan state university, northern Michigan university, Oakland university, university of Michigan, and Wayne state university. Wayne state university shall act as fiscal agent, and the funds shall be divided among the participating universities.

Sec. 405. Included in the amounts appropriated in section 101 are funds for the following consortia projects:

- (a) Northern inter-collegiate research sharing consortium central Michigan university and Kirtland community college.
 - (b) Industrial development institute Michigan state university and Lansing community college.
- (c) Enabling technology consortium university of Michigan, Michigan state university, and Wayne state university.
- (d) Kalamazoo consortium western Michigan university, Kalamazoo valley community college, Kalamazoo college, Davenport college, and Nazareth college.

- (e) Urban teacher education consortium eastern Michigan university, Wayne state university, and Wayne county community college.
- (f) Michigan higher education institute Michigan state university, Grand Valley state university, and western Michigan university.
 - (g) Grand Rapids applied technology center Ferris state university and Grand Rapids junior college.
 - (h) Race relations consortium Wayne state university and western Michigan university.
- Sec. 406. The principal executive officer of each institution of higher education receiving an appropriation under this act shall expend a portion of the funds appropriated to the institution in reporting to the house and senate appropriations committees, the auditor general, the senate and house fiscal agencies, and the department of management and budget within 60 days after the auditor general issues his or her annual report on the operation of the institution. The institution's report shall specify all of the following:
- (a) The recommendations of the auditor general implemented by the institution, including projected dates and resources required, if any, to achieve compliance.
- (b) The recommendations of the auditor general not implemented by the institution or implemented by the institution as modified.
- (c) The rationale for not implementing a recommendation of the auditor general or of implementing a recommendation as modified.
- Sec. 407. From the funds appropriated in section 101 for Michigan state university cooperative extension service, the legislature encourages that \$250,000.00 be expended for the expanded food and nutrition education program.
- Sec. 408. From the amount appropriated in section 101 for state universities, \$30,000.00 shall be expended to establish a systematic method for universities to inform school districts regarding the number of students from their districts who are enrolled in remedial/developmental course work. The presidents council of state universities shall submit a report, not later than January 31, 1990, to the chairs of the house and senate appropriations committees concerning the progress made in establishing the reporting system described in this section. Each university shall allocate \$2,000.00 of the funds appropriated to their institution in section 101 to promote communication between school district personnel and university personnel so that a cooperative effort can be made to improve student academic preparation.
- Sec. 409. To encourage more students to study mathematics in high school and to reduce the amount of remediation in the mathematics area at the college and university level, \$190,500.00 is appropriated in section 101 for the Michigan mathematics early placement test. Included within the appropriation in section 101 for each state university is \$12,700.00 for activities to increase both the number of students and high schools participating in the Michigan mathematics early placement test, a program of the presidents council of state universities. A report on the results of the mathematics early placement test program shall be submitted by the presidents council of state universities to the house and senate higher education appropriations subcommittees by June 15, 1990.
- Sec. 410. (1) Included in the appropriation for each Michigan public university from the amount in section 101 is funding for the Martin Luther King, Jr.-Cesar Chavez-Rosa Parks visiting professors program.
- (2) Universities with student head count totals exceeding 20,000 for the fall of 1987 are appropriated \$85,000.00 each. Universities with student head count totals of less than 20,000 for the fall of 1987 are appropriated \$21,200.00 each.
- (3) Martin Luther King, Jr.-Cesar Chavez-Rosa Parks visiting professors program funds shall be expended to increase the number of minority instructors in the classroom and provide role models for underrepresented minority students.
- (4) The presidents council of state universities shall report by October 30, 1989 to the house and senate appropriations committees, the office of minority equity in postsecondary education, and the department of management and budget all of the following Martin Luther King, Jr.-Cesar Chavez-Rosa Parks visiting professors program information:
 - (a) Names of visiting professors.
 - (b) Courses instructed by visiting professors.
 - (c) Duration and dates of instruction.
- (d) Employment status, excluding Martin Luther King, Jr.-Cesar Chavez-Rosa Parks visiting professor duties.

- (e) Race and sex of visiting professors.
- (5) Martin Luther King, Jr.-Cesar Chavez-Rosa Parks visiting professor funds shall be equally matched with institution funding devoted to the purpose stated in subsection (3). No part of the visiting professor funds or the institution's matching funds shall be deducted to cover indirect costs.
- (6) A Martin Luther King, Jr.-Cesar Chavez-Rosa Parks visiting professor shall be limited to receiving 1 Martin Luther King, Jr.-Cesar Chavez-Rosa Parks visiting professor award per year at any 1 of the state public universities. An applicant for a visiting professor award shall provide all of the following information to the office of minority equity in postsecondary education at the time of application:
 - (a) The name of each institution where the applicant has served in a visiting professor capacity.
 - (b) Courses instructed as a visiting professor at each institution.
 - (c) Money earned for serving as a visiting professor at each institution.
 - (d) The dates during which the applicant served as a visiting professor at each institution.
- Sec. 411. (1) Included in the appropriation for each public university in this state from the amount appropriated in section 101 is funding for a Martin Luther King, Jr.-Cesar Chavez-Rosa Parks fellowship/scholarship program. The Martin Luther King, Jr.-Cesar Chavez-Rosa Parks fellowship/scholarship program is intended to increase the pool of minority candidates pursuing academic careers in postsecondary education in this state.
- (2) The Martin Luther King, Jr.-Cesar Chavez-Rosa Parks fellowship/scholarship program shall be administered by each institution. Each institution may grant a scholarship or fellowship to a student to attend any Michigan university. An award shall be granted to a candidate considered by the granting institution to be an underrepresented minority in that academic field of study. University of Michigan-Ann Arbor, Michigan state university, Wayne state university, and western Michigan university may grant only fellowships under this program.
 - (3) A Martin Luther King, Jr.-Cesar Chavez-Rosa Parks fellowship shall be awarded to a candidate who will:
- (a) Begin an academic career in a Michigan postsecondary educational institution within 1 year after attaining his or her doctorate degree.
 - (b) Remain in an academic career in Michigan postsecondary education for a period of not less than 3 years.
 - (c) Pursue a doctorate at a Michigan postsecondary educational institution.
- (4) A Martin Luther King, Jr.-Cesar Chavez-Rosa Parks fellowship/scholarship is intended to offset any educational or living expenses that the fellow or scholar may incur, so long as the student remains in good academic standing as defined by the host institution.
- (5) A Martin Luther King, Jr.-Cesar Chavez-Rosa Parks fellowship award shall not exceed \$25,000.00 for a student pursuing a doctorate degree, and a Martin Luther King, Jr.-Cesar Chavez-Rosa Parks scholarship award shall not exceed \$15,000.00 for a student pursuing a master's degree. Martin Luther King, Jr.-Cesar Chavez-Rosa Parks scholarship recipients are to be considered candidates for the Martin Luther King, Jr.-Cesar Chavez-Rosa Parks fellowship program, when eligible.
- (6) A Martin Luther King, Jr.-Cesar Chavez-Rosa Parks fellow has 6 years in which to attain his or her doctorate degree. This 6-year period begins after obtaining a master's degree or spending an equivalent 2-1/2 year period at master's level studies. A Martin Luther King, Jr.-Cesar Chavez-Rosa Parks scholar shall attain the master's degree within 2-1/2 years of receiving the award. The Michigan higher education assistance authority may extend these periods by 1 year for good cause.
- (7) The Martin Luther King, Jr.-Cesar Chavez-Rosa Parks fellowship/scholarship shall be defaulted and considered a loan subject to repayment in full to the state if any 1 of the following occurs:
 - (a) The recipient fails to maintain good academic standing at the postsecondary institution.
 - (b) The recipient fails to attain the appropriate degree in the time required by subsection (6).
- (c) The recipient fellow does not meet the requirements of subsection (3)(a) and (b), or the recipient scholar does not meet the requirements of this section.
- (8) The first fellowship/scholarship repayment is due within 1 year of fellowship/scholarship default, as described in subsection (8). The loan amount to be repaid shall include the fellowship/scholarship award, plus interest calculated at a rate not less than that of the guaranteed student loan at the time of default, and collection fees including attorney fees, according to a schedule established by the Michigan higher education assistance authority. Interest amounts shall be calculated pursuant to the interest computation procedures of the guaranteed student loan program. Repayment shall be made according to a schedule published by the Michigan higher education assistance authority. The schedule shall call for repayment of the loan within a period of not more than 10 years, or monthly repayment of \$100.00, whichever is less.

- (9) Each university granting Martin Luther King, Jr.-Cesar Chavez-Rosa Parks awards shall require recipients to sign an agreement specifying acceptance of the terms of the award.
- (10) The Michigan higher education assistance authority shall implement and administer the loan repayment provisions of subsections (7) and (8).
- (11) The Michigan higher education assistance authority shall report by September 30, 1990, and each year thereafter, on September 30, to the house and senate appropriations committees and the office of minority equity in postsecondary education all of the following information:
 - (a) Names of student fellows/scholars, the institutions, and fields of study.
- (b) Names of scholars having completed their master's degree requirements and their current educational status.
- (c) Names of fellows having completed their studies, and their current employment status or employing institutions, or both.
- (d) Names of fellows/scholars in default as described in subsection (7), and the status of their Martin Luther King, Jr.-Cesar Chavez-Rosa Parks fellowship/scholarship repayment.
- (12) Martin Luther King, Jr.-Cesar Chavez-Rosa Parks fellowship/scholarship funds shall not supplant institutional funding devoted to the purpose stated in subsection (1).
- (13) On April 15, 1990, each university shall report to the office of minority equity in postsecondary education the name and social security number of each recipient of a Martin Luther King, Jr.-Cesar Chavez-Rosa Parks scholarship or fellowship, and the amount, date, and duration of the award.
- (14) If any funds are not awarded or committed by a university to a specific recipient by April 1, 1990, the department of management and budget may recommend legislative transfers to other Martin Luther King, Jr.-Cesar Chavez-Rosa Parks line items within a university or to Martin Luther King, Jr.-Cesar Chavez-Rosa Parks line items at another university.
- Sec. 412. (1) Included in section 101 is funding for the Martin Luther King, Jr.-Cesar Chavez-Rosa Parks college day program. The Martin Luther King, Jr.-Cesar Chavez-Rosa Parks college day program is an intervention program intended to introduce school children underrepresented in postsecondary education to the potential of a college education.
- (2) The programs shall provide a day, overnight, or extended experience on the college campus for pupils in grades 7 through 11, if the program meets the intent stated in subsection (1), and is designed primarily as a motivational program to inspire targeted pupils to pursue a college education. It is not designed principally as an academic or athletic skills development program.
- (3) If possible and practical, the program shall focus on serving those 35 school districts with the highest percentage of minority pupils as reported to the Michigan department of education. However, all eligible pupils from the participating school districts shall be included in this program, regardless of the pupil's race.
- (4) Each pupil participating in the program shall be provided with standard appropriate background information describing the Michigan postsecondary education system, both 2-year and 4-year public and independent degree granting colleges and universities, the opportunities afforded by a college experience, admissions requirements, and financial aid availability. The Michigan department of education shall develop and make available this material.
 - (5) Individual program plans shall include all of the following:
- (a) A budget of equal contributions from this program, the participating public university, the participating school district, and the participating independent degree granting college. No college day funds may be deducted to cover indirect costs. No more than 20% of the university match may be attributable to indirect costs.
- (b) A letter of support signed by the superintendents of the participating school districts and the presidents or chancellors of the participating colleges and universities named in subsection (5)(a).
- (c) The formal involvement of the appropriate public 2-year colleges and independent degree granting colleges in the college day program.
- (6) The presidents council of state universities shall report by September 30, 1990, and each year thereafter, to the house and senate fiscal agencies, the office of minority equity in postsecondary education, and the department of management and budget all of the following for each participating university and school district:
 - (a) Number of pupils participating and their schools.
 - (b) Age, race, and sex of participating pupils.
 - (c) Description of the college experience offered by the program to the pupils.
 - (d) A copy of the program plans described in subsection (5).
 - (e) A copy of the program budget.

- (7) The participating school district, the participating colleges and universities, and the presidents council of state universities shall retain the information as is necessary to assess the long-range impact of the Martin Luther King, Jr.-Cesar Chavez-Rosa Parks college day program on the high school graduation rate, college attendance of participating pupils, or any other benefits that may be realized by this program.
- (8) The universities shall submit a report to the office of minority equity in postsecondary education by January 30, 1990, detailing their plans for college day activities for the 1990-91 fiscal year.
- Sec. 413. Included in the amounts contained in section 101, Wayne state university is granted \$320,000.00 for the college of education to deliver professional school district programs to meet their service needs. A minimum of \$100,000.00 shall be allocated for the establishment and maintenance of a staff development/school improvement program with the intermediate school district servicing its area.
- Sec. 414. (1) The research excellence fund for which funds are appropriated in section 101 is created to support research programs at the public universities of this state.
- (2) The research excellence funds shall not be released to the eligible institution until the institution's research proposals are approved by a review panel created pursuant to subsection (3).
- (3) The review panel shall be composed of 3 members who shall serve without compensation. The membership of the panel shall consist of the chairs of both the house and senate higher education appropriations subcommittees and 1 member to be appointed by the director of the department of management and budget. The director of the department of commerce and the president of the Michigan strategic fund may serve as ex officio members of the panel.
- (4) The review panel may approve all or part of an institution's research proposal. The review panel shall respond to each research proposal within 30 days after submission. Funds for the approved research proposals or any part of the funds shall be released for payment to the institution within 30 days after approval of the award. The review panel shall submit a copy of each research proposal received, and grant award notification, to the speaker and minority leader of the house, the majority and minority leaders of the senate, and the chairs of the house and senate appropriations committees.
- (5) The research proposals shall be submitted to the review panel in 1 complete, comprehensive research proposal. The research proposals shall be evaluated according to the following criteria:
 - (a) Leads to the development of scientific or technological discoveries.
 - (b) Applies scientific or technological discoveries or advances to new applications.
 - (c) Provides a tangible, direct benefit to the economy of the state or region.
 - (d) Is of general interest to an entire industrial field.
 - (e) Contributes directly or indirectly to the development of additional products or processes.
 - (f) The applicant demonstrates the capability to implement the proposed project.
 - (g) The applicant has an ability to generate outside funding sources for the proposal.
- (h) The applicant demonstrates the ability or submits a plan for transferring research results or technology advances to the private sector.
- (6) Proposals shall be submitted to the review panel before October 15, 1989, in a form and manner as prescribed by the department of management and budget. The department of management and budget shall submit a comprehensive research excellence fund annual report within 60 days after the end of the fiscal year to those legislators listed in subsection (4).
- (7) Of the amount appropriated in section 101 for the research excellence fund, \$500,000.00 shall be reserved for distribution as competitive grants. The review panel created pursuant to subsection (3) shall review all grant requests and shall make its awards not later than February 1, 1990.
- (8) Universities receiving research excellence fund grants shall not deduct an amount from the grant award to cover indirect costs or supplant existing research resources with research excellence funds.
- Sec. 415. (1) Included in the amounts contained in section 101, Oakland university is granted \$220,000.00 for the labor education service program.
- (2) Included in the amounts contained in section 101, Oakland university is granted \$30,000.00 for community services of Oakland.
- Sec. 416. The legislature recognizes the value of cooperative programs between state universities and community colleges aimed at stimulating economic development and diversification in this state. It is the intent of the legislature to encourage continued development and expansion of these cooperative programs in the years ahead.

- Sec. 417. It is the intent of the legislature that eastern Michigan university shall coordinate a professional teacher development program for local area school districts.
- Sec. 418. (1) From the amount appropriated in section 101 for select student support services programs, \$1,552,500.00 is allocated for developing academically and economically disadvantaged student retention programs for 4-year public and independent educational institutions in this state.
- (2) Not later than January 1, 1990, the office of minority equity in postsecondary education shall develop and make available proposal guidelines to eligible 4-year institutions for programs described in subsection (1). Each proposal shall be submitted to the office not later than February 15, 1990.
- (3) A committee shall be established to review submitted proposals and to make recommendations. The committee shall be composed of 1 member appointed by the office of minority equity in postsecondary education, 1 member appointed by the association of independent colleges and universities of Michigan, and 3 members appointed by the presidents council of state universities.
- (4) A 3-member review panel composed of 1 member appointed by the speaker of the house of representatives, 1 member appointed by the majority leader of the senate, and 1 member appointed by the state budget director shall review all committee recommendations and make awards.
- (5) The review panel shall make its awards to eligible institutions not later than April 1, 1990. An award to any 1 institution shall not be greater than \$150,000.00, and the amount awarded shall be matched on an 80% state, 20% college-university basis.
- (6) An educational institution that receives an award under this section shall report by September 30, 1990 to the house and senate appropriations committees, the office of minority equity in postsecondary education, and the department of management and budget all of the following information:
 - (a) A description of select student support services programs initiated.
 - (b) The number of participants, measured in head count, by racial, ethnic, and 4-S program category.
- (c) Other information considered necessary or appropriate by the office of minority equity in postsecondary education.
- (7) The funds awarded under this section shall not supplant institutional funding devoted to the purpose described in subsection (1).
- Sec. 419. It is the intent of the legislature in expending funds for the operation of the D. J. Jacobetti vocational skill center that the following activities be performed in order to insure that the integrity and the original role set forth for the vocational skill center be retained:
- (a) Insuring the flexibility and adequate autonomy that will enable the vocational skill center to expand, upgrade, and modify its existing programs as well as to develop new vocational programs in partnership with its industrial, commercial, agency, and labor advisories. The length and content of programs at the skill center, whether they be certificate, 1-year, or 2-year, shall be determined by the performances required in the marketplace rather than by baccalaureate criteria.
- (b) Developing a ladder of articulation at northern Michigan university that grants fair value for vocational skill center credits that constitute a viable portion of a related 2- or 4-year baccalaureate career ladder. This articulation process shall be accomplished without nullifying the intent of the vocational program or consuming those programs into the baccalaureate department.
- (c) Funding the skill center for its credit hour production in a manner equitable to other vocational technical centers.
- (d) Placing the vocational skill center budget funds and the decision making process for housing certificate and 1- or 2-year vocational technical programs within the vocational skill center under the direct supervision of the vocational skill center administration in order to insure the integrity and the continuation of the role of the skill center.
- Sec. 420. Included in the appropriation in section 101 is funding for tuition stabilization. This funding is included to recognize Wayne state university, Saginaw valley state university, northern Michigan university, grand valley state university, central Michigan university, Lake Superior university, and eastern Michigan university for maintaining low levels of tuition.
- Sec. 421. From the amounts appropriated in section 101 for operations for each public institution, at least 1.5% shall be expended for physical plant maintenance. Each university shall submit a report delineating their 1988-89 plant maintenance expenditures to the senate and house appropriations subcommittees on higher education not later than January 1, 1990.

- Sec. 422. The university of Michigan biological station at Douglas lake in Cheboygan county is regarded as a unique resource and is designated as a special research reserve. It is the intent of the legislature to protect and preserve the unique long-term research value and capabilities of the biological station area and Douglas lake. The legislature further intends that no state programs or policies be developed that would have a deleterious impact on the research value of Douglas lake.
- Sec. 423. (1) Included in section 101 is funding for a linkage program between public 4-year universities and public community colleges. The purpose of this program is to increase the number of underrepresented minority students who transfer from community colleges into baccalaureate programs.
- (2) The grants shall be made under this program to Michigan public universities. The grants shall reflect geographic diversity.
- (3) Not later than October 1, 1989, the office of minority equity in postsecondary education shall develop and make available proposal guidelines to eligible universities. Each proposal shall be submitted to the office not later than October 30, 1989.
- (4) The office of minority equity in postsecondary education shall review submitted proposals and make recommendations to the Martin Luther King, Jr.-Cesar Chavez-Rosa Parks review panel established in section 417.
- (5) The review panel shall review the recommendations of the office of minority equity in postsecondary education and make awards not later than November 15, 1989. An award to any 1 institution shall not be greater than \$150,000.00, and the amount awarded shall be matched on an 80% state, 20% university basis.
- (6) An educational institution that receives an award under this section shall report by September 30, 1990, to the house and senate appropriations committees, the department of management and budget, and the office of minority equity in postsecondary education in the manner requested by the office of minority equity in postsecondary education on the progress made to increase the number of minority students transferring from the community college into baccalaureate degree programs.
- (7) The funds awarded under this section shall not supplant institutional funding devoted to the purpose described in subsection (1).
- Sec. 424. Included in the appropriation in section 101 for the Martin Luther King, Jr.-Cesar Chavez-Rosa Parks program is \$132,000.00 for a media presentation program. From this amount, the office of minority equity, in collaboration with the American association of university professors, shall develop media presentations to motivate minority students to enter higher education and to instruct minority students and their families in college and financial aid opportunities.
- Sec. 425. Included in the appropriation in section 101 for each university except central Michigan university, Ferris state university, and Oakland university is funding for an enrollment adjustment factor based on student head count changes from 1987-88 to 1988-89. The following equation shall be utilized to determine this 1-time funding amount each school shall receive as an enrollment adjustment factor:
- (FALL HEAD COUNT 1988 FALL HEAD COUNT 1987) X \$600.00 = ENROLLMENT ADJUSTMENT FACTOR FOR FY 1989-90.
- Sec. 426. Recognizing that each public 4-year institution has a distinctive role and mission and that faculty assignments vary widely due to differing emphasis on teaching, research, and service responsibilities, it is the intent of the legislature to review the status of faculty productivity. Included in section 101 is an appropriation of \$75,000.00 to conduct a faculty productivity study to be completed by April 1, 1990. It is expected that the study will be performed by an external consultant, jointly retained by the house and senate subcommittees on higher education, utilizing a competitive bidding process administered by the department of management and budget. The presidents council of state universities shall make appropriate advisory services available to the consultant as the study is implemented. A report detailing the results of the study shall be submitted to the house and senate higher education appropriations subcommittees no later than April 15, 1990.
- Sec. 427. (1) Included in the appropriation in section 101 is \$225,000.00 for scholarships for students participating in a full-year academic year program at the Japan center for Michigan universities. Individual scholarships shall not exceed \$7,500.00. This scholarship program is under the jurisdiction of the presidents council of state universities. A report on the expenditure of these funds shall be submitted to the house and senate higher education appropriations subcommittees and to the Michigan higher education assistance authority no later than March 1, 1990.
- (2) It is the intent of the legislature to enable Michigan university students to study the language and culture of Japan in the prefecture of Shiga, Michigan's sister state. The amount of \$81,000.00 is appropriated for the

Japan center for Michigan universities. The amount of \$5,400.00 is included in the appropriation for each university for the administration of the Japan center for Michigan universities. The presidents council of state universities shall submit a progress report to the house and senate higher education appropriations subcommittees by March 1, 1990. The Japan center for Michigan universities, which is located in Hikone, Japan, has the following 4 major program components:

- (a) Japanese language and culture studies for Michigan students.
- (b) English language studies for Japanese citizens.
- (c) Workshops and seminars for Japanese and American businesses and professional persons.
- (d) Research by faculty and students.

Sec. 428. Included in the appropriations in section 101 is funding for the urban teacher education program. The amount appropriated shall be equally divided between eastern Michigan university, Wayne state university, and Wayne county community college for the sole purpose of development and implementation of the urban teacher education program approved by the state board of education. Not less than 75% of the allocation to each institution for the urban teacher education program shall be spent for operation and support of activities and personnel to advise and counsel students and support the field-based teacher education experiences of students.

Sec. 429. Recognizing that each public university has a distinctive role and mission, recognizing that revenue and expenditure patterns should reflect the degree to which each institution is able to maintain the integrity of its role and mission, and recognizing that the findings may promote more systematic planning by the universities and more systematic funding by the legislature, the department of education and the department of management and budget are requested to provide IPEDS and HEIDI information for each institution for each year since 1978. The reports should be sent to the members of the house and senate higher education appropriations subcommittees by December 31, 1989 and should include current funds by category, total revenues by source, and total expenditures in each of the following 10 major program categories:

- (a) Instruction.
- (b) Research.
- (c) Public service.
- (d) Student services.
- (e) Financial aid.
- (f) Institutional support.
- (g) Academic support, including a library, academic administration, and other.
- (h) Plant operation and maintenance.
- (i) Auxiliary enterprises.
- (j) Mandatory transfers.

Sec. 430. (1) The teaching excellence fund appropriated in section 101 is created to recognize outstanding teaching performance by faculty members of state universities.

- (2) An award of \$2,500.00 shall be made to faculty members selected by a process administered by each university which provides for participation by students and members of the faculty. The students and faculty members participating in the selection process shall be representative of all segments of the campus community, including academic discipline, academic level, instructional level, race, and sex. Students shall comprise at least 1/3 of the selection committee. All faculty members in the tenure track of a university shall be eligible for selection for an award.
- (3) The criteria to be used in the selection process are to be limited to the following: superior classroom performance, innovative instructional practice, high educational standards, and concern for students in and out of the classroom.
- (4) By May 1, 1990 each university receiving teaching excellence funds shall report to the legislature and the department of management and budget the following: the names of faculty members receiving teaching excellence fund awards, the basis for each award, and a description of the selection process, including the names, sex, and race of the students and faculty members participating in the selection process; and also the names, sex, and race of the recipients shall be provided in each annual report.
 - (5) Each institution shall receive a number of awards based on the number of full-time faculty as follows:
- (a) 2 awards each: Lake Superior state university, Saginaw valley state university, university of Michigan at Flint, university of Michigan at Dearborn, and Grand valley state university.

- (b) 4 awards each: Michigan technological university, northern Michigan university, and Oakland university.
 - (c) 6 awards each: Ferris state university and central Michigan university.
 - (d) 8 awards each: eastern Michigan university and western Michigan university.
 - (e) 12 awards: Wayne state university.
 - (f) 18 awards: university of Michigan at Ann Arbor.
 - (g) 20 awards: Michigan state university.

The funds awarded under this section shall not supplant current institutional expenditures devoted to the selection and monetary recognition of outstanding teaching performance by faculty members.

- Sec. 431. (1) Included in the appropriation in section 101 for each state university, except Michigan state university, Michigan technological university, the university of Michigan-Ann Arbor, Wayne state university, and western Michigan university, is funding for a student equity plan based on state appropriations per student.
- (2) The following equation shall be utilized to determine the amount each state university eligible under subsection (1) shall receive for providing base support of \$1,485.00 per student for undergraduate instruction:
- [(NUMBER OF FY 1987-88 UNDERGRADUATE FISCAL YEAR EQUATED STUDENTS NUMBER OF FY 1986-87 UNDERGRADUATE FISCAL YEAR EQUATED STUDENTS) X \$1,475.00] + (NUMBER OF FY 1987-88 UNDERGRADUATE FISCAL YEAR EQUATED STUDENTS X \$10.00) = STUDENT EQUITY PLAN AMOUNT FOR UNDERGRADUATE INSTRUCTION FOR FY 1989-90.
- (3) The following equation shall be utilized to determine the amount each state university eligible under subsection (1) shall receive for providing base support of \$1,900.00 per student for graduate I instruction:
- [(NUMBER OF FY 1987-88 GRADUATE I FISCAL YEAR EQUATED STUDENTS NUMBER OF FY 1986-87 GRADUATE I FISCAL YEAR EQUATED STUDENTS) X \$1,800.00] + (NUMBER OF FY 1987-88 GRADUATE I FISCAL YEAR EQUATED STUDENTS X \$100.00) = STUDENT EQUITY PLAN AMOUNT FOR GRADUATE I INSTRUCTION FOR FY 1989-90.
- (4) The following equation shall be utilized to determine the amount each state university eligible under subsection (1) shall receive for providing base support of \$150.00 per student for financial aid:
- (\$150.00 FY 1987-88 STATE APPROPRIATION FOR FINANCIAL AID PER FISCAL YEAR EQUATED STUDENT) X NUMBER OF FY 1987-88 FISCAL YEAR EQUATED STUDENTS = STUDENT EQUITY PLAN AMOUNT FOR FINANCIAL AID FOR FY 1989-90.
- (5) The following equation shall be utilized to determine the amount each state university eligible under subsection (1) shall receive for providing base support of \$425.00 per student for academic support/student services:
- (\$425.00 FY 1987-88 STATE APPROPRIATION FOR ACADEMIC SUPPORT/STUDENT SERVICES PER HEADCOUNT) X NUMBER OF FY 1987-88 FALL HEADCOUNT STUDENTS = STUDENT EQUITY PLAN AMOUNT FOR ACADEMIC SUPPORT/STUDENT SERVICES FOR FY 1989-90.
- Sec. 432. Included in the appropriation in section 101 is a funding allocation for the following graduate intensive universities: Michigan state university, Michigan technological university, university of Michigan-Ann Arbor, Wayne state university, and western Michigan university. The funding allocation is based on the amount of remaining revenue need for each institution, as determined by the 1985 investment needs model.
- Sec. 433. Each state university shall submit an annual report to the department of management and budget and to the chairpersons of the house and senate higher education appropriations subcommittees in a manner prescribed by the department of management and budget describing each energy conservation project financed wholly or in part by oil overcharge revenues appropriated in fiscal year 1987 and fiscal year 1988. The report shall include a description of each energy conservation project and the actual expenditures and energy savings estimates. The information contained in the report shall be utilized to meet the annual reporting requirements to the United States district court and the United States secretary of energy regarding state use of oil overcharge refunds.
- Sec. 434. From the funds appropriated in section 101 for Michigan state university, the legislature encourages that \$150,000.00 be expended for the collegiate employment research institute and that those funds expended be accounted for independently.
- Sec. 435. Included in the appropriation in section 101 for contractual studies is \$75,000.00 to contract for studies proposed by the senate student task force on the accessibility and quality of higher education. The

studies shall include, but are not limited to, research regarding support and service programs for students with special needs and research regarding unmet student financial need. It is expected that the studies will be performed by an external consultant, jointly retained by the senate and house appropriations subcommittees on higher education.

Sec. 436. To enable the legislature to better understand tuition and fee practices at the state universities, each state university is requested to submit a report on its tuition and fees to the members of the house and senate higher education appropriations subcommittees no later than December 31, 1989. The report shall include, but is not limited to, all of the following:

- (a) The amounts of all types of tuition and mandatory fees then being charged to students by the university.
- (b) A detailed description of the tuition and fee structure of the university, including, but not limited to, a description of the tuition and fees charged to, and any exceptions made for, each of the following groups:
 - (i) Residents of other states.
 - (ii) Citizens of other nations.
 - (iii) Foreign nationals residing in this state.
 - (iv) Dependents of nonresident alumni.
 - (v) Dependents of university employees.
 - (vi) Student-employees.
 - (vii) Student-athletes.
- (c) The university's policies or rules concerning tuition and fees, including, but not limited to, its policies or rules concerning the groups listed in subdivision (b).
- (d) Any reciprocal agreements regarding tuition or fees that the university has with another state or nation or in which the university participates. As used in this subdivision, "reciprocal agreement" means that term as defined in Act No. 251 of the Public Acts of 1972, being sections 390.501 to 390.506 of the Michigan Compiled Laws, or a similar agreement entered into by the university.
- Sec. 437. It is the intent of the legislature that funds from the Martin Luther King, Jr.-Cesar Chavez-Rosa Parks program shall not be used for any purpose other than the purposes designated in this act.
- Sec. 438. It is the intent of the legislature to fund the consortium on race relations from the funds appropriated under this act. The consortium is to be comprised of the race relations institute at Wayne state university, and the institute for the study of race and ethnic relations at western Michigan university. The consortium is to be governed by an advisory council consisting of 2 members from Wayne state university, 2 members from western Michigan university, and chairs of the house and senate higher education appropriations subcommittees. The consortium shall conduct research; provide outreach programs; promote racial and ethnic harmony; and encourage participation and commitments from other higher education institutions and communities.
- Sec. 439. The department of management and budget shall commission a study of equity in the funding of higher education institutions. This study shall include, but is not limited to, a review of state appropriations per student, funding levels of similar programs, and general fund institutional student financial aid. The final report shall be transmitted to the chairpersons of the house and senate higher education appropriations subcommittees not later than February 1, 1990.
- Sec. 440. The legislature recommends that the ratio of out-of-state students at any public institution not exceed a ratio of 30% of undergraduate student enrollment and 38% of graduate student enrollment.
