## ENROLLED HOUSE BILL No. 4760

AN ACT to amend sections 204 and 305 of Act No. 86 of the Public Acts of 1980, entitled "An act to regulate the taking and subsequent transport of game animals, game birds, fur-bearing animals, and fish; to provide for the issuing of licenses, permits, and stamps for the taking, catching, hunting, or killing of game animals, game birds, fur-bearing animals, and fish; to provide for the collection, disposition, and use of certain funds; to prescribe the powers and duties of certain state agencies; to provide for certain immunities from civil and criminal liability; to provide penalties for the violation of this act; and to repeal certain acts and parts of acts," section 305 as amended by Act No. 63 of the Public Acts of 1986, being sections 316.204 and 316.305 of the Michigan Compiled Laws.

## The People of the State of Michigan enact:

Section 1. Sections 204 and 305 of Act No. 86 of the Public Acts of 1980, section 305 as amended by Act No. 63 of the Public Acts of 1986, being sections 316.204 and 316.305 of the Michigan Compiled Laws, are amended to read as follows:

- Sec. 204. A person shall not carry a firearm or a bow and arrow while in any area open for wild turkey hunting during the spring wild turkey hunting season, unless the person possesses a valid turkey license issued under section 306.
- Sec. 305. (1) Except as otherwise provided in this act, a person shall not hunt small game without a current small game license. Each small game license shall authorize the person named in the license to hunt for small game except for animals or birds which require a special license. The fee for a resident small game license shall be \$9.50. The fee for a nonresident small game license shall be \$50.00. The resident small game license fee for a minor child shall be 1/2 the amount prescribed in this subsection.
- (2) A nonresident may purchase a limited small game license entitling that person to hunt for a 3-day period all species of small game that are available to hunt under the small game license. The fee for the limited nonresident small game license shall be \$20.00.
  - (3) A small game license shall be void between the hours of sunset and sunrise.
- (4) A nonresident hunter who legally possesses a nonresident hunting license may take from this state as open hand baggage the number of birds and animals which are permitted to be taken and in the person's possession at any 1 time.
- (5) Wild turkey may be taken during the open season for wild turkey with a valid wild turkey hunting license issued under section 306. A small game license issued under this section is not required to take wild turkey.
