ENROLLED SENATE BILL No. 219

AN ACT to make appropriations for the department of agriculture for the fiscal year ending September 30, 1990; to provide for the expenditure of the appropriations; to create funds; to provide for the imposition of fees; to require reports, audits, and plans; to authorize certain transfers by certain state agencies; and to provide for the disposition of fees and other income received by certain state agencies.

The People of the State of Michigan enact:

Sec. 101. There is appropriated for the department of agriculture for the fiscal year ending September 30, 1990, from the following funds:

Sec. 201. (1) In accordance with the provisions of section 30 of article IX of the state constitution of 1963, total state spending in this appropriation act is \$57,599,200.00 and state appropriations to be paid to local units of government in section 101 are as follows:

(2) When it appears to the principal executive officer of each department that state spending to local units of government will be less than the amount that was projected to be expended for any quarter, the principal executive officer shall immediately give notice of the approximate shortfall to the department of management and budget, the senate and house appropriations committees, and the senate and house fiscal agencies.

Sec. 202. The appropriations made and the expenditures authorized under this act and the departments, agencies, commissions, boards, offices, and programs for which an appropriation is made under this act are subject to the management and budget act, Act No. 431 of the Public Acts of 1984, being sections 18.1101 to 18.1594 of the Michigan Compiled Laws.

Sec. 203. As used in this act:

- (a) "Department" means the department of agriculture.
- (b) "Director" means the director of the department.
- (c) "DAG-AMS" means the United States department of agriculture-agriculture marketing service.
- (d) "DAG-APHIS" means the United States department of agriculture-animal plant health inspection service.
 - (e) "DAG-FNS" means the United States department of agriculture-food and nutrition service.
 - (f) "DAG-FS" means the United States department of agriculture-forest service.
 - (g) "DAG-SRS" means the United States department of agriculture-statistical reporting service.
 - (h) "DAG-VS" means the United States department of agriculture-veterinary science.
 - (i) "EPA-OE" means the United States environmental protection agency-office of enforcement.
- (j) "EPA-OWWM" means the United States environmental protection agency-office of water and waste management.
 - (k) "FTE" means full-time equated.
- (l) "HHS-FDA" means the United States department of health and human services-food and drug administration.
 - (m) "IDG" means interdepartmental grant.

- (n) "IDT" means intradepartmental transfer.
- (o) "MEDA" means Michigan export development authority.
- (p) "NASDA" means national association of state departments of agriculture.

Sec. 204. The department may receive and expend funds in addition to those authorized in section 101 for conducting training and orientation workshops and seminars that are consistent with the programmatic mission of the individual unit sponsoring or coordinating the program. Not later than January 2, 1990, the department shall provide the senate and house appropriations subcommittees and the senate and house fiscal agencies with a report indicating the program, number of participants, costs incurred, and income received for the previous fiscal year.

Sec. 205. (1) The unexpended and unobligated balance of any state restricted fund or account remaining at the end of the fiscal year shall revert back to the state restricted fund or account from which appropriated and be available for reappropriation for the next fiscal year. Appropriations which revert to a state restricted fund or account pursuant to this section shall not revert to the general fund of the state.

- (2) A state restricted revenue fund or account which receives revenues in excess of appropriations made from that state restricted revenue fund or account shall not have the excess revenue revert to the general fund of the state.
 - (3) This section does not apply to horse racing revenue.

Sec. 206. Of the funds appropriated in section 101 which are in units other than the grants unit, the department may provide grants to local government agencies, institutions of higher education and nonprofit organizations. The grants shall be used to support research or other related activities for the purpose of enhancing the agricultural industries in this state. A grant allocated by the department pursuant to this section shall not be issued or expended unless approved by the senate and house of representatives appropriations subcommittees responsible for the department's budget.

Sec. 207. (1) The following amounts and FTEs have been added for purposes of creating a new food safety program:

- (2) A product shall not be considered as a premium product unless it is considered safe. If any portion of the food safety program is vetoed, then the amount appropriated for the center for agricultural innovation and development for the Michigan premium program shall not be expended and shall be considered as vetoed.
- (3) Any amount transferred or appropriated for the food safety program for fiscal year ending in 1989 shall be carried forward and expended as a work project.
- (4) Of the grants to local soil conservation districts/food safety appropriated in section 101, the department may make grants to local soil conservation districts for purposes of providing technical assistance and may make grants to Michigan state university—agricultural experiment stations and cooperative extension service for purposes of providing education and research. Not less than 25% of the total grants shall be given to Michigan state university.

Sec. 208. If fees or other revenues are increased pursuant to changes in law for a state restricted fund or account, then the department shall expend those revenues from the state restricted fund or account as increased and as reflected in the governor's budget as introduced, and the state general fund authorizations shall be decreased accordingly.

Sec. 209. Any pamphlet, brochure, or literature which is paid for from any line item appropriated for in this act shall not contain the photograph or likeness of any elected official who is currently serving.

EXECUTIVE

Sec. 301. The appropriations in section 101 may be used for per diem payments to members of boards, committees, and commissions for a full day's board, committee, or commission work at which a quorum is present; for attending a hearing as authorized by the respective board, committee, or commission; or for performing official business as authorized by the respective board, committee, or commission. The per diem payments shall be at a rate as follows:

(a) Commission of agriculture\$	$75.00 \mathrm{~per~day}$
(b) Soil conservation committee\$	35.00 per day
(c) Upper Peninsula state fair board\$	50.00 per day
(d) Agricultural marketing and bargaining board\$	35.00 per day

Sec. 302. If the director is required to lay off any department employees to implement this act, the director shall be exempted from using a strict application of continuous service credits in accordance with guidelines developed by the state personnel director and approved by the civil service commission in order to preserve affirmative action gains made in a program approved by the Michigan equal employment and business opportunity council. This is in accordance with civil service commission rule.

Sec. 303. (1) Of the amount appropriated in section 101 to the center for agricultural innovation and development, \$150,000.00 is for the PICK MICHIGAN-quality promotion program to be used to influence volume buyer and individual consumer choices in purchasing Michigan grown fresh fruits and vegetables as opposed to those grown out of the state. The department shall prepare a program primarily concerned with increasing the potential market share of these commodities by concentrating on enhancing the image of Michigan's product quality and value. The plan to implement this program shall be submitted by the department to the senate and house appropriations committees at least 30 days before the program is scheduled to start.

- (2) From the amount appropriated in section 101 to the center for agricultural innovation and development, \$50,000.00 shall be allocated for the food bank council.
- (3) From the amount appropriated in section 101 to the center for agricultural innovation and development, \$200,00.00 shall be allocated to the farm resources encouraging and supporting health program.

Sec. 304. To qualify for the funds appropriated in section 101 for the commodity promotion matching fund, an organization shall be 1 of the following:

- (a) Organized under the agricultural commodities marketing act, Act No. 232 of the Public Acts of 1965, being sections 290.651 to 290.674 of the Michigan Compiled Laws.
 - (b) Subject to a state commission or council pursuant to statute.
- (c) A recognized, statewide, grower-funded organization for the promotion or market development of a commodity if approved by the commission of agriculture.

Sec. 305. Within the appropriations in section 101 for the center for innovation and development, \$408,100.00 is for the grape and wine industry council, from which the department may provide grants for the purposes as described in section 16b of the Michigan liquor control act, Act No. 8 of the Public Acts of the Extra Session of 1933, being section 436.16b of the Michigan Compiled Laws. Before October 15, 1990, the department shall report the grants made pursuant to this section to the appropriations subcommittees of the senate and house of representatives and to the senate and house fiscal agencies. The report shall include to whom the grants were made, the amounts of the grants, and a brief description of the purpose of the grants.

Sec. 306. The department may charge fees for publications and to use those fees to cover necessary expenses.

Sec. 307. The department shall operate all inspection and regulatory programs at full strength as authorized by this act.

Sec. 308. (1) The department shall establish a system for assessing the goals and accomplishments of the center for innovation and development.

- (2) The department shall report to the senate and house appropriations subcommittees on agriculture and the senate and house fiscal agencies the following relative to any grant made by the center for innovation and development:
 - (a) The criteria used to make the grant.
 - (b) The amount of the grant.
 - (c) The entity or person to whom the grant is made.
 - (d) The names of any entities who requested grants but were rejected.
 - (e) A brief description of the purpose of the grants.
- Sec. 309. From the amount appropriated in section 101 for the center for innovation and development, \$25,000.00 shall be allocated for the Michigan beef expo.
- Sec. 310. The department may combine the administration and financing of the family farm development program and the agricultural marketing and bargaining program.

ADMINISTRATIVE SERVICES

- Sec. 401. The department may collect revenues and fees for audit and licensing functions and may use these fees for necessary expenses.
- Sec. 402. The department may collect fees to conduct livestock sales at the Upper Peninsula state fairgrounds and use the fees for necessary expenses related to the livestock sales.

PESTICIDE AND PLANT PEST MANAGEMENT

- Sec. 501. The department may charge a fee for propagating and certifying virus free foundation stock.
- Sec. 502. A fund is created, to be financed from commercial feed inspection fees. The cost of the commercial feed inspectors shall be financed from the fund created under this section.
- Sec. 503. The department shall develop a strategy with accompanying cost estimates for the purpose of the suppression of the gypsy moth infestation in this state. In the development of this strategy, the department shall form a committee consisting of representatives from the department and the departments of natural resources, public health, and commerce and from Michigan state university. The department shall consult with other states that are or have experienced similar gypsy moth infestations. The department shall report its findings to the house and senate appropriations subcommittees on agriculture and to the department of management and budget by January 1, 1990.
- Sec. 504. Of the funds appropriated in section 101, to the pesticide and plant pest management division, up to \$75,000.00 may be made available to the Michigan cooperative extension service for the purpose of training of applicators. Reimbursement shall be based on actual expenditures and revenue availability.
- Sec. 505. (1) From the amount appropriated in section 101 for the gypsy moth program, \$100,000.00 shall be allocated to Michigan state university for a gypsy moth education program.
- (2) Any unexpended balance which is allocated pursuant to this section shall be carried forward as a work project.

FOOD AND CONSUMER PROTECTION

- Sec. 601. The department may collect fees and fines and may use these funds to administer the gasoline inspection and testing program in accordance with the motor fuels quality act, Act No. 44 of the Public Acts of 1984, being sections 290.641 to 290.650 of the Michigan Compiled Laws.
- Sec. 602. The department may provide bean inspection and grading services and state meat grading services and use the revenues received from these services for necessary expenses.

Sec. 603. The department may use all the inspection fees collected from the inspection of fruits and vegetables at shipping points and processing plants to pay necessary expenses related to the inspections.

LABORATORY SUPPORT

Sec. 701. The amount appropriated in section 101 for equine drug testing includes sufficient funds to test horses entered in draft horse pulling contests at county fairs when local jurisdictions request state assistance.

Sec. 702. The department may make necessary analyses to determine whether or not stimulants or depressants were administered to horses engaged in racing or pulling contests at tracks. A fee shall be charged to reimburse the department for the costs of the tests.

Sec. 703. The department may levy and collect fees for the inspection, testing, and identification of livestock for infectious or contagious diseases for noxious or toxic materials or for equine infectious anemia diagnostic tests.

Sec. 704. The department may conduct analyses of liming samples and charge a fee for the service.

Sec. 705. The department may make regulatory and service tests of feed and fertilizer samples and charge a fee sufficient to cover the costs of these tests.

Sec. 706. The department may test samples for other agencies and organizations and charge a fee for the services. The fees shall be used to cover necessary expenses and shall be interaccounted.

OFFICE OF RACING COMMISSIONER

Sec. 801. The racing commissioner shall require, by rule, that each racetrack in this state implement a signin and sign-out system at each gate to a horse stable area.

Sec. 802. The appropriation in section 101 for the discretionary reward fund in the racing supervision component shall be used by the racing commissioner to pay rewards of not more than \$5,800.00 to a person who provides information which results in the arrest and conviction on a felony charge for a crime which involves the horse racing industry.

Sec. 803. Included in section 101 is an amount not to exceed \$1,000,000.00 for promotion of attendance at pari-mutuel horse racing. The state funds shall be matched before expenditure such that each \$2.00 of state funds is matched by \$1.00 of private industry funds. A race meeting licensee or an association of thoroughbred and harness racetracks or any horsemen's group may submit a plan and proposal to the racing commissioner for use of funds authorized to be expended for promotion of attendance at pari-mutuel horse racing. A plan shall be submitted by the commissioner before the funds may be expended. Each licensee or association of thoroughbred and harness racetracks or horsemen's group shall be eligible for promotional funds. The distribution shall not be made until approved by the chairpersons of the appropriations subcommittees on agriculture of the senate and house appropriations committees. All unexpended funds shall lapse to the state general fund.

Sec. 804. The department shall report by January 1, 1990, to the senate and house appropriations committees the horse racing revenues generated by each breed of horse for which funds are appropriated in this act.

Sec. 805. (1) The appropriations made in section 101 from general fund/special purpose horse racing revenues is intended for full funding compliance with the racing law of 1980, Act No. 327 of the Public Acts of 1980, being sections 431.61 to 431.88 of the Michigan Compiled Laws.

(2) By May 1, 1990, the department, together with the office of the racing commissioner, shall report to the house and senate appropriation subcommittees on agriculture the status of the appropriations made in this act in complying with the funding requirements of the racing law of 1980.

Sec. 806. The office of the racing commissioner shall report to the agriculture appropriations subcommittees of the house of representatives and the senate by November 1, 1989, on what programs, policies, and financial

enhancements should be implemented to bring the Michigan horse racing industry to an equal and competitive standing with other states in the north central region. The office of the racing commissioner shall work collectively with the racing associations and the house and senate agriculture appropriation subcommittee in attaining equal and competitive standing with other states.

WORLD TRADE SERVICES

Sec. 851. Of the funds appropriated in section 101 for international trade, \$175,000.00 and 1 FTE is added to world trade service for the department to expand services for promotion of trade development with the countries in Africa and the Carribbean.

Sec. 852. From the amount appropriated in section 101 to international trade, the department may make a grant of not more than \$20,000.00 to the Partners of the Americas, a nonprofit organization, for promotion of exchange of business leaders in Michigan and the Dominican Republic.

GRANTS

Sec. 901. Of the \$95,000.00 appropriated in section 101 for the Great Lakes draft horse show, \$35,500.00 shall be made available for the Michigan dynamometers association, \$49,500.00 shall be made available for the Michigan draft horse breeders association, and \$10,000.00 shall be used for advertisement and promotion of an annual Great Lakes international draft horse show.

Sec. 902. Included in the appropriation made in section 101 for the thoroughbred program is \$40,000.00 for the Michigan united thoroughbred breeders and owners association to conduct a thoroughbred yearling show. The Michigan united thoroughbred breeders and owners association shall submit to the department an itemized list of expenses showing that the expenses of the yearling show were paid.

Sec. 903. (1) Except as provided in subsection (2), the appropriation of \$400,000.00 in section 101 for purses and supplements-licensed tracks is intended to provide state purse supplements for 4 races at state licensed pari-mutuel horse racing tracks. The purse supplements are to be used for races comprised only of Michigan bred horses segregated into a 4-year-old colt trot division, a 4-year-old filly trot division, a 4-year-old colt pace division, and a 4-year-old filly pace division.

(2) Of the \$400,000.00 appropriated in section 101 for purses and supplements licensed tracks, \$100,000.00 shall be allocated as follows:

(3) The allocations made pursuant to this section shall be considered allocations for work projects and the unexpended balances shall be carried forward and shall not lapse until expended.

Sec. 904. Of the amount appropriated in section 101 for purses and supplements-fairs, a sufficient amount is appropriated to provide for overnight purse supplements at the maximum supplement of \$1,000.00 per overnight race.

Sec. 905. Of the amount appropriated in section 101 for premiums, \$12,000.00 shall be expended as a grant for the Michigan horse show association-fall youth show at the Michigan exposition and fairgrounds.

Sec. 906. A local unit of government which receives money from horse race revenues for having racetracks within their limits shall report the expenditures it incurred by having those racetracks within their limits for the previous calendar year to the senate and house appropriations committees by March 31 of each year.

Sec. 907. The independent audits of local units of government, as required by the uniform budgeting and accounting act, Act No. 2 of the Public Acts of 1968, being sections 141.421 to 141.440a of the Michigan Compiled Laws, shall include an examination to determine the accuracy of reports submitted in compliance with section 1005 of this act. The reports shall be subject, at the authorization of the chairpersons of the senate and house appropriations committees, to the review of the auditor general.

- Sec. 908. (1) The \$80,000.00 appropriated in section 101 for the Fedele Fauri futurity shall only be used by the department to award a grant to an Upper Peninsula county fair based upon competitive bidding.
- (2) The \$80,000.00 appropriated in section 101 for the Michigan futurity shall only be used by the department to award a grant to a Lower Peninsula county fair based upon competitive bidding.
- Sec. 909. Of the \$150,000.00 appropriated in section 101 for water wonderland breeder awards, not more than 2% of the amount appropriated may be used for administrative expenses required to manage the program, the remainder shall be expended for premiums, judges, ribbons and trophies, promotion, and to send state champions to national shows. Large breeds receiving over \$8,000.00 may use up to 20% for a show held separate from county or state fairs.
- Sec. 910. The grant in section 101 to the future farmers of America shall be used only to support authorized activities of the Michigan association of the future farmers of America for regional and state level activities that promote the development of technical agriculture and leadership skills. Final approval for distribution of funds shall be given by the state future farmers of America advisor who shall be designated by the director of the department.
- Sec. 911. A county fair, district fair, 4-H fair, or state fair receiving funds under this act to be used for prizes or awards, in whole or in part, as a condition precedent to the receiving of the funds for those purposes, shall publish the rules relative to the prizes, awards, and deadlines for entries eligible for the funds in their official premium books or lists relative to the prizes or awards. An aggrieved exhibitor may make a written complaint to the department and the department shall investigate the complaint and make a finding of fact regarding the complaint and take appropriate action regarding the complaint.
- Sec. 912. The \$1,202,700.00 appropriated in section 101 for grants to local soil conservation districts shall be used for providing financial assistance to all soil conservation districts in order to permit the districts to engage in programs that conserve soil resources and prevent and control soil erosion. All grants to local soil conservation districts shall be allocated according to a formula approved by the commission of agriculture.
- Sec. 913. An authority which receives money for stadium rental pursuant to this act shall be audited before January 1, 1990, by the legislative auditor general or an independent accounting firm approved by the legislative auditor general. A copy of the audit, which shall include a detailed itemization of all revenues and expenditures in a form approved by the legislative auditor general, shall be submitted to the legislature before January 1, 1990.
- Sec. 914. The department may carry forward unexpended appropriated funds from the thoroughbred and standardbred sire stakes programs pursuant to section 13(9) and (10) of the racing law of 1980, Act No. 327 of the Public Acts of 1980, being section 431.73 of the Michigan Compiled Laws, for the purposes of reimbursement of sire stakes purses for Michigan bred 2- and 3-year-old horse races held in the following fiscal year.
- Sec. 915. (1) From the grant in section 101 for the energy conservation program for agriculture and forestry, the following allocations shall be made:
- (2) The grants allocated pursuant to this section shall be expended for projects which target conservation practices which will result in reducing soil, chemical, and nutrient entry into Michigan's rivers, lakes, streams, and aquifers.
