## **HOUSE BILL No. 4033**

February 1, 1989, Introduced by Rep. Pridnia and referred to the Committee on State Affairs.

A bill to authorize the department of natural resources to convey certain state owned property located in Cheboygan county; to provide conditions for the conveyance; and to provide for disposition of the revenue derived from the conveyance.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- Sec. 1. The department of natural resources, on behalf of 2 the state, may convey to the village of Wolverine, for considera-3 tion of \$1.00, real property described as follows:
- 4 Commencing at the SW corner of SE1/4 of NW1/4, th. N 89° 19'
- 5 30" E along S line of SE1/4 of NW1/4, 387.45 feet (formerly known
- 6 as 200 feet E of river) for point of beginning, N 01° 15'00" W
- 7 212.07 feet to Sturgeon River, SW'ly along river to S line of
- 8 SE1/4 of NW1/4, E to point of beginning, Sec. 6; commencing at NW
- 9 corner of NEI/4 of SWI/4, th. N 89° 19'30" E along N line of
- 10 NE1/4 of SW1/4, 387.45 feet to a point (formerly known as 200

- 1 feet E of river) S 01° 15'00" E 298.35 feet to a point,
- 2 continuing S'ly along the following eight courses (formerly known

- 14 Sec. 6; all that part of SE1/4 of SW1/4 lying SE of river,
- 15 Sec. 6; T33N, R2W, Village of Wolverine; also Lots 1 and 2, Block
- 16 6, Plat of McKillops Addition; Lot 1, Block 7, Plat of Village of
- 17 Torrey, now Village of Wolverine; Lots 1 to 7, inclusive, Block
- 18 K, Plat of Richard's and Holcomb's First Addition; Village of
- 19 Wolverine, Cheboygan County 29.50 acres.
- 20 Sec. 2. The conveyance authorized by this act shall provide
- 21 that the property shall be used only for public park purposes,
- 22 and that the park located on the property shall be open to all
- 23 residents of the state on the same terms, fees, and conditions;
- 24 and that upon termination of that use, or upon use for any other
- 25 purpose, title to the property shall revert immediately to the
- 26 state, with the state assuming no liability for any improvements
- 27 made by the village of Wolverine.

- Sec. 3. The conveyance authorized by this act shall be by
- 2 quitclaim deed approved by the attorney general and shall reserve
- 3 to the state all rights to coal, oil, gas, and other minerals.
- 4 Sec. 4. The revenue derived from the conveyance authorized
- 5 by this act shall be deposited with the state treasurer and cred-
- 6 ited to the general fund.
