## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Section 1. Section 1 of Act No. 4 of the Local Acts of
- 2 1929, is amended to read as follows:
- 3 Sec. 1. It shall be unlawful for any person to hunt for
- 4 game with firearms OR dogs or otherwise, on Sunday, on
- 5 any lands or premises in the county of Sanilac in this state.
- 6 The purpose of this act is to preserve the game in Sanilac
- 7 county. The word "Sunday" as used in this act shall be deemed
- 8 to- mean the first day of the week.
