- 4 SEC. 493F. (1) A PERSON WHO KNOWINGLY RELEASES OR CAUSES
- 5 THE RELEASE OF INFECTIOUS MEDICAL WASTE IN VIOLATION OF THE
- 6 INFECTIOUS MEDICAL WASTE REGULATORY ACT OR RULES PROMULGATED
- 7 UNDER THAT ACT IS GUILTY OF A FELONY PUNISHABLE BY IMPRISONMENT
- 8 FOR NOT MORE THAN 15 YEARS, OR A FINE OF NOT LESS THAN \$10,000.00
- 9 AND NOT MORE THAN \$200,000.00 PER DAY OF VIOLATION, OR BOTH.
