- Section 1. Act No. 300 of the Public Acts of 1949, as

- 4 SEC. 8031. (1) A PERSON WHO WAS A MEMBER OF THE ARMED SERV-
- 5 ICES DURING WORLD WAR II MAY MAKE APPLICATION TO THE SECRETARY OF
- 6 STATE FOR A SPECIAL REGISTRATION PLATE, WHICH SHALL BE INSCRIBED
- 7 WITH SPECIAL IDENTIFICATION NUMBERS PRECEDED BY THE LETTERS
- 8 "WWII" AND SHALL HAVE THE WORDS "WORLD WAR II VETERAN" INSCRIBED
- 9 BENEATH THE REGISTRATION NUMBER.
