- 1 Section 1. Section 320e of Act No. 300 of the Public Acts

- 3 being section 257.320e of the Michigan Compiled Laws, is amended
- 4 and section 319e is added to read as follows:
- 5 SEC. 319E. (1) THE SECRETARY OF STATE SHALL SUSPEND THE
- 6 OPERATOR'S OR CHAUFFEUR'S LICENSE OF A PERSON 16 TO 18 YEARS OF
- 7 AGE, ENROLLED IN A GRADE K TO 12, UPON RECEIPT OF A NOTICE FROM

- 9 Sec. 320e. (1) A person whose operator's or chauffeur's

- 12 license reinstatement fee of \$60.00 to the secretary of state
- 13 before a license is issued or returned to the person. The
- 14 increase in the reinstatement fee from \$25.00 to \$60.00 shall be
- 15 imposed for a license which is issued or returned on or after
- 16 April 5, 1988 regardless of when the license was suspended,
- 17 revoked, or restricted. The fee shall be waived if the license
