THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 4 SEC. 8A. (1) THE DEPARTMENT MAY CONDUCT RESEARCH INTO THE

- 6 LIZED BY CHARTER BOATS.
- 7 (2) THE DEPARTMENT SHALL FORM A CATCH ACTIVITY COMMITTEE
- 8 THAT IS COMPOSED OF 2 INDIVIDUALS FROM THE DEPARTMENT AND 2

- 1 REPRESENTATIVES FROM THE MICHIGAN CHARTER BOAT ASSOCIATION. THE
- 2 CATCH ACTIVITY COMMITTEE SHALL DO ALL OF THE FOLLOWING:
- (A) DEVELOP A FORM THAT PERTAINS TO THE NUMBER, TYPE, AND
- 4 LOCATION OF FISH TAKEN FROM CHARTER BOATS IN THIS STATE.
- 5 (B) PARTICIPATE IN RESEARCH REGARDING INFORMATION CONTAINED

- 10 (4) FOLLOWING THE AVAILABILITY AND DISTRIBUTION OF THE CATCH
- 11 ACTIVITY FORM, THE DEPARTMENT SHALL REQUIRE THE FORM TO BE COM-
- 12 PLETED AND RETURNED TO THE DEPARTMENT PRIOR TO ISSUING A CERTIFI-
- 13 CATE OF INSPECTION. THE FORM THAT IS RETURNED TO THE DEPARTMENT
- 14 SHALL NOT REQUIRE DISCLOSURE OF THE NAME OF THE CHARTER BOAT
- 15 OPERATOR. THE DEPARTMENT SHALL DEVELOP A SYSTEM THAT INSURES
- 16 THAT EACH CHARTER BOAT OPERATOR COMPLETES A CATCH ACTIVITY FORM
- 17 BUT THAT PROTECTS THE CONFIDENTIALITY OF THE IDENTITY OF THE CON-
- 18 TRIBUTING CHARTER BOAT OPERATOR.
- 19 (5) THE DEPARTMENT SHALL UTILIZE THE RETURNED CATCH ACTIVITY
- 20 FORMS TO COMPILE A REPORT BASED ON THE REPORTED CATCH ACTIVITY.
- 21 THE REPORT SHALL BE MADE AVAILABLE TO THE PUBLIC BY THE
- 22 DEPARTMENT. THE REPORT SHALL NOT DISCLOSE THE IDENTITY OF
- 23 CHARTER BOAT OPERATORS WHO DISCLOSED SPECIFIC INFORMATION
- 24 REQUIRED UNDER THIS SECTION.
