THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 5 SEC. 550. (1) EXCEPT AS OTHERWISE PROVIDED IN THIS SECTION,
- 6 EACH VOLUNTEER OF A NONPROFIT CORPORATION SHALL BE IMMUNE FROM
- 7 TORT LIABILITY FOR INJURIES TO PERSONS OR DAMAGES TO PROPERTY
- 8 CAUSED BY THE VOLUNTEER IF ALL OF THE FOLLOWING ARE MET:

- (A) THE VOLUNTEER WAS ACTING OR REASONABLY BELIEVED HE OR

- 9 RECEIVE COMPENSATION OR ANY OTHER THING OF VALUE FOR THE SERV-
- 10 ICES, OTHER THAN REIMBURSEMENT FOR EXPENSES ACTUALLY INCURRED.
