## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Section 1. Act No. 350 of the Public Acts of 1980, as

- 5 SEC. 413D. A CORPORATION SHALL NOT ISSUE A MEDICARE SUPPLE-
- 6 MENTAL CERTIFICATE TO A PERSON WHO IS NOT ELIGIBLE FOR MEDICARE.
- 7 BEFORE OFFERING A MEDICARE SUPPLEMENTAL CERTIFICATE TO A PERSON,
- 8 THE CORPORATION SHALL VERIFY THAT THE COVERED PERSON IS ELIGIBLE
- 9 FOR MEDICARE. HOWEVER, AN APPLICATION FOR MEDICARE SUPPLEMENTAL

- 1 COVERAGE MAY BE TAKEN PRIOR TO DETERMINING ELIGIBILITY FOR
