- (ii) A dependent of an employee of that employer and not a
 member of the family of a sole propriety or partnership.
- 3 (iii) Enrolled in a facility licensed by the -department of
- 4 social services CHILDREN AND FAMILY SERVICES AGENCY pursuant to
- 5 Act No. 116 of the Public Acts of 1973, as amended, being sec-
- 6 tions 722.111 to 722.128 of the Michigan Compiled Laws.
- 7 (b) "Equivalent hour" is determined by taking the total
- 8 number of hours of child care services provided to each eligible
- 9 child -which THAT is paid by the employer, as defined in this
