- 5 Sec. 48. (1) Upon request, the court or the department of
- 6 social CHILDREN AND FAMILY services AGENCY shall make a good
- 7 faith effort to notify the victim before either of the following
- 8 occurs:

- 1 (a) The juvenile is dismissed from court jurisdiction or
- 2 discharged from the department of social CHILDREN AND FAMILY
- 3 services AGENCY jurisdiction.
- 4 (b) The juvenile is transferred from a secure detention or
- 5 treatment facility to a nonsecure residential treatment facility
- 6 located in the county in which the victim resides.
- 7 (2) If the court or department of social CHILDREN AND
- 8 FAMILY services AGENCY is not successful in notifying the victim
- 9 before subsection (1)(a) or (b) occurs, the court or -department
- 10 of social CHILDREN AND FAMILY services AGENCY shall notify the
- 11 victim as soon as possible after the occurrence of

- (3) Upon the victim's request, the department of social
- 14 CHILDREN AND FAMILY services AGENCY or the court shall give to
- 15 the victim notice of a juvenile's escape from a secure detention
- 16 or treatment facility. A victim who requests notice of an escape
- 17 shall be given immediate notice of the escape by any means rea-
