- 5 Sec. 22. (1) The administrator may deny, suspend, or revoke
- 6 a registration, certificate, or mechanic trainee permit after
- 7 notice and opportunity for a hearing if the administrator

- 7 (e) Refused to honor warranties made by a facility.

- (g) Was enjoined by a court of competent jurisdiction from the engaging in the trade or business of repairing motor vehicles or the from a violation of this act or a rule promulgated under this act.

- 18 MOTOR VEHICLE REPAIR FACILITY OR IS CERTIFIED AS A SPECIALTY OR
- 19 MASTER MECHANIC, UPON RECEIPT OF THE APPROPRIATE ABSTRACTS OF
- 20 CONVICTION FROM THE COURT, THE ADMINISTRATOR SHALL REVOKE THE
- 21 REGISTRATION OF THE FACILITY OR THE PERSON'S MECHANIC'S
- 22 CERTIFICATE.
- 23 (B) THE ADMINISTRATOR SHALL NOT ISSUE A MOTOR VEHICLE REPAIR
- 24 FACILITY REGISTRATION TO A FACILITY OWNED IN WHOLE OR IN PART BY
- 25 THE PERSON CONVICTED OR A MECHANIC'S CERTIFICATE TO THE PERSON
- 26 FOR A PERIOD OF NOT LESS THAN 5 YEARS AFTER THE DATE OF THE LAST
- 27 CONVICTION.

- 1 (3) THE ADMINISTRATOR SHALL DENY A MOTOR VEHICLE REPAIR
- 2 FACILITY REGISTRATION TO A PERSON, OR TO A FACILITY OWNED IN
- 3 WHOLE OR IN PART BY THE PERSON, IF 1 OR MORE OF THE FOLLOWING
- 4 APPLY:
- 5 (A) THE PERSON HAS 3 OR MORE CONVICTIONS UNDER SECTION 413
- 6 OF ACT NO. 328 OF THE PUBLIC ACTS OF 1931.
- 7 (B) THE PERSON HAS 3 OR MORE CONVICTIONS UNDER SECTION 535A
- 8 OF ACT NO. 328 OF THE PUBLIC ACTS OF 1931.
- 9 (C) THE PERSON HAS 3 OR MORE CONVICTIONS UNDER SECTION 535C 10 OF ACT NO. 328 OF THE PUBLIC ACTS OF 1931.
