

# HOUSE BILL No. 4314

February 28, 1989, Introduced by Reps. Fitzgerald, Camp, Runco, Bandstra, Bender, Emmons, Munsell, Randall, Giese, Crandall, London, Jaye, Willis Bullard, Middaugh, Sparks, DeLange, Strand, Dunaskiss, Palamara, Miller, Martin, Law, Bankes, Oxender, Wallace, Honigman, Dolan, Krause, Gubow and Hillegonds and referred to the Committee on Senior Citizens and Retirement.

A bill to amend Act No. 180 of the Public Acts of 1981, entitled as amended  
"Older Michiganians act,"  
as amended, being sections 400.581 to 400.594 of the Michigan Compiled Laws, by adding section 64.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 Section 1. Act No. 180 of the Public Acts of 1981, as  
2 amended, being sections 400.581 to 400.594 of the Michigan  
3 Compiled Laws, is amended by adding section 64 to read as  
4 follows:

5 SEC. 64. (1) IN COOPERATION WITH THE DEPARTMENT OF MENTAL  
6 HEALTH, THE OFFICE SHALL STUDY THE EMERGING LONG-TERM HEALTH CARE  
7 NEEDS OF INDIVIDUALS OVER 50 YEARS OF AGE WHO HAVE A  
8 DEVELOPMENTAL DISABILITY, AND SHALL PREPARE A REPORT ON THE STUDY

1 THAT RECOMMENDS A PLAN FOR PROVIDING INFORMATION ABOUT, AND  
2 PROVIDING ACCESS TO, APPROPRIATE HEALTH CARE SERVICES.

3 (2) THE REPORT SHALL BE COMPLETED AND A COPY PROVIDED TO THE  
4 LEGISLATURE NOT LATER THAN 1 YEAR AFTER THE EFFECTIVE DATE OF  
5 THIS SECTION.

6 (3) AS USED IN THIS SECTION, "DEVELOPMENTAL DISABILITY"  
7 MEANS THAT TERM AS DEFINED IN SECTION 600 OF THE MENTAL HEALTH  
8 CODE, ACT NO. 258 OF THE PUBLIC ACTS OF 1974, BEING SECTION  
9 330.1600 OF THE MICHIGAN COMPILED LAWS.

10 Section 2. This amendatory act shall not take effect unless  
11 Senate Bill No. \_\_\_\_\_ or House Bill No. 4315 (request  
12 no. 00883'89) of the 85th Legislature is enacted into law.
