## **HOUSE BILL No. 4335**

## EXECUTIVE BUDGET BILL

March 2, 1989, Introduced by Rep. Jacobetti and referred to the Committee on Appropriations.

A bill to make appropriations for the department of mental health and certain state purposes related to mental hygiene for the fiscal year ending September 30, 1990; to provide for the expenditure of such appropriations; to create funds; to provide for reports; to prescribe the powers and duties of certain state agencies and departments; and to provide for disposition of fees and other income received by the various state agencies.

- 9 the community mental health board may enter into a contract with the
- 10 department which provides that clients of the community mental health board in
- 11 a state facility shall continue to be served by the department, which shall
- 12 retain full allocation authority on behalf of the community mental health
- 13 board for state facility services.
- 14 (3) Within the provisions of this section, the department may enter into a
- 15 formal contract with a community mental health board for shared management of
- 16 the provision of state facility services to a client who is a resident of the
- 17 county served by the community mental health board.
- 18 (4) Current billing and collection procedures for the net cost of state
- 19 provided services shall continue as specified in chapter 3 of the mental
- 20 health code, Act No. 258 of the Public Acts of 1974, being sections 330.1300
- 21 to 330.1320 of the Michigan Compiled Laws.
- 22 (5) With the exception of funds allocated to community mental health
- 23 boards, the department shall have administrative authority to transfer funds
- 24 from the appropriation authorized in section 101 to satisfy but not exceed
- 25 state facility deduct amounts.
- 26 (6) The department may access funds from this appropriation directly for

- 1 patients who have no county affiliation or for whom county charges are
- 2 exempted.
- 3 (7) The shift of funds to the counties shall not result in increased costs
- 4 to counties in excess of the local match required under section 302 of the
- 5 mental health code, Act No. 258 of the Public Acts of 1974, being section
- 6 330.1302 of the Michigan Compiled Laws.
- 7 Sec. 506. Funds appropriated in section 101 for federal block grants shall
- 8 provide continuation funding for community mental health board programs and do
- 9 not assume any reductions in federal funding. If reductions in the department
- 10 of mental health allotment of federal ADAMHA block grant funds occur, it is
- 11 the intent of the legislature that the amount of the reduction be implemented
- 12 through a pro rata reduction applied to all community mental health board
- 13 contracts and departmental operations in the amount of the block grant
- 14 reduction.
- 15 Sec. 507. Subject to guidelines issued by the department, funds
- 16 appropriated in section 101 for community mental health operations for
- 17 developmentally disabled family support services may be used for family friend
- 18 respite care services in which the community mental health board provides
- 19 respite care funds directly to the family for their purchase of respite care
- 20 services from individuals other than family members.
- 21 Sec. 508. The department of mental health shall develop a coordinated
- 22 approach to recruitment of qualified mental health professionals to serve
- 23 within the county community mental health system. Objectives of the project
- 24 shall include all of the following:
- 25 (a) Provision of information to state colleges and universities on public
- 26 mental health services for inclusion in curriculum development, development of

- 1 field placement and practicum experiences, and recruitment of new graduates
- 2 into the CMH system.
- 3 (b) Development of a centralized listing of professional staff vacancies
- 4 which exist within the system and a coordinated approach to recruit
- 5 professional staff to fill those vacancies.
- 6 Sec. 509. The department shall establish a process for the design and
- 7 implementation of mechanisms and arrangements to assure the long-term
- 8 viability of a single entry and single exit locally controlled comprehensive
- 9 CMH system. The department shall ensure the involvement of representatives
- 10 from the CMH system, the legislature, and the executive department in this
- 11 process. The department, in collaboration with representatives of the CMH
- 12 system, shall purpose to the legislature and the governor changes in the law,
- 13 administrative rules, accounting and budgeting mechanisms, and appropriations
- 14 which appear to be necessary and desirable in achieving the goal of a stable,
- 15 viable, and comprehensive CMH system vested with authority and responsibility
- 16 for managing and providing a full array of public mental health services.
- 17 Sec. 510. CMH boards may, consistent with generally accepted accounting
- 18 principles, establish accounts payable to finance known costs such as
- 19 anticipated court judgments and settlements, audit exceptions, and other
- 20 1-time costs.
- 21 Sec. 511. (1) The department shall prepare a report of the per capita
- 22 expenditures of each CMH board for services to both of the following groups:
- 23 (a) Mentally ill adults and children.
- (b) Developmentally disabled adults and children.
- 25 (2) The report shall review such expenditures for the 1985, 1986, and 1987
- 26 fiscal years, and include recommendations for equalizing the distribution of

- 1 funds appropriated to CMH boards for CMH services.
- 2 (3) The report shall be provided to the department of management and
- 3 budget, and to the house and senate subcommittees on mental health prior to
- 4 April 1, 1990.
- 5 Sec. 512. Funds appropriated in section 101 for community mental health
- 6 programs may be used to provide technical assistance, training and support
- 7 aimed at development of a comprehensive range of community-based services for
- 8 the seriously mentally ill. These funds shall promote availability of and
- 9 access to a comprehensive range of alternative services provided in integrated
- 10 community settings which enable the client to function in those settings as
- 11 independently as possible. The range of alternative community services would
- 12 be available based on the changing needs and treatment goals of the client and
- 13 would include services such as assertive community treatment programs,
- 14 supported independence programs, crisis housing services and work
- 15 opportunities for persons with serious mental illness. The program should:
- 16 (1) Identify the elements of a continuum of community-based services for
- 17 the seriously mentally ill which are alternatives to state psychiatric
- 18 hospital programs and assess the presence of these elements across the state,
- 19 and promote model alternative community treatment systems.
- 20 (2) Reduce length of stay at state psychiatric hospitals through increased
- 21 use of alternative and combined orders and expansion of private psychiatric
- 22 hospital contracts. The program shall train community mental health state
- 23 facility liaison staff in the full use of combined and alternative treatment
- 24 orders and in developing successful and functional liaison arrangement with
- 25 courts, state facilities, and local law enforcement entities.
- 26 (3) Provide technical assistance to county community mental health boards

- 1 in expanding community-based services for the seriously mentally ill through
- 2 redirected funding and exploration of alternative sources of revenue.
- 3 (4) Promote networking among community mental health boards to enhance
- 4 service delivery, provide information and training to community mental health
- 5 staff on services to the seriously mentally ill, develop an organized means of
- 6 sharing of information among service providers regarding model programs, and
- 7 improve community understanding of mental illness and availability of
- 8 appropriate services. The department shall report by March 31, 1990 to the
- 9 house and senate appropriations committees and to the department of management
- 10 and budget on progress in implementing this section.
- 11 COMMUNITY RESIDENTIAL SERVICES
- 12 Sec. 601. Funds appropriated in section 101 for residential services
- 13 support staff may be used to provide resource assistance for community
- 14 placement and home development activities, through allocation to or by
- 15 contract with county community mental health boards, or through state
- 16 facilities, or other placement entities established by the department.
- 17 Sec. 602. The funds appropriated in section 101 for community residential
- 18 services programs may be used for basic care in cases where individuals are
- 19 not eligible to receive social security benefits and are not otherwise capable
- 20 of supporting themselves out of their own resources. Funds may be used for
- 21 purposes of aftercare or to prevent admissions to state facilities through
- 22 residential and support services. Expenditures and allocations may be
- 23 authorized for community mental health board or state facilities, or both.
- Sec. 603. (1) The department shall establish community advisory committees
- 25 for alternatives to institutional care and for community living facilities
- 26 funded under section 101.

- 1 (2) Not less than 60 days prior to the planning and locating of a
- 2 specialized residential service as defined in section 300 of the mental health
- 3 code, Act No. 258 of the Public Acts of 1974, being section 330.1300 of the
- 4 Michigan Compiled Laws, including a residential home in a city, village, or
- 5 township, the department shall seek the advice and consultation of the
- 6 governing body of the city, village, or township in which the specialized
- 7 residential service is proposed to be located.
- 8 (3) The department shall develop uniform standards and policies regarding
- 9 the financing and procurement of furnishings and equipment for residential
- 10 programs. Any furnishings and equipment purchased with state funds shall be
- 11 inventoried as state property. If the full amount of the funds advanced for
- 12 purchase of the furnishings and equipment are not used for that purpose, the
- 13 excess funds shall be returned to the department.
- 14 (4) Funds appropriated in section 101 shall be used to maintain an office
- 15 of community residential services to coordinate, monitor and provide
- 16 management oversight for home development and residential services activities
- 17 conducted by the department and by community mental health boards. This
- 18 office shall oversee the development and implementation of policies and
- 19 procedures to be used by the department and community mental health boards as
- 20 part of the process of development of community based specialized residential
- 21 facilities.
- 22 (5) Funds appropriated in section 101 for residential services shall not be
- 23 used for a new placement unless the department has obtained, before the
- 24 placement, a written plan for residential placement and after-care services
- 25 which is sufficient to meet the needs of the individual. The development of a
- 26 plan shall involve the department of social services, appropriate state mental

- 1 health institutional staff, and appropriate community mental health boards'
- 2 staff in prerelease planning and approval of the plan.
- 3 (6) Placement of a developmentally disabled person from a state center for
- 4 the developmentally disabled shall not occur unless the care to be received in
- 5 the community setting will be at least as good as the care being received in
- 6 the institution. The need of an individual for close supervision for medical
- 7 reasons and for readily available medical backup 24 hours per day shall be
- 8 considered in determining the quality of care. In the case of an individual
- 9 with close family relationships, the placement shall not diminish family
- 10 access to the individual.
- 11 (7) Funds appropriated in section 101 for the executive program shall be
- 12 used for the development of a centralized system for monitoring the release
- 13 and the placement of patients and residents from state institutions into
- 14 community or other institutional settings, including returns to the patients'
- 15 or residents' homes, and monitoring the provision of all aftercare and
- 16 follow-up services by an agency providing those services in accordance with
- 17 standards of the department for a period of not less than 1 year.
- 18 (8) The funds appropriated in section 101 for residential services programs
- 19 may be used to maintain and improve residential and support services,
- 20 aftercare programs, and residential and support services designed to prevent
- 21 admissions to state facilities. Expenditures and allocations may be
- 22 authorized for CMH boards, state facilities, or both, for the purposes
- 23 described in this section.
- 24 Sec. 604. Funds appropriated in section 101 for private nursing homes and
- 25 alternative services program may be used to finance case management services,
- 26 ancillary medical services, equipment not covered by medicaid, vacant bed

- 1 penalty payments, conversion costs, and departmental administrative staff not
- 2 to exceed 10 FTE positions.
- 3 Sec. 605. The department shall not enter into new contracts with private
- 4 attorneys for legal services for the purposes of gaining and maintaining
- 5 occupancy to a specialized residential facility. The department may enter
- 6 into a contract with the protection and advocacy service, authorized under
- 7 section 927 of the mental health code, Act No. 258 of the Public Acts of 1974,
- 8 being section 330.1927 of the Michigan Compiled Laws, or a similar
- 9 organization to provide legal services for purposes of gaining and maintaining
- 10 occupancy in a specialized residential facility which is under lease or
- 11 contract with the department or a community mental health board to provide
- 12 services to developmentally disabled persons or mental health recipients.
- 13 State funds shall not be used for legal services to represent private
- 14 investors purchasing homes for these purposes.
- 15 Sec. 606. Funds appropriated in section 101 for residential services may
- 16 be used to make payments to the state housing development authority for
- 17 in-home support services assumed by the state housing development authority
- 18 through agreement with the department.
- 19 Sec. 607. (1) The department shall maintain in cooperation with the
- 20 department of social services and the department of public health a mechanism
- 21 to refer all persons less than 18 years of age who meet the criteria in
- 22 section 500(h) of the mental health code, Act No. 258 of the Public Acts of
- 23 1974, being section 330.1500 of the Michigan Compiled Laws, and who are
- 24 residing in or have been referred for admission to skilled, basic, or
- 25 pediatric nursing homes.
- 26 (2) Upon determination of appropriateness for services, the department

- 1 shall provide client services management and develop alternative residential
- 2 services as appropriate. Funds allocated in section 101 for residential
- 3 services and residential services support may be utilized for this purpose.
- 4 Sec. 608. The department of mental health shall pay the same rate for all
- 5 department contracted child caring institutions and child placing agencies as
- 6 established by the department of social services, office of children and youth
- 7 services. If community residential services funding is insufficient for this
- 8 purpose, then the department of management and budget in conjunction with the
- 9 department of mental health shall report this information to the senate and
- 10 house appropriations subcommittees on mental health along with recommendations
- 11 for complying with this section.
- 12 INSTITUTIONAL SERVICES AND FACILITIES
- 13 Sec. 701. The shift of funds to any county for inpatient care and
- 14 alternative programs pursuant to section 116 of the mental health code, Act
- 15 No. 258 of the Public Acts of 1974, being section 330.1116 of the Michigan
- 16 Compiled Laws, shall not alter the relationship existing on the effective date
- 17 of this act between Hawthorn center and services provided to residents of this
- 18 state. The director of the department shall notify the legislature of any
- 19 violations of this section.
- 20 Sec. 702. (1) The department may charge rent to state or other tenants
- 21 occupying space in any of its facilities. The rental rates and all leasing
- 22 arrangements shall be subject to the approval of the department of management
- 23 and budget and the state administrative board. Revenues received under this
- 24 section shall be available for expenditure by the department for maintenance,
- 25 renovation, administrative expense associated with the leased space and for
- 26 other departmental expenditures. Unexpended and unencumbered amounts

- 1 remaining on September 30, 1990 from the amounts appropriated in section 101
- 2 for the lease/rental program shall carry forward for 1 fiscal year after which
- 3 time they shall lapse.
- (2) In order to assist with the implementation of Act No. 117 of the Public
- 5 Acts of 1986 and to assure that county community mental health boards are able
- 6 to provide the proper liaison and client services management assistance to
- 7 county residents of state facilities, the department shall ensure that
- 8 adequate office space is made available on the grounds of state facilities at
- 9 no cost to counties whose residents are cared for at those facilities.
- 10 Sec. 703. Funds appropriated in section 101 for facilities for the
- 11 mentally ill and developmentally disabled are intended to maintain direct care
- 12 staffing levels phased toward staffing needs assessment project standards, for
- 13 facilities for mentally ill adults, developmentally disabled persons, and
- 14 mentally ill children.
- 15 Sec. 704. The operation of the power plant at the Kalamazoo state hospital
- 16 shall be financed from charges to the appropriations to the Kalamazoo state
- 17 hospital and western Michigan university, which charges shall be based upon
- 18 the cost of the power plant and upon the usage of heat and electrical power by
- 19 the hospital and the university.
- 20 Sec. 705. Funds appropriated in section 101 for state facility operating
- 21 maintenance projects which have been approved by the department of management
- 22 and budget shall carry forward for 1 fiscal year to enable completion.
- 23 Sec. 706. Transfer of the Wayne community living services agency to the
- 24 Detroit-Wayne community mental health board is contingent upon the following:
- 25 (a) Completion of a transition, service, and funding plan by the
- 26 Detroit-Wayne community mental health board which addresses all aspects of the

- 1 services, administration, and staffing, and submission of the plan to the
- 2 department.
- 3 (b) Approval of the plan by the department.
- 4 (c) Legislative appropriation of funds sufficient for state assumption of
- 5 the additional state costs of the specialized residential services as a result
- 6 of the transfer of Wayne community living services to the Detroit-Wayne
- 7 community mental health board pursuant to section 309 of the mental health
- 8 code, Act No. 258 of the Public Acts of 1974, being section 330.1309 of the
- 9 Michigan Compiled Laws.
- 10 (d) It is the intent of the legislature that this transfer take effect when
- 11 all program, employee and fiscal issues have been resolved.
- 12 Sec. 707. In addition to the amounts appropriated in section 101, revenues
- 13 from the sale of sheltered workshop services and products are appropriated to
- 14 be expended for supplies, equipment, and other costs associated with the
- 15 maintenance of the sheltered workshop program, excluding costs of compensating
- 16 state classified employees. The unspent balance on the last day of the fiscal
- 17 year ending September 30, 1990 shall be carried forward into the subsequent
- 18 fiscal year.
- 19 Sec. 708. Funds appropriated in section 101 for gifts and bequests include
- 20 patient trust fund revenues and pay telephone revenues to be allocated for
- 21 patient living unit furnishings, recreational and vocational materials and
- 22 supplies.

- 24 Sec. 801. (1) The worker's compensation appropriation to the department of
- 25 mental health for the fiscal year ending September 30, 1990 is based on the
