

# HOUSE BILL No. 4342

## EXECUTIVE BUDGET BILL

March 2, 1989, Introduced by Rep. Jacobetti and referred to the Committee on Appropriations.

A bill to make appropriations for the department of state police, and certain other state purposes for the fiscal year ending September 30, 1990; to provide for the expenditure of those appropriations; to provide for certain reports and the consideration of such reports; to provide for the disposition of other income received by the various state agencies; to provide testing of certain persons; to provide for certain emergency powers; and to provide for the powers and duties of certain committees, certain state agencies, and certain employees.

### THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

Sec. 101. There is appropriated for the department of state police, for the fiscal year ending September 30, 1990, from the funds identified as follows:

2       (2) When it appears to the principal executive officer of each department  
3 that state spending to local units of government will be less than the amount  
4 that was projected to be expended for any quarter, the principal executive  
5 officer shall immediately give notice of the approximate shortfall to the  
6 department of management and budget, the senate and house appropriations  
7 committees, and the senate and house fiscal agencies.

8       Sec. 202. The appropriations made and the expenditures authorized under  
9 this act and the departments, agencies, commissions, boards, offices, and  
10 programs for which an appropriation is made under this act are subject to the  
11 management and budget act, Act No. 431 of the Public Acts of 1984, as amended,  
12 being sections 18.1101 to 18.1594 of the Michigan Compiled Laws.

13       Sec. 203. As used in this act:

14       (a) "AFIS" means automated fingerprint identification system.

15       (b) "AIS/ICF/MR" means alternate intermediate services, intermediate  
16 care facilities, mentally retarded.

17       (c) "CARE" means combined accident reduction effort.

18       (d) "CCD" or "consolidated central dispatch" means an entity consisting  
19 of 75% or more of the law enforcement, fire fighting, and emergency service  
20 agencies, or those agencies encompassing 75% or more of the population of the  
21 service area, joined under a written agreement to operate under a single  
22 dispatching operation. The 75% requirements for a CCD may be waived in  
23 counties of over 250,000 where other configurations promise effective and  
24 efficient services. A CCD must also include all of the following:

25       (i) The participation of the county sheriff and the state police.

26       (ii) The control of central dispatching by a countywide or regional



1 authority consisting of representatives of participating jurisdictions and  
2 agencies and the general public, that selects supervisory staff and oversees  
3 operations.

4 (iii) One or 2 dispatching points operated by the authority as is  
5 determined to be necessary given the size of the county.

6 (iv) Dispatch services 24 hours a day, 7 days a week, year-round to all  
7 participating jurisdictions and agencies.

8 (v) A written agreement including an annual budget by the participants  
9 that specifies the nature and amount of service and identifies sources of  
10 financing, including the provision of personnel, equipment, supplies, and  
11 funds from participants or dedicated sources.

12 (vi) An operational policy based on the concept of the dispatch of the  
13 closest unit, of the appropriate type, to the service request.

14 (vii) Operation using 9-1-1, or enhanced 9-1-1, under the emergency  
15 telephone service enabling act, Act No. 32 of the Public Acts of 1986, being  
16 sections 484.1101 to 484.1707 of the Michigan Compiled Laws, where feasible  
17 and cost-effective.

18 (e) "CCH" means computerized criminal history.

19 (f) "Department" means the department of state police.

20 (g) "DMB" means the Michigan department of management and budget.

21 (h) "DOD" means United States department of defense.

22 (i) "DOJ" means the United States department of justice.

23 (j) "DOJ-BJS" means the United States department of justice, Bureau of  
24 justice statistics.

25 (k) "DOT" means the United States department of transportation.

26 (l) "DOT-NHTSA" means DOT-national highway traffic safety administration.

- 1 (m) "FTE" means full-time equated.
- 2 (n) "IDG" means interdepartmental grant.
- 3 (o) "IDT" means intradepartmental transfer.
- 4 (p) "LEIN" means law enforcement information network.
- 5 (q) "MDOT" means Michigan department of transportation.
- 6 (r) "MLEOTC" means the Michigan law enforcement officer training council.
- 7 (s) "OHSP" means office of highway safety planning.
- 8 (t) "Title XVIII" means title XVIII of the Social Security Act of 1935
- 9 as amended.

10 Sec. 204. The appropriations provided in section 101 for salaries and  
 11 wages, longevity and insurance, retirement, and pension, and for project  
 12 accounts are approved for expenditure for automated information processing  
 13 which is relevant to the objectives of the given appropriation unit or project  
 14 account. Such expenditure shall not be applied to the \$20,000.00 limitation  
 15 provided in section 203(2) of the management and budget act, Act No. 431 of  
 16 the Public Acts of 1984, being section 18.1203 of the Michigan Compiled Laws.

17 Sec. 205. The amounts appropriated for utilities and that portion of  
 18 contractual services, supplies, and materials used to pay for utility service  
 19 to state facilities in section 101 may be expended in a manner consistent with  
 20 the provisions of section 253 of the management and budget act, Act No. 431 of  
 21 the Public Acts of 1984, as amended, being section 18.1253 of the Michigan  
 22 Compiled Laws.

### 23 DEPARTMENTWIDE APPROPRIATIONS

24 Sec. 301. Expenditures of federal, local, or private allotments from the  
 25 amounts appropriated in section 101 for federal, local, and private assistance  
 26 for state police services shall not be made until after review by DMB and the

1 approval of the state police subcommittees of the senate and house  
2 appropriations committees. If a request for approval is not acted upon within  
3 45 days after the date of submission to the state police subcommittees of the  
4 senate and house appropriations committees, the request shall be considered  
5 approved.

6       Sec. 302. (1) The \$5,602,100.00 and 110.0 full-time equated positions  
7 appropriated in section 101 for general police services are intended to be  
8 used for enhanced crime prevention, crime detection, criminal investigations,  
9 and traffic enforcement in Wayne county, Oakland county, Macomb county,  
10 Genesee county, Ingham county, and Kent county. The director of the department  
11 may allocate these positions to the uniform services division, investigative  
12 services division, or forensic sciences division.

13       (2) Any increase in the staff of the department pursuant to this section  
14 shall not be used by county or other local units of government to reduce their  
15 general financial commitment to law enforcement efforts.

16       Sec. 303. The department shall submit a semiannual report on November 1,  
17 1989 and April 1, 1990 on the allocations and expenditures of the \$500,000.00  
18 appropriated in section 101 to departmentwide appropriations for narcotic  
19 investigation funds.

20       Sec. 304. (1) Pursuant to the provisions of civil service rules and  
21 regulations and applicable collective bargaining agreements, individuals  
22 seeking employment with the department shall submit to a controlled substance  
23 test. The test shall be administered by the department.

24       (2) Individuals seeking employment with the department who refuse to take  
25 a controlled substance test or who test positive for the illicit use of a  
26 controlled substance on such a test shall be denied employment by the

1 department for a minimum of 2 years.

2 (3) Funds shall not be expended by the MLEOTC for training law  
3 enforcement officer candidates, nor shall a candidate be certified by the  
4 MLEOTC, unless he or she tests negative on a test designed to detect the  
5 illicit use of a controlled substance. The test shall be conducted prior to  
6 basic training or application for certification. A candidate who tests  
7 positive or refuses to submit to the testing shall not be eligible for MLEOTC  
8 certification for a minimum of 2 years.

9 (4) From the funds available in section 101, sufficient money is provided  
10 to maintain the substance abuse data base as provided for in the MLEOTC  
11 substance abuse testing program.

12 (5) The fire fighters training council shall consider requiring all new  
13 fire fighter candidates to submit to controlled substance testing procedures  
14 developed by the fire fighters training council and administered at the local  
15 level. At the discretion of the fire fighters training council, candidates  
16 may be required to pay the cost of a controlled substance test required by the  
17 fire fighters training council. Candidates who refuse to submit to a  
18 controlled substance test as may be required by the fire fighters training  
19 council, or who test positive for the illicit use of a controlled substance on  
20 such a test, shall not be eligible for certification as a fire fighter for a  
21 minimum of 2 years.

## 22 HIGHWAY SAFETY PLANNING

23 Sec. 401. (1) The amounts appropriated in section 101 for highway safety  
24 planning programs shall be treated as work project accounts and shall not  
25 revert to the general fund of the state at the conclusion of the fiscal year  
26 ending September 30, 1990, but shall continue to be available for expenditure

1 until the projects for which they were appropriated are completed or otherwise  
2 terminated. At the conclusion of the fiscal year ending September 30, 1990,  
3 the unencumbered balance for each completed or terminated project shall revert  
4 to the general fund and unearned federal funds received for the completed or  
5 terminated project shall be returned.

6 (2) A principal executive officer of a department having an appropriation  
7 for highway safety planning funds shall notify the state budget director as to  
8 the September 30, 1990, status of each project for which appropriations are  
9 made. This notification shall be made by the following November 1, 1990, and  
10 shall be in sufficient detail so that the state budget director can cause the  
11 unencumbered balance of the completed or terminated projects to be reverted to  
12 the general fund of the state.

13 CENTRAL RECORDS

14 Sec. 501. (1) The funds appropriated in section 101 for the automated  
15 fingerprint identification system shall be considered a work project account  
16 that shall not lapse at the end of the fiscal year.

17 (2) In addition to appropriations contained in section 101, the  
18 department may receive and expend funds from local units of government for the  
19 purpose of acquiring equipment for the automated fingerprint identification  
20 system.

21 Sec. 502. (1) The appropriations in section 101 include funds for the  
22 purchase of AFIS equipment.

23 (2) Funds expended by the department for the purchase of AFIS equipment  
24 for local consortiums shall be on a per capita basis.

25 (3) State funds shall not be used in the operations or maintenance of  
26 AFIS equipment for local consortiums.

1       Sec. 503. From the \$1,783,300.00 appropriated in section 101 for AFIS,  
2 an amount not to exceed \$415,000.00 may be used for the state share of local  
3 AFIS equipment. The total state share for this purpose shall not exceed  
4 \$1,660,000.00 over the 4-year lease-purchase period. The per capita rate to  
5 be established by the AFIS policy council shall not exceed a 4-year total of  
6 \$41,000.00 per 100,000 population. State funds shall be limited to the  
7 purchase of AFIS terminals that are on a 4-year lease-purchase basis. The  
8 state share shall not exceed 75%.

9 CRIMINAL JUSTICE DATA CENTER

10       Sec. 601. In addition to the appropriations contained in section 101,  
11 the department may receive funds from local units of government for the  
12 purpose of expanding or upgrading the law enforcement information network, if  
13 the funds do not require state money either for matching purposes or for  
14 continuing programs if the funds from local units of government become  
15 unavailable.

16       Sec. 602. The \$1,854,000.00 appropriated in section 101 for a new  
17 computer shall be used for the lease/purchase and contract maintenance of a  
18 new mainframe computer which shall be funded by LEIN user fees sufficient to  
19 pay 1/3 of the purchase, installation, and contract maintenance costs.

20       Sec. 603. (1) The state budget director is authorized to make  
21 administrative transfers of the unexpended general fund-general purpose  
22 amounts available from amounts appropriated in section 101 to a special work  
23 project account for office automation in the department.

24       (2) The department shall certify to DMB by November 8, 1990 projected  
25 unexpended account balances available for transfer under the authority of  
26 subsection (1).

1 (3) DMB shall report to the house and senate appropriations committees  
2 the listing of all administrative transfers made under the authority of  
3 subsection (1).

4 EMERGENCY SERVICES

5 Sec. 701. (1) The state director of emergency services may call upon all  
6 agencies or departments of the state and all resources of the state for the  
7 purpose of protecting life and property and providing for the health and  
8 safety of the population in any area of the state in which the governor  
9 proclaims a state of emergency under Act No. 302 of the Public Acts of 1945,  
10 being sections 10.31 to 10.33 of the Michigan Compiled Laws, or under the  
11 emergency preparedness act, Act No. 390 of the Public Acts of 1976, being  
12 sections 30.401 to 30.420 of the Michigan Compiled Laws. The state director  
13 of emergency services shall expend the amounts the director considers  
14 necessary to accomplish these purposes. The director shall submit to the state  
15 budget director as soon as possible a complete report of all actions taken  
16 under the authority of this section. The report shall contain as a separate  
17 item a statement of all funds expended which were not reimbursable from  
18 federal funds. The state budget director shall review the expenditures and  
19 submit recommendations to the legislature in regard to any possible need for a  
20 supplemental appropriation.

21 (2) In addition to the appropriations contained in section 101, the  
22 department may receive and expend funds from local or private sources for the  
23 purpose of providing emergency management training to local or private  
24 interests.

25 (3) In addition to appropriations contained in section 101, the  
26 department may receive or expend funds from local sources for the purpose of

1 supporting emergency preparedness response and mitigation activity.

2 UNIFORM SERVICES

3       Sec. 801. (1) The funds appropriated in section 101 to the operations  
4 division for 9-1-1/central dispatch shall be used for state participation in  
5 current and proposed central dispatch operations. The appropriation shall  
6 provide staff for central dispatch services in Genesee county, Saginaw county,  
7 and Marquette county. This shall be a work project account and the state  
8 budget director may authorize the carryforward of these funds into the fiscal  
9 year beginning October 1, 1990. By November 15, 1990, any authorized  
10 carryforward of funds shall be reported to the members of the senate and house  
11 appropriations committees and the senate and house fiscal agencies.

12       (2) Any request for initial appropriation to CCD shall be submitted to  
13 the department for guideline approval and presented to the senate and house  
14 appropriations committees on state police for consideration of funding.

15       (3) Expenditure of the funds appropriated in section 101 for  
16 9-1-1/central dispatch shall be in accordance with the June 2, 1988 central  
17 dispatch state plan recommendations of the office of criminal  
18 justice/emergency telephone services (9-1-1) committee.

19 INVESTIGATIVE SERVICES

20       Sec. 901. (1) The funds appropriated in section 101 for federal anti-drug  
21 initiatives shall be limited to operations that include significant financial  
22 and personnel participation from local units of government.

23       (2) The funds appropriated in section 101 for cooperative drug team  
24 expansion shall be subject to a 50 percent match from participating local  
25 units of government.
