

HOUSE BILL No. 4344

EXECUTIVE BUDGET BILL

March 2, 1989, Introduced by Rep. Jacobetti and referred to the Committee on Appropriations.

A bill to make appropriations for the department of agriculture for the fiscal year ending September 30, 1990; to provide for the expenditure of the appropriations; to create funds; to provide for the imposition of fees; to require reports, audits, and plans; to authorize certain transfers by certain state agencies; and to provide for the disposition of fees and other income received by certain state agencies.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 Sec. 101. There is appropriated for the department of agriculture for the
2 fiscal year ending September 30, 1990, from the following funds:

16 Sec. 201. (1) In accordance with the provisions of section 30 of
 17 article IX of the state constitution of 1963, total state spending in this
 18 appropriation act is \$52,776,900.00 and state appropriations to be paid to
 19 local units of government in section 101 are as follows:

26 (2) When it appears to the principal executive officer of each department

1 that state spending to local units of government will be less than the amount
2 that was projected to be expended for any quarter, the principal executive
3 officer shall immediately give notice of the approximate shortfall to the
4 department of management and budget, the senate and house appropriations
5 committees, and the senate and house fiscal agencies.

6 Sec. 202. The appropriations made and the expenditures authorized under
7 this act and the departments, agencies, commissions, boards, offices, and
8 programs for which an appropriation is made under this act are subject to the
9 management and budget act, Act No. 431 of the Public Acts of 1984, being
10 sections 18.1101 to 18.1594 of the Michigan Compiled Laws.

11 Sec. 203. As used in this act:

12 (a) "Department" means the department of agriculture.

13 (b) "Director" means the director of the department.

14 (c) "EPA" means the United States environmental protection agency.

15 (d) "EPA-OE" means the United States environmental protection
16 agency-office of enforcement.

17 (e) "HHS-FDA" means the United States department of health and human
18 services-food and drug administration.

19 (f) "DAG-APHIS" means the United States department of
20 agriculture-animal plant health inspection service.

21 (g) "DAG-AMS" means the United States department of agriculture-
22 agriculture marketing service.

23 (h) "FTE" means full-time equated.

24 (i) "DAG-FSQS" means the United States department of agriculture-food
25 safety and quality service.

26

1 (j) "AGR-SRS" means the United States department of agriculture-
2 statistical reporting service.

3 (k) "IDG" means interdepartmental grant.

4 (l) "IDT" means intradepartmental transfer.

5 (m) "PCB" means polychlorinated biphenyl.

6 (n) "MEDA" means Michigan export development authority.

7 EXECUTIVE

8 Sec. 301. The appropriations in section 101 may be used for per diem
9 payments to members of boards, committees, and commissions for a full day's
10 board, committee, or commission work at which a quorum is present; for
11 attending a hearing as authorized by the respective board, committee, or
12 commission; or for performing official business as authorized by the respective
13 board, committee, or commission. The per diem payments shall be at a rate as
14 follows:

15	(a) Commission of agriculture.....	\$ 75.00 per day
16	(b) Soil conservation committee.....	\$ 35.00 per day
17	(c) Upper Peninsula state fair board.....	\$ 50.00 per day
18	(d) Agricultural marketing and bargaining board.....	\$ 35.00 per day

19 Sec. 302. If the director is required to lay off any department employees
20 to implement this act, the director shall be exempted from using a strict
21 application of continuous service credits in accordance with guidelines
22 developed by the state personnel director and approved by the civil service
23 commission in order to preserve affirmative action gains made in a program
24 approved by the Michigan equal employment and business opportunity council.
25 This is in accordance with civil service commission rule.

26 Sec. 303. The Pick Michigan program shall be considered a work project

1 and may be carried forward into the fiscal year beginning October 1, 1990.

2 Sec. 304. To qualify for the funds appropriated in section 101 for the
3 commodity promotion matching fund, an organization shall be 1 of the following:

4 (a) Organized under the agricultural commodities marketing act, Act No.
5 232 of the Public Acts of 1965, being sections 290.651 to 290.674 of the
6 Michigan Compiled Laws.

7 (b) Subject to a state commission or council pursuant to statute.

8 (c) A recognized, statewide, grower-funded organization for the promotion
9 or market development of a commodity if approved by the commission of
10 agriculture.

11 Sec. 305. The department may charge fees for publications and to use
12 those fees to cover necessary expenses.

13 ADMINISTRATIVE SERVICES

14 Sec. 401. The department may collect revenues and fees for audit and
15 licensing functions and may use these fees for necessary expenses.

16 PESTICIDE AND PLANT PEST MANAGEMENT

17 Sec. 501. The department may collect fees to conduct livestock sales at
18 the Upper Peninsula state fairgrounds and use the fees for necessary expenses
19 related to the livestock sales. Fees collected in excess of expenses shall be
20 credited to the state general fund.

21 Sec. 502. The department may charge a fee for propagating and certifying
22 virus free foundation stock.

23 Sec. 503. A fund is created, to be financed from commercial feed
24 inspection fees. The cost of the commercial feed inspectors shall be financed
25 from the fund created under this section.

26 Sec. 504. The department shall develop a strategy with accompanying cost

1 estimates for the purpose of the suppression of the gypsy moth infestation in
2 this state. In the development of this strategy, the department shall form a
3 committee consisting of representatives from the department and the departments
4 of natural resources, public health, and commerce and from Michigan state
5 university. The department shall consult with other states that are or have
6 experienced similar gypsy moth infestations. The department shall report its
7 findings to the house and senate appropriations subcommittees on agriculture
8 and to the department of management and budget by January 1, 1990.

9 Sec. 505. Of the funds appropriated in section 101, to the pesticide and
10 plant pest management division, up to \$50,000.00 may be made available to the
11 Michigan cooperative extension service for the purpose of training of
12 applicators. Reimbursement shall be based on actual expenditures and revenue
13 availability.

14 FOOD AND CONSUMER PROTECTION

15 Sec. 601. The department may collect fees and fines and may use these
16 funds to administer the gasoline inspection and testing program in accordance
17 with the motor fuels quality act, Act No. 44 of the Public Acts of 1984, being
18 sections 290.641 to 290.650 of the Michigan Compiled Laws.

19 Sec. 602. The department may provide bean inspection and grading services
20 and state meat grading services and use the revenues received from these
21 services for necessary expenses. The balance of those revenues on September
22 30, 1990, shall revert to the state general fund.

23 Sec. 603. The department may use all the inspection fees collected from
24 the inspection of fruits and vegetables at shipping points and processing
25 plants to pay necessary expenses related to the inspections.

26 LABORATORY SUPPORT

1 Sec. 701. The \$701,700.00 appropriated in section 801 for equine drug
2 testing includes sufficient funds to test horses entered in draft horse pulling
3 contests at county fairs when local jurisdictions request state assistance.

4 Sec. 702. The department may make necessary analyses to determine whether
5 or not stimulants or depressants were administered to horses engaged in racing
6 or pulling contests at tracks. A fee shall be charged to reimburse the
7 department for the costs of the tests.

8 Sec. 703. The department may levy and collect fees for the inspection,
9 testing, and identification of livestock for infectious or contagious diseases
10 for noxious or toxic materials or for equine infectious anemia diagnostic
11 tests.

12 Sec. 704. The department may conduct analyses of liming samples and
13 charge a fee for the service.

14 Sec. 705. The department may make regulatory and service tests of feed
15 and fertilizer samples and charge a fee sufficient to cover the costs of these
16 tests.

17 Sec. 706. The department may test samples for other agencies and
18 organizations and charge a fee for the services. The fees shall be used to
19 cover necessary expenses and shall be interaccounted.

20 OFFICE OF RACING COMMISSIONER

21 Sec. 801. The racing commissioner shall require, by rule, that each
22 racetrack in this state implement a sign-in and sign-out system at each gate to
23 a horse stable area.

24 Sec. 802. The appropriation in section 101 for the discretionary reward
25 fund in the racing supervision component shall be used by the racing
26 commissioner to pay rewards of not more than \$5,800.00 to a person who provides

1 information which results in the arrest and conviction on a felony charge for a
2 crime which involves the horse racing industry.

3 Sec. 803. Included in section 101 is an amount not to exceed \$750,000.00
4 for promotion of attendance at pari-mutuel horse racing. The state funds shall
5 be matched before expenditure such that each \$2.00 of state funds is matched by
6 \$1.00 of private industry funds. A race meeting licensee or an association of
7 thoroughbred and harness racetracks or any horsemen's group may submit a plan
8 and proposal to the racing commissioner for use of funds authorized to be
9 expended for promotion of attendance at pari-mutuel horse racing. A plan shall
10 be submitted by the commissioner before the funds may be expended. Each
11 licensee or association of thoroughbred and harness racetracks or horsemen's
12 group shall be eligible for promotional funds. The distribution shall not be
13 made until approved by the chairpersons of the appropriations subcommittees on
14 agriculture of the senate and house appropriations committees. All unexpended
15 funds shall lapse to the state general fund.

16 Sec. 804. The department shall report by November 1, 1989, to the senate
17 and house appropriations committees the horse racing revenues generated by each
18 breed of horse for which funds are appropriated in this act.

19 Sec. 805. (1) The appropriations made in section 101 from general
20 fund/special purpose horse racing revenues is intended for full funding
21 compliance with the racing law of 1980, Act No. 327 of the Public Acts of 1980,
22 being sections 431.61 to 431.88 of the Michigan Compiled Laws.

23 (2) By May 1, 1990, the department, together with the office of the racing
24 commissioner, shall report to the house and senate appropriation subcommittees
25 on agriculture the status of the appropriations made in this act in complying
26 with the funding requirements of the racing law of 1980.

1 GRANTS

2 Sec. 901. Of the \$83,600.00 appropriated in section 101 for the Great
 3 Lakes draft horse show, \$31,300.00 shall be made available for the Michigan
 4 dynamometers association, \$43,600.00 shall be made available for the Michigan
 5 draft horse breeders association, and \$8,700.00 shall be used for advertisement
 6 and promotion of an annual Great Lakes international draft horse show.

7 Sec. 902. Included in the appropriation made in section 101 for the
 8 thoroughbred program is \$35,200.00 for the Michigan united thoroughbred
 9 breeders and owners association to conduct a thoroughbred yearling show. The
 10 Michigan united thoroughbred breeders and owners association shall submit to
 11 the department an itemized list of expenses showing that the expenses of the
 12 yearling show were paid.

13 Sec. 903. (1) Except as provided in subsection (2), the appropriation of
 14 \$352,000.00 in section 101 for purses and supplements - licensed tracks is
 15 intended to provide state purse supplements for 4 races at state licensed
 16 pari-mutuel horse racing tracks. The purse supplements are to be used for
 17 races comprised only of Michigan bred horses segregated into a 4-year-old colt
 18 trot division, a 4-year-old filly trot division, a 4-year-old colt pace
 19 division, and a 4-year-old filly pace division.

20 (2) Of the \$352,000.00 appropriated in section 101 for purses and
 21 supplements licensed tracks, \$88,000.00 shall be allocated as follows:

22 Arabian and appaloosa horse racing.....	\$	22,000
23 Quarter horse racing.....		66,000

24 (3) The allocations made pursuant to this section shall be considered
 25 allocations for work projects and the unexpended balances shall be carried
 26 forward and shall not lapse until expended.

1 Sec. 904. (1) Of the amount appropriated in section 101 for purses and
2 supplements-fairs, a sufficient amount is appropriated to provide for overnight
3 purse supplements at the maximum supplement of \$1,000.00 per overnight race.

4 Sec. 905. Of the amount appropriated in section 101 for premiums
5 \$12,000.00 shall be expended as a grant for the Michigan horse show
6 association-fall youth show at the Michigan exposition and fairgrounds.

7 Sec. 906. A local unit of government which receives money from horse race
8 revenues for having racetracks within their limits shall report the
9 expenditures it incurred by having those racetracks within their limits for the
10 previous calendar year to the senate and house appropriations committees by
11 March 31 of each year.

12 Sec. 907. The independent audits of local units of government, as
13 required by the uniform budgeting and accounting act, Act No. 2 of the Public
14 Acts of 1968, being sections 141.421 to 141.440a of the Michigan Compiled Laws,
15 shall include an examination to determine the accuracy of reports submitted in
16 compliance with section 906 of this act. The reports shall be subject, at the
17 authorization of the chairpersons of the senate and house appropriations
18 committees, to the review of the auditor general.

19 Sec. 908. (1) The \$70,400.00 appropriated in section 101 for the Fedele
20 Fauri futurity shall only be used by the department to award a grant to an
21 Upper Peninsula county fair based upon competitive bidding.

22 (2) The \$70,400.00 appropriated in section 101 for the Michigan futurity
23 shall only be used by the department to award a grant to a Lower Peninsula
24 county fair based upon competitive bidding.

25 Sec. 909. Of the \$132,000.00 appropriated in section 101 for water
26 wonderland breeder awards, not more than 2% of the amount appropriated may be

1 used for administrative expenses required to manage the program, the remainder
2 shall be expended for premiums, judges, ribbons and trophies, promotion, and to
3 send state champions to national shows. Large breeds receiving over \$8,000.00
4 may use up to 20% for a show held separate from county or state fairs.

5 Sec. 910. The grant in section 101 to the future farmers of America shall
6 be used only to support authorized activities of the Michigan association of
7 the future farmers of America for regional and state level activities that
8 promote the development of technical agriculture and leadership skills. Final
9 approval for distribution of funds shall be given by the state future farmers
10 of America advisor who shall be designated by the director of the department.

11 Sec. 911. A county fair, district fair, 4-H fair, or state fair receiving
12 funds under this act to be used for prizes or awards, in whole or in part, as a
13 condition precedent to the receiving of the funds for those purposes, shall
14 publish the rules relative to the prizes, awards, and deadlines for entries
15 eligible for the funds in their official premium books or lists relative to the
16 prizes or awards. An aggrieved exhibitor may make a written complaint to the
17 department and the department shall investigate the complaint and make a
18 finding of fact regarding the complaint and take appropriate action regarding
19 the complaint.

20 Sec. 912. The \$1,202,700.00 appropriated in section 101 for grants to
21 local soil conservation districts shall be used for providing financial
22 assistance to all soil conservation districts in order to permit the districts
23 to engage in programs that conserve soil resources and prevent and control soil
24 erosion. All grants to local soil conservation districts shall be allocated
25 according to a formula approved by the commission of agriculture.

26 Sec. 913. An authority which receives money for stadium rental pursuant

1 to this act shall be audited before January 1, 1990, by the legislative auditor
2 general or an independent accounting firm approved by the legislative auditor
3 general. A copy of the audit, which shall include a detailed itemization of
4 all revenues and expenditures in a form approved by the legislative auditor
5 general, shall be submitted to the legislature before January 1, 1990.

6 Sec. 914. The department may carry forward unexpended appropriated funds
7 from the thoroughbred and standardbred sire stakes programs pursuant to section
8 13(9) and (10) of the racing law of 1980, Act No. 327 of the Public Acts of
9 1980, being section 431.73 of the Michigan Compiled Laws, for the purposes of
10 reimbursement of sire stakes purses for Michigan bred 2- and 3-year-old horse
11 races held in the following fiscal year.

12 Sec. 915. The amounts appropriated for utilities and that portion of
13 contractual services, supplies, and materials used to pay for utility service
14 to state facilities in section 101 may be expended in a manner consistent with
15 the provisions of section 253 of the management and budget act, Act No. 431 of
16 the Public Acts of 1984, as amended, being section 18.1253 of the Michigan
17 Compiled Laws.
