The fees and charges provided for in this section 14 shall be deposited in the state treasury to the credit of the 15 general fund. 16 (4) The provisions of subsection (1)(h), insofar as they 17 provide for examination fees, are applicable only if the examina-18 tions are administered by the commissioner. If the examinations 19 are administered by some designated authority other than the com-20 missioner, appropriate examination fees shall be payable directly 21 to the designated authority. 22 (5) THE FEES COLLECTED PURSUANT TO SUBSECTION (1)(J) SHALL 23 BE EARMARKED FOR THE SENIOR CITIZEN COMPLAINT UNIT OF THE INSUR-24 ANCE BUREAU.
