- 8 (A) SHALL INCLUDE COVERAGE FOR INTERMEDIATE/BASIC CARE.

- (B) SHALL NOT LIMIT OR EXCLUDE COVERAGE BY TYPE OF ILLNESS,
- 2 TREATMENT, MEDICAL CONDITION, OR ACCIDENT, EXCEPT AS FOLLOWS:

- 4 (ii) MENTAL OR NERVOUS DISORDERS; HOWEVER, THIS SHALL NOT

- 16 (E) AVIATION. THIS EXCLUSION APPLIES ONLY TO NONFARE PAYING
- 17 PASSENGERS.
- 18 (v) THIS SUBDIVISION IS NOT INTENDED TO PROHIBIT EXCLUSIONS
- 19 AND LIMITATIONS BY TYPE OF PROVIDER OR TERRITORIAL LIMITATIONS.
