- 5 SEC. 2289. LONG-TERM CARE COVERAGE THAT IS ISSUED OR
- 6 RENEWED AFTER THE EFFECTIVE DATE OF THIS SECTION SHALL MEET ALL
- 7 OF THE FOLLOWING REQUIREMENTS:
- 8 (A) SHALL INCLUDE COVERAGE FOR INTERMEDIATE/BASIC CARE.

- (B) SHALL NOT LIMIT OR EXCLUDE COVERAGE BY TYPE OF ILLNESS,
- 2 TREATMENT, MEDICAL CONDITION, OR ACCIDENT, EXCEPT AS FOLLOWS:
- 3 (i) PREEXISTING CONDITIONS.
- 4 (ii) MENTAL OR NERVOUS DISORDERS; HOWEVER, THIS SHALL NOT
- 5 PERMIT EXCLUSION OR LIMITATION OF BENEFITS ON THE BASIS OF
