THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Section 1. Section 21513 of Act No. 368 of the Public Acts
- 2 of 1978, as amended by Act No. 178 of the Public Acts of 1987,
- 3 being section 333.21513 of the Michigan Compiled Laws, is amended
- 4 to read as follows:
- 5 Sec. 21513. The owner, operator, and governing body of a
- 6 hospital licensed under this article:
- 7 (a) Are responsible for all phases of the operation of the
- 8 hospital, selection of the medical staff, and quality of care
- 9 rendered in the hospital.

- (b) Shall cooperate with the department in the enforcement
- 2 of this part, and require that the physicians, dentists, and
- 3 other personnel working in the hospital and for whom a license or
- 4 registration is required be currently licensed or registered.
- 5 (c) Shall assure that physicians and dentists admitted to
- 6 practice in the hospital are granted hospital privileges consis-
- 7 tent with their individual training, experience, and other
- 8 qualifications.
- 9 (d) Shall assure that physicians and dentists admitted to
- 10 practice in the hospital are organized into a medical staff to
- 11 enable an effective review of the professional practices in the
- 12 hospital for the purpose of reducing morbidity and mortality and
- 13 improving the care provided in the hospital for patients. This
- 14 review shall include the quality and necessity of the care pro-
- 15 vided and the preventability of complications and deaths occur-
- 16 ring in the hospital.
- (e) Shall notify the appropriate board as to disciplinary
- 18 action taken by the hospital for any of the grounds set forth in
- 19 section 16221 which results in a change of employment status or
- 20 privileges of practice of a physician or dentist admitted to
- 21 practice in the hospital, including an offer by the hospital to
- 22 permit the physician or dentist to resign in lieu of the hospital
- 23 taking disciplinary action against the physician or dentist. The
- 24 notice shall contain a summary of the information pertinent to
- 25 the change and shall be transmitted in writing to the appropriate
- 26 board within 30 days after the change occurs. As used in this

- 1 subdivision, "board" means a licensing board created pursuant to
- 2 article 15.
- 3 (F) SHALL NOT DISCRIMINATE BECAUSE OF RACE, RELIGION, COLOR,
- 4 NATIONAL ORIGIN, AGE, OR SEX IN THE OPERATION OF THE HOSPITAL
- 5 INCLUDING EMPLOYMENT, PATIENT ADMISSION AND CARE, ROOM ASSIGN-
- 6 MENT, AND PROFESSIONAL OR NONPROFESSIONAL SELECTION AND TRAINING
- 7 PROGRAMS, AND SHALL NOT DISCRIMINATE IN THE SELECTION AND
- 8 APPOINTMENT OF INDIVIDUALS TO THE PHYSICIAN STAFF OF THE HOSPITAL
- 9 OR ITS TRAINING PROGRAMS ON THE BASIS OF LICENSURE OR REGISTRA-
- 10 TION OR PROFESSIONAL EDUCATION AS DOCTORS OF MEDICINE, OSTEO-
- 11 PATHIC MEDICINE AND SURGERY, OR PODIATRY.
