HOUSE BILL No. 4417

March 9, 1989, Introduced by Rep. Bryant and referred to the Committee on State Affairs.

A bill to create the self-esteem and personal and social responsibility commission; to prescribe the powers and duties of the commission; to prescribe the powers and duties of certain state agencies; and to repeal this act on a specific date.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 1. This act shall be known and may be cited as the
- 2 "self-esteem and personal and social responsibility commission
- 3 act".
- 4 Sec. 2. As used in this act:
- 5 (a) "Commission" means the self-esteem and personal and
- 6 social responsibility commission created by section 3.
- 7 (b) "Department" means the department of public health.
- 8 Sec. 3. (1) The self-esteem and personal and social
- 9 responsibility commission is created within the department.

- 1 (2) The commission shall consist of 15 members appointed by
- 2 the governor, with the advice and consent of the senate,
- 3 representing various age, gender, political, and racial groups
- 4 and various geographic, cultural, educational, and professional

- 6 (3) The members of the commission shall serve for the life 7 of the commission.
- 8 (4) A vacancy occurring on the commission shall be filled in

- 9 may require and as may be available to the commission for the

- (b) Employ stenographic and clerical assistants the commis-
- 12 sion considers necessary in order to carry out the commission's
- 13 duties.
- 14 Sec. 8. This act is repealed upon the expiration of 3 years
- 15 after its effective date.
