- 1 (2) IN ORDER TO BE ELIGIBLE FOR AN ACHIEVEMENT INCENTIVE
- 2 GRANT, A BOARD SHALL SUBMIT TO THE DEPARTMENT A PLAN FOR DETER-

- 4 IN VARIOUS DISTRICT, REGIONAL, OR STATE COMPETITIONS OF ANY

- 6 (F) AN INCREASE IN THE NUMBER OF GRADUATES WHO WERE PLACED
- 7 IN JOBS OR JOB TRAINING PROGRAMS.
- 8 (C) THE PLAN IDENTIFIES BY NAME EACH SCHOOL WITHIN THE
- 9 SCHOOL DISTRICT.
- 10 (D) THE PLAN DESCRIBES ITS CRITERIA FOR SELECTING WHICH
- 11 SCHOOL OR SCHOOLS WITHIN THE SCHOOL DISTRICT WILL BE MONETARILY
- 12 REWARDED FOR ITS IMPROVED ACADEMIC PERFORMANCE AND ATTENDANCE
- 13 RATE. IN ORDER TO BE MONETARILY REWARDED, A SCHOOL WITHIN THE
