- 5 SEC. 1279. (1) BEGINNING WITH THE 1989-90 SCHOOL YEAR, THE
- 6 BOARD OF A SCHOOL DISTRICT SHALL PROVIDE THAT EACH PUPIL IN
- 7 GRADES 4 THROUGH 12 DEVELOP A PUPIL PORTFOLIO WITH THE ASSISTANCE
- 8 OF HIS OR HER PARENTS, GUARDIANS, OR PERSONS IN LOCO PARENTIS;
- 9 SCHOOL PERSONNEL; AND OTHER INTERESTED PERSONS. A PUPIL

- 1 PORTFOLIO SHALL CONTAIN INFORMATION ABOUT THE PUPIL'S ACADEMIC

- 22 (D) A RECORD OF RECOGNITIONS. THIS CHAPTER SHALL INCLUDE,
