A bill to amend section 8 of Act No. 89 of the Public Acts of 1977, entitled as amended

"State aid to public libraries act,"

being section 397.558 of the Michigan Compiled Laws.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Section 1. Section 8 of Act No. 89 of the Public Acts of
- 2 1977, being section 397.558 of the Michigan Compiled Laws, is
- 3 amended to read as follows:
- 4 Sec. 8. The cooperative library board shall:
- 5 (a) Have powers which THAT relate to the functioning of
- 6 the cooperative library and the management and control of the
- 7 cooperative library's funds and property.
- 8 (b) Select a chairperson.
- 9 (c) Be a body corporate and a juristic entity for -social
- 10 security and legal identity ALL LAWFUL purposes.

- (d) Establish, maintain, and operate cooperative services
- 2 for public libraries in the cooperative library's area.
- 3 (e) Appoint a director or coordinator to administer the
- 4 cooperative library, fix that person's compensation, and delegate
- 5 -those powers to that person -as are THOSE POWERS THE DELEGA-
- 6 TION OF WHICH IS in the best interest of the cooperative library,
- 7 including the power to hire necessary employees.
- 8 (f) Purchase books, periodicals, library materials, equip-
- 9 ment, and supplies for the cooperative services.
- 10 (g) Purchase sites, erect buildings, and lease suitable
- 11 quarters. -, and have supervision FOR THE PURPOSES OF THIS SUB-
- 12 DIVISION, A COOPERATIVE LIBRARY BOARD MAY BECOME A VENDEE UNDER A
- 13 LAND CONTRACT WITH A PURCHASE PRICE OF NOT MORE THAN \$500,000.00
- 14 OR OBTAIN A LOAN OF NOT MORE THAN \$500,000.00 SECURED BY A PUR-
- 15 CHASE MONEY MORTGAGE.
- 16 (H) SUPERVISE and control of property of the cooperative
- 17 library.
- 18 (I) -(h) Enter into contracts to receive service from or
- 19 give service to libraries in the state, including public, school,
- 20 academic, COOPERATIVE, or special libraries, -other cooperative
- 21 libraries and political subdivisions of the state.
- 22 (J)  $\frac{(i)}{(i)}$  Have exclusive control of expenditures for the
- 23 cooperative library.
- 24 (K) (j) Accept gifts and donations of property -, real and
- 25 personal, for the benefit of the cooperative library and for the
- 26 purposes for which donated.

1 (1) -(k)- Adopt bylaws and rules not inconsistent with this
2 act for its own government and do -those things necessary to
3 carry out the purposes of this act.
