- 5 SEC. 3607. (1) IF EXISTING GROUP DISABILITY COVERAGE IS
- 6 REPLACED BY A GROUP DISABILITY INSURANCE POLICY WITH A PREEXIST-
- 7 ING CONDITION LIMITATION, THE LEVEL OF COVERAGE IN THE
- 8 REPLACEMENT POLICY APPLICABLE TO THE PREEXISTING CONDITION
- 9 LIMITATION FOR A PERSON WHO HAD BEEN COVERED FOR THAT CONDITION

- 1 BY THE REPLACED COVERAGE SHALL BE NOT LESS THAN THE LESSER OF THE
- 2 FOLLOWING:
- 3 (A) THE COVERAGE OF THE REPLACEMENT POLICY WITHOUT APPLICA-
- 4 TION OF THE PREEXISTING CONDITION LIMITATION.
