- Section 1. Act No. 350 of the Public Acts of 1980, as

- 4 follows:
- 5 SEC. 401C. (1) IF EXISTING GROUP DISABILITY COVERAGE IS
- 6 REPLACED BY A GROUP CERTIFICATE WITH A PREEXISTING CONDITION LIM-
- 7 ITATION, THE LEVEL OF COVERAGE IN THE REPLACEMENT CERTIFICATE
- 8 APPLICABLE TO THE PREEXISTING CONDITION LIMITATION FOR A PERSON

- I WHO HAD BEEN COVERED FOR THAT CONDITION BY THE REPLACED COVERAGE
- 2 SHALL NOT BE LESS THAN THE LESSER OF THE FOLLOWING:
- 3 (A) THE COVERAGE OF THE REPLACEMENT CERTIFICATE WITHOUT
- 4 APPLICATION OF THE PREEXISTING CONDITION LIMITATION.

- 12 (3) THIS SECTION DOES NOT PRECLUDE A REDUCTION OR LIMITATION
- 13 OF BENEFITS WHICH APPLIES TO AN ENTIRE PLAN.
