

HOUSE BILL No. 4551

April 10, 1989, Introduced by Reps. Joe Young, Jr., Harrison, Perry Bullard, Van Singel and DeMars and referred to the Committee on State Affairs.

A bill to amend section 390 of Act No. 380 of the Public Acts of 1965, entitled

"Executive organization act of 1965,"

being section 16.490 of the Michigan Compiled Laws.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 Section 1. Section 390 of Act No. 380 of the Public Acts of
2 1965, being section 16.490 of the Michigan Compiled Laws, is
3 amended to read as follows:

4 Sec. 390. There is established within the department a com-
5 mission to be known as the commission on agricultural labor with
6 powers of a type II transfer. The commission shall consist of 11
7 members, 4 of whom shall be ~~chosen from~~ growers and producers
8 of agricultural products, ~~4 of whom shall be chosen from~~
9 agricultural workers, ~~of the 4 agricultural workers chosen 2~~
10 ~~shall be permanent or year round workers and 2 shall be resident~~

1 ~~seasonal workers;~~ and 3 OF WHOM shall be ~~chosen from~~
2 REPRESENTATIVES OF the general public. OF THE 4 AGRICULTURAL
3 WORKERS CHOSEN, 2 SHALL BE PERMANENT OR YEAR ROUND WORKERS, AND 2
4 SHALL BE RESIDENT SEASONAL WORKERS. The members of the commission
5 shall be appointed by the governor by and with the advice and
6 consent of the senate. ~~Of the members first appointed, 2 chosen~~
7 ~~from growers and producers and 1 of the general public shall~~
8 ~~serve for a term of 3 years, 1 chosen from growers and producers~~
9 ~~and 1 of the general public shall serve for terms of 2 years~~
10 ~~each, 1 chosen from growers and producers and 1 of the general~~
11 ~~public shall serve for a term of 1 year, and their successors~~ A
12 MEMBER shall serve for ~~terms~~ A TERM of 3 years. ~~Of those mem-~~
13 ~~bers first appointed to represent agricultural workers, 2 shall~~
14 ~~serve for 2 years and 2 shall serve for 3 years. Vacancies may~~
15 A VACANCY SHALL be filled for the BALANCE OF THE unexpired
16 ~~portion of the~~ term in the same manner as ~~appointments are~~
17 ~~made for a full term~~ THE ORIGINAL APPOINTMENT. The members
18 ~~shall serve without compensation other than for their necessary~~
19 ~~and proper expenses, which expenses are to be audited and paid~~
20 ~~from funds appropriated by the legislature for this purpose~~ MAY
21 RECEIVE PER DIEM COMPENSATION AND SHALL BE REIMBURSED FOR ACTUAL
22 AND NECESSARY EXPENSES INCURRED IN THE PERFORMANCE OF THEIR
23 DUTIES AS MEMBERS OF THE COMMISSION.
