- 3 Laws, is amended by adding section 7d to read as follows:
- 4 SEC. 7D. (1) A FIRE FIGHTER IS NOT CIVILLY OR CRIMINALLY
- 5 LIABLE FOR DAMAGE TO PUBLIC OR PRIVATE PROPERTY ARISING OUT THE
- 6 DISPERSAL, RELEASE, OR ESCAPE OF A POLLUTANT, INCLUDING DAMAGE TO
- 7 NATURAL RESOURCES OR THE PUBLIC TRUST IN NATURAL RESOURCES, IF
- 8 ALL OF THE FOLLOWING APPLY:

- (A) THE DAMAGE RESULTS FROM THE FIRE FIGHTER'S ACTS OR
- 2 OMISSIONS IN AN EMERGENCY OPERATION, INCLUDING, BUT NOT LIMITED
- 3 TO, AN OPERATION RELATED TO A FIRE, RESCUE, HAZARDOUS MATERIAL
