- 5 SEC. 4J. (1) THE TAX LEVIED UNDER THIS ACT DOES NOT APPLY
- 6 TO A MOTOR VEHICLE ACQUIRED BY A TOWING COMPANY FROM A POLICE
- 7 AGENCY AS SATISFACTION FOR TOWING AND STORAGE CHARGES IF THE
- 8 MOTOR VEHICLE WAS IMPOUNDED BY THE POLICE AGENCY OR DETERMINED TO

- 1 BE AN ABANDONED VEHICLE OR AN ABANDONED SCRAP VEHICLE BY THE 2 POLICE AGENCY.
- 3 (2) AS USED IN THIS SECTION:
- 4 (A) " ABANDONED VEHICLE" MEANS A VEHICLE THAT HAS REMAINED
- 5 ON PUBLIC PROPERTY OR ANY OTHER PLACE OPEN TO TRAVEL BY THE
- 6 PUBLIC WITHOUT THE CONSENT OF THE LOCAL POLICE AGENCY FOR A
- 7 PERIOD OF 48 HOURS AFTER A POLICE AGENCY HAS AFFIXED A WRITTEN
- 8 NOTICE TO THE VEHICLE.
- 9 (B) "ABANDONED SCRAP VEHICLE" MEANS A VEHICLE THAT MEETS ALL 10 OF THE FOLLOWING REQUIREMENTS:
- 11 (A) IS ON PUBLIC PROPERTY OR ANY OTHER PLACE OPEN TO TRAVEL 12 BY THE PUBLIC.
- 13 (B) IS 7 OR MORE YEARS OLD.
- 14 (C) IS APPARENTLY INOPERABLE OR IS EXTENSIVELY DAMAGED TO
 15 THE EXTENT THAT THE COST OF REPAIRING THE VEHICLE SO THAT IT IS
 16 OPERATIONAL AND SAFE WOULD EXCEED THE FAIR MARKET VALUE OF THAT
 17 VEHICLE.
- 18 (D) IS NOT CURRENTLY REGISTERED PURSUANT TO THE MICHIGAN
 19 VEHICLE CODE, ACT NO. 300 OF THE PUBLIC ACTS OF 1949, BEING SEC20 TIONS 257.1 TO 257.923 OF THE MICHIGAN COMPILED LAWS.
- 21 (E) IS NOT REMOVED WITHIN 48 HOURS AFTER A POLICE AGENCY HAS 22 AFFIXED A WRITTEN NOTICE TO THE VEHICLE.
