

HOUSE BILL No. 4638

April 13, 1989, Introduced by Reps. Bennane, DeMars, Pitoniak, Munsell and Leland and referred to the Committee on Public Health.

A bill to amend sections 16263, 18212, and 18223 of Act No. 368 of the Public Acts of 1978, entitled as amended "Public health code," section 16263 as amended by Act No. 473 of the Public Acts of 1988, section 18212 as amended by Act No. 20 of the Public Acts of 1987, and section 18223 as amended by Act No. 174 of the Public Acts of 1986, being sections 333.16263, 333.18212, and 333.18223 of the Michigan Compiled Laws.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 Section 1. Sections 16263, 18212, and 18223 of Act No. 368
2 of the Public Acts of 1978, section 16263 as amended by Act
3 No. 473 of the Public Acts of 1988, section 18212 as amended by
4 Act No. 20 of the Public Acts of 1987, and section 18223 as
5 amended by Act No. 174 of the Public Acts of 1986, being sections

1 333.16263, 333.18212, and 333.18223 of the Michigan Compiled
2 Laws, are amended to read as follows:

3 Sec. 16263. (1) Except as OTHERWISE provided in subsection
4 (2), the following words, titles, or letters or a combination
5 ~~thereof~~ OF THEM, with or without qualifying words or phrases,
6 are restricted in use only to those persons authorized under this
7 article to USE the terms and in a way prescribed in this
8 article:

9 (a) "Chiropractic", "doctor of chiropractic",
10 "chiropractor", "d.c.", and "chiropractic physician".

11 (b) "Dentist", "doctor of dental surgery", "oral and maxil-
12 lofacial surgeon", "orthodontist", ~~"prosthodontist"~~
13 "PROSTHODONTIST", "periodontist", "endodontist", "pediatric
14 dentist", "dental hygienist", "registered dental hygienist",
15 "dental assistant", "registered dental assistant", "R.D.A.",
16 "d.d.s.", "d.m.d.", and "r.d.h.".

17 (c) "Doctor of medicine" and "m.d.".

18 (d) "Physician's assistant" and "p.a.".

19 (e) "Registered professional nurse", "registered nurse",
20 "r.n.", "licensed practical nurse", "l.p.n.", "nurse midwife",
21 "nurse anesthetist", "nurse practitioner", "trained attendant",
22 and "t.a.".

23 (f) "Doctor of optometry", "optometrist", and "o.d.".

24 (g) "Osteopath", "osteopathy", "osteopathic practitioner",
25 "doctor of osteopathy", "diplomate in osteopathy", and "d.o.".

26 (h) "Pharmacy", "pharmacist", "apothecary", "drugstore",
27 "druggist", "medicine store", "prescriptions", and "r.ph.".

1 (i) "Physical therapy", "physical therapist",
 2 "physiotherapist", "registered physical therapist", "licensed
 3 physical therapist", "physical therapy technician", "p.t.",
 4 "r.p.t.", "l.p.t.", and "p.t.t.".

5 (j) "Chiropodist", "chiropody", "chiropodical", "podiatry",
 6 "podiatrist", "podiatric", "doctor of podiatric medicine", "foot
 7 specialist", "podiatric physician and surgeon", and "d.p.m.".

8 (k) "Consulting psychologist", "psychologist",
 9 "psychological assistant", and "psychological examiner",
 10 "licensed psychologist", "ASSOCIATE PSYCHOLOGIST", and "limited
 11 licensed psychologist".

12 (l) "Licensed professional counselor", "licensed counselor",
 13 "professional counselor", and "l.p.c.".

14 (m) "Sanitarian", "registered sanitarian", and "r.s.".

15 (n) "Veterinary", "veterinarian", "veterinary doctor",
 16 "veterinary surgeon", "doctor of veterinary medicine", "v.m.d.",
 17 "d.v.m.", ~~and after July 1, 1979,~~ "animal technician", or
 18 "animal technologist".

19 (o) "Occupational therapist", "occupational therapist
 20 registered", "certified occupational therapist", "o.t.",
 21 "o.t.r.", "c.o.t.", "certified occupational therapy assistant",
 22 "occupational therapy assistant", or "c.o.t.a.".

23 (2) Notwithstanding section 16261, a person who was spe-
 24 cially trained at an institution of higher education in this
 25 state to assist a physician in the field of orthopedics and upon
 26 completion of training, received a 2-year associate of science
 27 degree as an orthopedic physician's assistant before January 1,

1 1977, may use the title "orthopedic physician's assistant"
2 whether or not the person is licensed under this article.

3 Sec. 18212. (1) Except as otherwise provided in subsection
4 (3), an individual shall not engage in postdoctoral training
5 ~~which~~ THAT includes the practice of psychology without obtain-
6 ing a full or limited license to practice under this part.

7 (2) A limited license for an individual in postdoctoral
8 training shall require that the individual be under supervision
9 of a licensed psychologist and confine his or her practice and
10 training to a hospital, clinic, institution, or other arrangement
11 approved by the board for the training. The hospital, clinic, or
12 institution and designated licensed psychologist are responsible
13 for the training. A limited license for ~~a~~ postdoctoral train-
14 ing is renewable for not more than 5 years.

15 (3) The Michigan board of psychology shall waive the
16 requirement of having a limited license in order to engage in the
17 postdoctoral experience necessary to obtain a full license if all
18 of the following occur:

19 (a) The individual has met all the other requirements of
20 subsection (2).

21 (b) The individual submits a request for the waiver in writ-
22 ing and pays a sum equal to the cost of a limited license.

23 (c) The individual has applied for a license between July 1,
24 1985 and July 1, 1986.

25 Sec. 18223. (1) The board shall promulgate rules requiring
26 that an individual granted a license under this part, except as
27 OTHERWISE provided in subsection (2), shall have been granted a

1 doctoral degree in psychology, or a doctoral degree in a closely
2 related field, from a regionally accredited or other college,
3 university, or institution approved by the board, ~~which~~ THAT
4 included education and training appropriate to the practice of
5 psychology, and shall have not less than 2 years postdoctoral
6 experience in the practice of psychology in an organized health
7 care setting or other arrangement, as established by the board.

8 (2) In addition to A LIMITED LICENSE ISSUED UNDER
9 section 16182 OR SECTION 18212, the board shall grant ~~a limited~~
10 AN ASSOCIATE PSYCHOLOGIST license to an individual granted a
11 master's degree in psychology from a regionally accredited col-
12 lege, ~~or~~ university, or institution approved by the board, if
13 the individual has education, training, and experience appropri-
14 ate to the practice of psychology, as established by the board.
15 Except for duties performed as an employee of a governmental
16 entity or of a nonprofit organization serving benevolent and
17 charitable purposes, ~~2 limitations shall be placed on a license~~
18 ~~granted to an individual under this subsection. The limitations~~
19 ~~shall require supervision~~ AN INDIVIDUAL WITH AN ASSOCIATE PSY-
20 CHOLOGIST LICENSE SHALL BE SUPERVISED by a psychologist who has a
21 license other than a limited OR ASSOCIATE PSYCHOLOGIST license
22 and ~~shall prohibit advertising or other representation~~ SHALL
23 NOT ADVERTISE OR MAKE OTHER REPRESENTATIONS to the public ~~which~~
24 THAT will lead the public to believe the individual is engaging
25 in the practice of psychology EXCEPT AS THE INDIVIDUAL IS PERMIT-
26 TED TO PRACTICE UNDER THIS PART. ~~A limited~~ AN ASSOCIATE
27 PSYCHOLOGIST license granted under this subsection shall be

1 renewed pursuant to part 161. An individual applying for ~~a~~
2 ~~limited~~ AN ASSOCIATE PSYCHOLOGIST license pursuant to this sub-
3 section shall have 1 year of supervised postgraduate experience
4 in an organized health care setting or other arrangement, as
5 established by the board. The individual shall be supervised by
6 a psychologist who has a license other than a limited OR ASSOCI-
7 ATE PSYCHOLOGIST license, or if a psychologist who has a license
8 other than a limited OR ASSOCIATE PSYCHOLOGIST license is not
9 available, by a psychologist who has at least a master's degree
10 in psychology and at least 3 years of experience in the practice
11 of psychology or by any other individual approved by the board.
12 The board shall issue a temporary license to the individual for
13 the purpose of obtaining the 1 year of postgraduate experience.
