- 4 SEC. 493F. (1) A LESSOR OF RENTAL PROPERTY WHO KNOWINGLY
- 5 ALLOWS THE MANUFACTURE, DELIVERY, OR POSSESSION OF CONTROLLED
- 6 SUBSTANCES, AS DESCRIBED IN SUBSECTION (2), TO BE CONDUCTED BY
- 7 ANOTHER PERSON ON OR IN THE RENTAL PROPERTY IS GUILTY OF A
- 8 MISDEMEANOR, PUNISHABLE BY IMPRISONMENT FOR NOT MORE THAN 180
- 9 DAYS OR A FINE OF NOT MORE THAN \$5,000.00, OR BOTH.
