## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 7 WHO PROVIDES OBSTETRICAL HEALTH SERVICES IN THE COURSE OF HIS OR
- 8 HER PRIVATE PRACTICE SHALL DISTRIBUTE TO EACH PATIENT WHO
- 9 RECEIVES OBSTETRICAL SERVICES FROM THE PHYSICIAN AND IS PREGNANT

- 8 (2) IF A PATIENT IS GIVEN A COPY OF THE PAMPHLET REQUIRED
- 9 UNDER SUBSECTION (1), A FORM, SIGNED BY THE PATIENT, INDICATING
- 10 THAT THE PATIENT HAS BEEN GIVEN A COPY OF THE PAMPHLET, SHALL BE
- 11 INCLUDED IN THE PATIENT'S MEDICAL RECORD.
- 12 (3) A PATIENT WHO SIGNS A FORM PURSUANT TO SUBSECTION (3) IS
- 13 BARRED FROM SUBSEQUENTLY BRINGING A CIVIL ACTION AGAINST THE HOS-
- 14 PITAL, CLINIC, INSTITUTION, TEACHING INSTITUTION, OR OTHER HEALTH
- 15 FACILITY OR AGENCY PROVIDING THE PAMPHLET REQUIRED UNDER SUBSEC-
- 16 TION (1) BASED ON FAILURE TO PROVIDE THE INFORMATION CONTAINED IN

- 18 (4) THE PAMPHLET REQUIRED BY SUBSECTION (1) SHALL BE PRO-
- 19 VIDED BY THE DEPARTMENT. THE DEPARTMENT SHALL DEVELOP THE PAM-
- 20 PHLET IN CONSULTATION WITH APPROPRIATE PROFESSIONAL ORGANIZATIONS
- 21 AND HAVE THE PAMPHLET READY FOR DISTRIBUTION WITHIN 90 DAYS AFTER
- 22 THE EFFECTIVE DATE OF THIS SECTION. THE PAMPHLET SHALL BE WRIT-
- 23 TEN IN ENGLISH AND IN CLEAR, NONTECHNICAL TERMS. COPIES OF THE
- 24 PAMPHLET SHALL ALSO BE PRINTED IN SPANISH. THE PAMPHLET SHALL BE
- 25 DISTRIBUTED TO THE HEALTH FACILITIES DESCRIBED IN SUBSECTION

- 2 SUBSECTION (2), THE DEPARTMENT SHALL PROVIDE COPIES OF THE
- 3 PAMPHLET TO THE MICHIGAN BOARD OF MEDICINE AND THE MICHIGAN BOARD
- 4 OF OSTEOPATHIC MEDICINE AND SURGERY. THE DEPARTMENT SHALL PRO-
- 5 VIDE COPIES OF THE PAMPHLET TO OTHER PERSONS UPON WRITTEN
- 6 REQUEST, AT COST, AND SHALL ALSO PROVIDE COPIES OF THE PAMPHLET
- 7 FREE OF CHARGE, UPON REQUEST, TO PHYSICIANS DESCRIBED IN SECTIONS
