## **HOUSE BILL No. 4795**

May 10, 1989, Introduced by Reps. Spaniola and Hertel and referred to the Committee on Transportation.

A bill to amend section 18 of Act No. 73 of the Public Acts of 1970, entitled

"An act to provide for the creation of airport authorities; to provide for certain counties and cities within certain limitations of state-owned airports to create an airport authority; to provide for the membership of authorities; to provide for the powers and duties of the authorities; to provide for the transfer of employees of state airports to the employment of an authority; to provide for the transferring of state-owned lands to the authority; to provide for the retention of certain rights, powers and privileges by the state in state-owned airport facilities; to provide for a referendum; and to repeal acts and parts of acts,"

being section 259.818 of the Michigan Compiled Laws; and to repeal certain parts of the act.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Section 1. Section 18 of Act No. 73 of the Public Acts of
- 2 1970, being section 259.818 of the Michigan Compiled Laws, is

(1) The state shall have the use of the fueling rights, 21 22 ramps, aircraft parking, and motor vehicle parking rights, in 23 the immediate area adjacent to the state hangar with perpetual 24 rights of ingress and egress to such facilities, equipment and 25 properties— and the use of a plot of land without charge located 26 in the southeast aviation development area consisting of

- (2) The state reserves for the state health department the
- 11 use of all properties or a part thereof in the southwest 1/4 of
- 12 section 32, T5N, R2W, DeWitt township, Clinton county, Michigan,
- 13 except the north 500 feet thereof, containing 130 acres more or
- 14 less, and also the north 620 feet more or less of the west 3,000
- 15 feet of section 5, T4N, R2W, Lansing township, Ingham county,
- 16 Michigan, lying north of the Chesapeake and Ohio railroad
- 17 (formerly Pere Marquette) containing 31 acres more or less; so
- 18 long as not used for airport purposes, which shall be reserved
- 19 for use by the Michigan department of health for the purposes of
- 20 sanitary land fill, grazing, cropping, or other agricultural
- 21 purposes.
- 22 Section 2. Section 17 of Act No. 73 of the Public Acts of
- 23 1970, being section 259.817 of the Michigan Compiled Laws, is
- 24 repealed.
- 25 Section 3. This amendatory act shall not take effect unless
- 26 Senate Bill No. or House Bill No. 4797 (request no. 02429'89
- 27 b) of the 85th Legislature is enacted into law.
