## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 Section 1. Section 506 of Act No. 281 of the Public Acts of  
2 1967, as amended by Act No. 254 of the Public Acts of 1987, being  
3 section 206.506 of the Michigan Compiled Laws, is amended to read  
4 as follows:

5 Sec. 506. "Eligible serviceperson", "eligible veteran", and  
6 "eligible widow or widower" means a serviceperson, veteran, or  
7 widow or widower, whose income as defined in this chapter is not  
8 more than ~~\$7,500.00~~ \$12,000.00 per year unless the  
9 serviceperson, veteran, or widow or widower receives compensation
