THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Section 1. Section 14 of Act No. 256 of the Public Acts of
- 2 1988, being section 300.264 of the Michigan Compiled Laws, is
- 3 amended to read as follows:
- 4 Sec. 14. (1) The director or an authorized representative
- 5 of the director may issue a permit to a person who is unable to
- 6 walk due to being a paraplegic or an amputee, or being per-
- 7 manently disabled and unable to walk because of other disease or
- 8 injury. A permit issued under this subsection shall authorize
- 9 the person to take game during the open season for that game,
- 10 including deer of either sex, from or upon a standing vehicle if

- 1 that person holds a license to take that game issued pursuant to
- 2 the hunting and fishing license act, Act No. 86 of the Public
- 3 Acts of 1980, being sections 316.101 to 316.902 of the Michigan
- 4 Compiled Laws, and complies with all other laws and rules for the
- 5 taking of game. A PERMIT ISSUED UNDER THIS SECTION SHALL BE CAR-
- 6 RIED WHEN AFIELD AND EXHIBITED UPON DEMAND OF A CONSERVATION

- 8 (2) The director or an authorized representative of the
- 9 director may issue a permit to a person who is permanently dis-
- 10 abled and who has full use of only 1 arm and who upon investiga-

- 21 (3) THE DIRECTOR OR AN AUTHORIZED REPRESENTATIVE OF THE

- 23 PARALYSIS, AMPUTATION, OR DISEASE, IS PERMANENTLY UNABLE TO WALK
- 24 AND REQUIRES A WHEELCHAIR OR OTHER MECHANICAL DEVICE FOR ALL
- 25 TRANSPORTATION; OR TO A PERSON WHO, AS A RESULT OF PARALYSIS,
- 26 AMPUTATION, OR DISEASE HAS PERMANENTLY LOST ALL USE OF 1 ARM AND
- 27 IS UNABLE TO HUNT UNDER A PERMIT ISSUED PURSUANT TO

- 1 SUBSECTION (2). A PERSON ISSUED A PERMIT UNDER THIS SUBSECTION
- 2 MAY TAKE A DEER DURING THE OPEN BOW AND ARROW ONLY SEASON USING A
- 3 SHOTGUN IF THAT PERSON HOLDS A BOW AND ARROW LICENSE, JUNIOR BOW
- 4 AND ARROW LICENSE. SENIOR CITIZEN HUNTING LICENSE OR
- 5 SPORTSPERSON'S LICENSE ISSUED PURSUANT TO THE HUNTING AND FISHING
- 6 LICENSE ACT, ACT NO. 86 OF THE PUBLIC ACTS OF 1980, AND COMPLIES
- 7 WITH ALL OTHER LAWS AND RULES FOR THE TAKING OF GAME. A PERMIT
- 8 ISSUED UNDER THIS SUBSECTION SHALL BE CARRIED WHEN AFIELD AND
- 9 EXHIBITED UPON DEMAND OF A CONSERVATION OFFICER OR OTHER PEACE
- 10 OFFICER.
- (4) -(3) In addition, the director or an authorized repre-
- 12 sentative of the director may issue permits authorizing 1 or more
- 13 of the following:
- (a) The taking or possession of animals for the purpose of
- 15 rehabilitating animals.
- (b) The taking of animals to prevent or control damage and
- 17 nuisance caused by the animals.
- (c) The collection, transportation, possession, or disposi-
- 19 tion of animals, and parts of animals, for scientific purposes.
- 20 (d) The public exhibition of animals.
- 21 (e) Taxidermy.
- (f) The disposition of accidentally or unlawfully taken or
- 23 injured animals, or animals that are unlawfully possessed.
- 24 (5) -(4) A permit issued under this section may be sus-
- 25 pended, revoked, annulled, withdrawn, recalled, canceled, or
- 26 amended pursuant to the administrative procedures act of 1969,
- 27 Act No. 306 of the Public Acts of 1969, being sections 24.201 to

- 1 24.328 of the Michigan Compiled Laws. If the holder of a permit
- 2 is convicted of violating this section, his or her permit or
- 3 license may be revoked and any animal and the parts of any animal
- 4 in his or her possession shall be disposed of in a manner
- 5 approved by the director.
- 6 (6) -(5) All fees received for permits and licenses issued
- 7 under this section shall be forwarded by the department to the
- 8 state treasurer to be credited to the game and fish protection
- 9 fund CREATED IN THE HUNTING AND FISHING LICENSE ACT, ACT NO. 86
- 10 OF THE PUBLIC ACTS OF 1980, BEING SECTIONS 316.101 TO 316.902 OF
- 11 THE MICHIGAN COMPILED LAWS.
- 12 Section 2. This amendatory act shall not take effect unless
- 13 Senate Bill No. or House Bill No. 4864 (request
- 14 no. 02940'89 a) of the 85th Legislature are enacted into law.
