## **HOUSE BILL No. 4864**

May 23, 1989, Introduced by Reps. Bartnik, Krause, DeMars, Camp, Middaugh, Hertel, Hart, Niederstadt, Stupak, Weeks, Martin, Johnson, Owen and Profit and referred to the Committee on Tourism, Fisheries and Wildlife.

A bill to amend sections 802 and 805 of Act No. 86 of the Public Acts of 1980, entitled

"The hunting and fishing license act,"

being sections 316.802 and 316.805 of the Michigan Compiled Laws.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Section 1. Sections 802 and 805 of Act No. 86 of the Public
- 2 Acts of 1980, being sections 316.802 and 316.805 of the Michigan
- 3 Compiled Laws, are amended to read as follows:
- 4 Sec. 802. (1) During EXCEPT AS OTHERWISE PROVIDED IN SUB-
- 5 SECTION (2), DURING a season open to the hunting of deer with bow
- 6 and arrow, a licensee shall not carry a pistol, revolver, or any
- 7 other firearm while bow hunting for deer.
- 8 (2) SUBSECTION (1) SHALL NOT APPLY TO A PERSON WHO CARRIES A
- 9 SHOTGUN AND HOLDS A VALID PERMIT TO TAKE DEER WITH A SHOTGUN
