HOUSE BILL No. 4871

A bill to encourage cooperation in the development of markets for certain recyclable materials between this state and other states and countries; to provide for the powers and duties of certain state agencies and officials; and to repeal this act on a specific date.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 1. As used in this act:
- 2 (a) "Department" means the department of commerce.
- 3 (b) "Multistate" means this state, other states, and other
- 4 countries or provinces.
- 5 (c) "Recyclable materials" includes, but is not limited to,
- 6 recycled paper products, structural materials made from recycled
- 7 plastics, rerefined lubricating oils, reclaimed solvents,
- 8 recycled asphalt and concrete, recycled glass products, retreaded

- 1 tires, and ferrous and nonferrous metals containing recycled
- 2 scrap metals, that contain 1 or more of the following:
- 3 (i) Waste materials generated by a business or a consumer.
- 4 (ii) Materials that have served their intended purpose.
- 5 (iii) Materials that have been separated from solid waste
- 6 for purposes of collection, recycling, and disposition.
- 7 (d) "Solid waste" means solid waste as defined in the solid
- 8 waste management act, Act No. 641 of the Public Acts of 1978,
- 9 being sections 299.401 to 299.437 of the Michigan Compiled Laws.
- 10 Sec. 2. The department, with the advice and assistance of
- 11 the department of natural resources, shall assemble an interstate
- 12 task force to plan and develop markets for certain recyclable
- 13 materials that require interstate cooperation to generate and
- 14 collect sufficient materials to assure the economic feasibility
- 15 of the recycling enterprise.
- 16 Sec. 3. In implementing this act, the department, with the
- 17 advice and assistance of the department of natural resources,
- 18 shall do all of the following:
- (a) Identify recyclable materials that require multistate
- 20 organizations to facilitate economically viable recycling
- 21 enterprises.
- (b) Conduct, cause to be conducted, or utilize existing
- 23 waste stream assessments to estimate available recyclable materi-

- (c) Establish a data base of available information pertain-
- 26 ing to recyclable material that is or could be available within
- 27 this state.

- (d) Take such other action as necessary to fulfill the
- 2 requirements of section 2.
- 3 Sec. 4. This act is repealed effective upon the expiration
- 4 of 2 years after its effective date.
