

HOUSE BILL No. 4926

June 15, 1989, Introduced by Reps. Runco, Palamara, Richard A. Young, DeMars, Varga, Brown, Kosteva, DeBeaussaert, Jaye, Willis Bullard, Law, Middaugh, Bankes, Hoffman, Dunaskiss and Dolan and referred to the Committee on Conservation, Recreation and Environment.

A bill to amend Act No. 64 of the Public Acts of 1979, entitled as amended

"Hazardous waste management act,"

as amended, being sections 299.501 to 299.551 of the Michigan Compiled Laws, by adding section 19a.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 Section 1. Act No. 64 of the Public Acts of 1979, as
2 amended, being sections 299.501 to 299.551 of the Michigan
3 Compiled Laws, is amended by adding section 19a to read as
4 follows:

5 SEC. 19A. THE OWNER OR OPERATOR OF A DISPOSAL FACILITY THAT
6 IS LOCATED IN AN AREA WHERE THE POPULATION EXCEEDS 40,000 WITHIN
7 A 3-MILE RADIUS OF THE FACILITY SHALL DO ALL OF THE FOLLOWING:

8 (A) SCHEDULE AND PROVIDE NOTICE OF A BIENNIAL PUBLIC HEARING
9 IN THE COUNTY IN WHICH THE FACILITY IS LOCATED AND CONDUCT A

1 PUBLIC HEARING THAT PROVIDES INDIVIDUALS WHO RESIDE OR WORK
2 WITHIN A 3-MILE RADIUS OF THE FACILITY AN OPPORTUNITY TO TESTIFY
3 AND ASK QUESTIONS REGARDING THE OPERATION OF THE FACILITY AND ITS
4 IMPACT ON THE PUBLIC HEALTH, SAFETY, WELFARE, AND THE
5 ENVIRONMENT.

6 (B) SCHEDULE AND PROVIDE NOTICE OF THE OPPORTUNITY FOR INDIVIDUALS WHO RESIDE OR WORK WITHIN A 3-MILE RADIUS OF THE FACILITY
7 TO INSPECT THE FACILITY UNDER THE SUPERVISION OF THE FACILITY
8 OPERATOR OR HIS OR HER DESIGNATED AGENT AND THE DEPARTMENT.

9 (C) ONCE EVERY OTHER MONTH, COLLECT A 24-HOUR COMPOSITE
10 SAMPLE OF THE HAZARDOUS WASTE THAT IS DISPOSED OF AT THE FACILITY,
11 ANALYZE THE SAMPLE, AND PROVIDE INFORMATION OBTAINED FROM THE
12 ANALYSIS TO THE DEPARTMENT.

13 (D) NOT LESS THAN ONCE EVERY OTHER MONTH, CONDUCT ALL ENVIRONMENTAL MONITORING REQUIRED IN THE OPERATING LICENSE FOR THE
14 FACILITY. HOWEVER, IF THE OPERATING LICENSE REQUIRES THAT A PARTICULAR MONITORING PROGRAM OCCUR MORE FREQUENTLY THAN ONCE EVERY
15 OTHER MONTH, THEN THE LEVEL OF MONITORING FREQUENCY REQUIRED IN
16 THE LICENSE SHALL BE MAINTAINED NOTWITHSTANDING THIS SUBSECTION.
