THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Section 1. The title of Act No. 128 of the Public Acts of
- 2 1985, being sections 323.31 to 323.34 of the Michigan Compiled
- 3 Laws, is amended and section 5 is added to read as follows:
- 4 TITLE
- 5 An act to establish the office of the Great Lakes within the
- 6 department of natural resources and to designate the office as
- 7 the lead agency within state government for the development of
- 8 policies, programs, and procedures to protect, enhance, and
- 9 manage the Great Lakes; to prescribe the powers and duties of

- 1 state departments; TO CREATE A FUND AND PROVIDE FOR ITS USE; and
- 2 to require the governor to submit certain reports, analyses, and
- 3 inventories.
- 4 SEC. 5. (1) THE GREAT LAKES SPILL PREVENTION RESEARCH FUND
- 5 IS CREATED IN THE STATE TREASURY.
- 6 (2) THE FUND SHALL RECEIVE MONEY AS APPROPRIATED BY THE LEG-
- 7 ISLATURE AND AS OTHERWISE PROVIDED BY LAW. THE STATE TREASURER
- 8 SHALL DIRECT THE INVESTMENT OF THE FUND. INTEREST AND EARNINGS

- 17 (B) RESEARCH ON SELECTED POLLUTION INCIDENTS TO DETERMINE
- 18 CAUSAL FACTORS IN SPILLS OF HAZARDOUS SUBSTANCES ON THE GREAT
- 19 LAKES AND MAJOR TRIBUTARIES OF THE GREAT LAKES.
- 20 (C) RESEARCH AND DEVELOPMENT OF A TOTAL SYSTEMS APPROACH TO
- 21 ADDRESS GREAT LAKES POLLUTION PROBLEMS THAT INCLUDE HUMAN FACTORS
- 22 AND SOCIO-TECHNICAL CONSIDERATIONS.
- 23 (D) RESEARCH INTO THE ROLE OF HUMAN FACTORS IN SPILLS OF
- 24 HAZARDOUS SUBSTANCES ON THE GREAT LAKES AND MAJOR TRIBUTARIES OF
- 25 THE GREAT LAKES, INCLUDING HUMAN FACTORS IN POLLUTION ALARMS,
- 26 POLLUTION MONITORING SYSTEMS, AND INSTRUMENTATION.

- 1 (E) RESEARCH INTO THE DEPLOYMENT OF NEW TECHNOLOGY RELATED
- 2 TO TRANSPORTATION OF HAZARDOUS SUBSTANCES ON THE GREAT LAKES AND
- 3 MAJOR TRIBUTARIES OF THE GREAT LAKES AND THE APPROPRIATE ALLOCA-
- 4 TION OF FUNCTIONS BETWEEN INDIVIDUALS AND MACHINES.
- 5 (F) RESEARCH TO DETERMINE THE RELATIVE CONTRIBUTION OF
- 6 SPILLS OF HAZARDOUS SUBSTANCES INTO THE GREAT LAKES AND MAJOR
- 7 TRIBUTARIES OF THE GREAT LAKES TO THE TOTAL POLLUTION OF THE
- 8 GREAT LAKES BASIN.
- 9 (4) AS USED IN THIS SECTION:
- 10 (A) "FUND" MEANS THE GREAT LAKES SPILL PREVENTION RESEARCH
- 11 FUND CREATED IN SUBSECTION (1).
- 12 (B) "GREAT LAKES" MEANS THE GREAT LAKES AND THEIR CONNECTING
- 13 WATERWAYS OVER WHICH THE STATE HAS JURISDICTION.
- 14 (C) "HAZARDOUS SUBSTANCE" MEANS A CHEMICAL OR OTHER MATERIAL
- 15 WHICH IS OR MAY BECOME INJURIOUS TO THE PUBLIC HEALTH, SAFETY, OR
- 16 WELFARE OR TO THE ENVIRONMENT.
- 17 (D) "MAJOR TRIBUTARY OF THE GREAT LAKES" MEANS A RIVER THAT
- 18 FLOWS INTO THE GREAT LAKES THAT HAS A DRAINAGE AREA IN EXCESS OF
- 19 700 SQUARE MILES OR HAS A DRAINAGE AREA THAT CONTAINS A POPULA-
- 20 TION OF 1,000,000 OR MORE INDIVIDUALS.
- 21 (E) "SPILL" MEANS ANY SUDDEN, UNEXPECTED LEAKING, PUMPING,
- 22 POURING, EMITTING, LEACHING, EMPTYING, DISCHARGING, ESCAPING,
- 23 DUMPING, OR DISPOSING THAT OCCURS WITHOUT THE APPROVAL OF THE
- 24 DEPARTMENT.
