A bill to provide immunity from civil suits to certain persons involved in remedial actions associated with hazardous substance spills in the waters of the state.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 1. As used in this section:
- 2 (a) "Hazardous substances" means a chemical or other mate-
- 3 rial which is or may become injurious to the public health,
- 4 safety, or welfare or to the environment.
- 5 (b) "Person" means an individual, corporation, partnership,
- 6 association, the state, a local unit of government, a political
- 7 subdivision of the state or a local unit of government, or any
- 8 other legal entity.
- 9 (c) "Remedial action" means an activity to protect the
- 10 public health, safety, welfare, and the environment, and includes

- 1 but is not limited to, cleanup, removal, containment, or
- 2 isolation of spills of hazardous substances.
- 3 (d) "Spills" means a sudden, unexpected leaking, pumping,
- 4 pouring, emitting, leaching, emptying, discharging, escaping,
- 5 dumping, or disposing that occurs without the approval of the
- 6 department of natural resources.
- 7 (e) "Waters of the state" means all groundwaters, lakes,
- 8 rivers, streams, and other watercourses including the Great Lakes
- 9 and their connecting waterways within the jurisdiction of the
- 10 state.
- 11 Sec. 2. (1) A person who assists in remedial actions asso-
- 12 ciated with spills of hazardous substances into the waters of the
- 13 state shall not be liable in a civil action for damages resulting
- 14 from an act or omission arising out of and in the course of the
- 15 person's good faith rendering of that assistance unless the
- 16 person's act or omission was the result of that person's gross
- 17 negligence or willful misconduct.
- 18 (2) Subsection (1) shall not apply to a person rendering
- 19 assistance for remuneration beyond reimbursement for out of
- 20 pocket expenses in connection with the assistance.
- 21 (3) This section does not grant immunity to a person who
- 22 causes a spill.
