- 4 SEC. 830M. (1) A PERSON WHO WAS OR IS A MEMBER OF THE MILI-
- 5 TARY RESERVE MAY MAKE APPLICATION TO THE SECRETARY OF STATE FOR A
- 6 SPECIAL REGISTRATION PLATE, WHICH SHALL DISPLAY AN APPROPRIATE
- 7 VIGNETTE PRECEDING THE REGISTRATION NUMBERS AND SHALL HAVE THE
- 8 WORDS "MILITARY RESERVIST" INSCRIBED BENEATH THE REGISTRATION

9 NUMBERS.

- 1 (2) APPLICATION FOR A SPECIAL REGISTRATION PLATE SHALL BE ON
- 2 A FORM PRESCRIBED BY THE SECRETARY OF STATE, AND SHALL BE ACCOM-
- 3 PANIED BY ANY PROOF OF THE APPLICANT BEING OR HAVING BEEN A MILI-
- 4 TARY RESERVIST WHICH THE SECRETARY OF STATE MAY REQUIRE. THE

- 22 MISDEMEANOR.
- 23 (5) THE SPECIAL REGISTRATION PLATE ISSUED UNDER THIS SECTION
- 24 EXPIRES ON THE BIRTHDAY OF THE VEHICLE OWNER. WHEN NEW PLATES
- 25 ARE ISSUED BY THE SECRETARY OF STATE, APPLICATION FOR RENEWAL OF
- 26 THE SPECIAL REGISTRATION PLATE SHALL BE ACCOMPANIED BY A \$5.00

- 1 SERVICE FEE. THE APPLICANT SHALL NOT BE REQUIRED TO FURNISH THE
- 2 PROOF PROVIDED IN SUBSECTION (2).
