A bill to amend section 19 of Act No. 255 of the Public Acts of 1986, entitled

"Prepaid funeral contract funding act,"

being section 328.229 of the Michigan Compiled Laws.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Section 1. Section 19 of Act No. 255 of the Public Acts of
- 2 1986, being section 328.229 of the Michigan Compiled Laws, is
- 3 amended to read as follows:
- 4 Sec. 19. (1) A prepaid funeral contract may be made with an
- 5 applicant for or recipient of assistance under the social welfare
- 6 act, Act No. 280 of the Public Acts of 1939, being sections 400.1
- 7 to 400.121 of the Michigan Compiled Laws, or a patient or a legal
- 8 guardian of a patient in a mental health care facility under the
- 9 jurisdiction of the department of mental health. If the
- 10 department of social services or department of mental health

- 1 determines that the contract is a fully paid guaranteed price
- 2 contract of not more than \$2,000.00 exclusive of income THE
- 3 VALUE OF WHICH DOES NOT EXCEED THE AMOUNT SET FORTH IN SUBSECTION
- 4 (3), and that the state will not be liable for the funeral goods
- 5 or funeral services, excluding an outside receptacle when
- 6 required by the chosen cemetery, of the applicant for or recipi-
- 7 ent of assistance or patient allowable under contracts under this
- 8 act, the prepaid funeral contract shall be made irrevocable at
- 9 the request of the applicant for or recipient of assistance, or
- 10 the patient or a legal guardian of a patient. The department of

- 12 CONTRACT IS MADE IRREVOCABLE, THE TOTAL AMOUNT PAID TO THE CON-
- 13 TRACT SELLER OR PROVIDER AS CONSIDERATION IS THE SAME AS OR LESS
- 14 THAN THE MAXIMUM AMOUNT OF THE DEATH BENEFIT OF AN ASSOCIATED
- 15 LIFE INSURANCE POLICY THAT IS AUTHORIZED TO BE EXCLUDED IN DETER-
- 16 MINING ELIGIBILITY FOR SUCH ASSISTANCE UNDER SECTION 2080 OF THE
- 17 INSURANCE CODE OF 1956, ACT NO. 218 OF THE PUBLIC ACTS OF 1956,
- 18 BEING SECTION 500.2080 OF THE MICHIGAN COMPILED LAWS, INCLUDING
- 19 SUBSEQUENT AMENDMENTS TO THAT ACT.
- 20 (4) -(3) Notwithstanding any other provisions of this act,
- 21 funds paid in connection with an irrevocable prepaid funeral con-
- 22 tract may, at the option of the provider, be held and deposited
- 23 in the manner prescribed for a nonquaranteed price contract.
- 24 (5) -(4) The department of social services and department
- 25 of mental health may promulgate rules under the administrative
- 26 procedures act of 1969, Act No. 306 of the Public Acts of 1969,

- 1 being sections 24.201 to 24.328 of the Michigan Compiled Laws, to
- 2 provide for the uniform administration of this section.
- 3 Section 2. This amendatory act shall not take effect unless
- 4 Senate Bill No. or House Bill No. 4503 (request
- 5 no. 00243'89) of the 85th Legislature is enacted into law.
