A bill to create national guard army training site committees; to establish the powers and duties of the committees; and to prescribe the powers and duties of certain departments and officers.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 1. This act shall be known and may be cited as the
- 2 "national guard army training site committees act".
- 3 Sec. 2. As used in this act:
- 4 (a) "Camp" means a Michigan national guard army training
 5 site in this state.
- 6 (b) "Committee" means a national guard army training site 7 committee created in section 3.
- 8 (c) "Michigan national guard" means that term as defined in
- 9 section 105 of the Michigan military act, Act No. 150 of the

- 2 Compiled Laws.
- 3 (d) "Ombudsman" means a citizen ombudsman appointed pursuant
- 4 to section 8.
- 5 Sec. 3. There is created for each camp a national guard
- 6 army training site committee within the department of natural
- 7 resources.
- 8 Sec. 4. (1) Each committee shall consist of 7 voting mem-
- 9 bers and 6 nonvoting members. The 7 voting members shall be
- 10 appointed by the governor with the advice and consent of the
- 11 senate and shall represent persons interested in the committee's
- 12 purpose, persons who have an acknowledged interest or expertise
- 13 in matters involving camp oversight and camp activities, and rep-
- 14 resentatives of each local governmental body having camp training
- 15 land within the camp's geographic boundaries. The 6 nonvoting
- 16 members shall be as follows:
- 17 (a) A forester, conservation officer, and wildlife biologist
- 18 from the department of natural resources selected by the director
- 19 of the department of natural resources.
- 20 (b) The camp commander, his or her training officer, and his
- 21 or her resident environmentalist.
- 22 (2) Except as otherwise provided in this subsection, commit-
- 23 tee members shall serve for 3-year terms. Of the members first
- 24 appointed by the governor, 2 shall serve for a 1-year term, 2
- 25 shall serve for a 2-year term, and 3 shall serve for a 3-year
- 26 term.

- 1 (3) Vacancies in the committee's membership shall be filled 2 in the same manner as the original appointment for the unexpired 3 term.
- 4 Sec. 5. (1) Each committee shall elect a voting member to
- 5 serve as chairperson for a 1-year term. The chairperson shall
- 6 call meetings, set agenda which shall be sent to each committee
- 7 member 2 weeks before each meeting, and appoint subcommittees as
- 8 the committee considers necessary. The chairperson shall serve
- 9 without vote as a member of all subcommittees.
- 10 (2) Each committee shall elect a voting member to serve as
- 11 vice-chairperson for a 1-year term. The vice-chairperson shall
- 12 serve as chairperson in the chairperson's absence and shall oth-
- 13 erwise assist the chairperson in his or her duties.
- 14 Sec. 6. (1) Each committee shall meet at least 4 times a
- 15 year and the business of the committee shall be conducted at a
- 16 public meeting held in compliance with the open meetings act, Act
- 17 No. 267 of the Public Acts of 1976, being sections 15.261 to
- 18 15.275 of the Michigan Compiled Laws. Public notice of the time,
- 19 date, and place of the meeting shall be given in the manner
- 20 required by Act No. 267 of the Public Acts of 1976.
- 21 (2) A writing prepared, owned, used, in the possession of,
- 22 or retained by the committee in the performance of an official
- 23 function shall be made available to the public in compliance with
- 24 the freedom of information act, Act No. 442 of the Public Acts of
- 25 1976, being sections 15.231 to 15.246 of the Michigan Compiled
- 26 Laws.

- (3) A quorum of the committee shall consist of a simple
 majority of the voting members.
- 3 (4) A committee member shall not be entitled to per diem
- 4 compensation but each committee member shall be entitled to
- 5 actual and necessary travel expenses and other expenses incurred
- 6 in the performance of official duties under this act.
- 7 Sec. 7. Each committee shall do all of the following:
- 8 (a) Become familiar with the physical features and charac-
- 9 teristics of the region affected by the camp, including present
- 10 patterns of military, public, and private use.
- (b) Become familiar with the long-range plans to improve,
- 12 develop, or intensify the use of the camp.
- (c) Monitor the plans, programs, and activities proposed or
- 14 conducted within the camp as they relate to the environment, nat-
- 15 ural resources, and quality of human life in the region used for
- 16 or affected by the camp's military training operations.
- (d) Quickly identify problems that conflict with or endanger
- 18 the environment, natural resources, and quality of human life,
- 19 recommend modifications in the camp's plans, programs, and activ-
- 20 ities as the committee considers warranted, and report these rec-
- 21 ommendations to the governor, the director of the department of
- 22 natural resources, and the director of the department of military
- 23 affairs and adjutant general of the state of Michigan.
- (e) Develop a management plan describing limits on various
- 25 types of land use, whether military, public, or private, to pro-
- 26 mote the long-term maintenance of the property within the region
- 27 used for or affected by the camp's military training operations

- 1 and appraise ongoing programs in terms of meeting the management
 2 plan's objectives.
- 3 (f) Serve as a public forum for discussions concerning the
- 4 camp and the camp's use of property within the region used for or
- 5 affected by the camp's military training operations.
- 6 (g) Engage in any other activity which in its judgment may
- 7 further the purposes of this section.
- 8 Sec. 8. The governor shall appoint a citizen ombudsman for
- 9 each committee. The ombudsman shall serve as staff for the com-
- 10 mittee, maintain an office for the committee, and be under the
- 11 supervision of the committee's chairperson. The ombudsman shall
- 12 monitor, investigate, and report to the committee on public com-
- 13 plaints concerning the camp.
